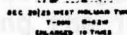
GENERAL HIGHWAY AND TRANSPORTATION MAP

An old saying goes, "What's everybody's business is nobody's business." Since the first white settlers came to Iowa, precious little thought has been devoted to public records administration as a state-wide responsibility. As an illustration of this point, Iowa is presently one of two states in the Union that does not have a professional state archivist although there is much interest in some quarters in creating the position.

In 1977 the Division of the State Historical Society received funding from the National Historical Publications and Records Commission for a two-year study of county records. Precisely what records have been generated and retained by Iowa's 99 counties? To help answer this question, effort has been directed during the project's first year to inventorying the records in a representative sample of six counties - one from each of the state's six congressional districts. The document which follows is one of the initial half dozen inventories compiled by Mark H. Jones, Archivist for the County Records Project.

People will find this inventory useful for a variety of administrative, legal, and research purposes. Information and insights gained in the preparation of the inventory will also help to bring into focus public policy issues that transcend an individual county. For example, Mr. Jones is responsible for reporting on the general status of county records in Iowa. He will draft an Inventory Procedures Manual which will assist in the preparation of surveys beyond the sample group. He will also draft, with the aid of county and state officials, a Records Management Manual including a retention-disposal schedule which will help to bring order to the management of records in Iowa's courthouses. Finally, on the basis of his two years' experience with county records in Iowa, the project archivist will make recommendations for a permanent local records program for the state.

Introduction

Osceola County was created in 1851 and organized in 1871. Sibley is the county seat. County offices and records are located in the courthouse, built in 1902, and in the nearby Public Safety Building, 309-6th Street.

Within the courthouse records are stored in the following rooms:

Ground Floor: Assessor's and Auditors Storage Room; Clerk's Office and Vault; Clerk's and Treasurer's Vault; Engineer's Office and Conference Room; Recorder's and Engineer's Storage Room.

First Floor: Auditor's Office and Vault; Assessor's Office and Vault; Treasurer's Office and Vault; Recorder's Office and Vault.

Second Floor: Courtroom Annex; County Public Health Office.

At the time of this inventory the county had contracted with Cott Indexing, Columbus, Ohio to place on computer tape all instruments filed in the Recorder's Office since 1970. The Recorder files all instruments in volumes entitled "Record." Entries in Grantor-Grantee and Grantee-Grantor indexes as the code by which a printout of all instruments filed by an individual is secured. The county had also purchased equipment for the Auditor to computerize claims against the county and county warrants.

Different regions of the State often generate an abundance of certain types of records on account of local needs. In Osceola County 65 individual drainage districts and 6 joint districts appeared between 1903 and 1971. Though most of these taxing districts are inactive, the Board of Supervisors is empowered to revive and pass levies for inhabitants of any district.

The following inventory was taken during the period of August 16-28, 1977. Entries are arranged according to the office of origin with the exception of County Auditor, REPORTS. Offices are arranged Alphabetically according to those elected (Auditor, Clerk of Court, Recorder, Sheriff, and Treasurer) and those appointed by the Board of Supervisors (Commission of Veterans Affairs, Conservation Board, County Assessor, County Engineer, County Medical Examiner, County Public Health, Zoning Commission). Entries for the Coroner's records are placed under the County Medical Examiner, and entries for Magistrate's Records (an appointive office) are found within the Clerk's section. Records for the defunct County Superintendent of Schools are listed in the last section of the inventory. Entries for the Auditor's records are grouped in one section under three broad headings which reflect the three legal areas of responsibilities faced by this office: Auditor; Auditor as Commissioner of Elections; and Auditor as Clerk, Board of Supervisors. Within offices entries are arranged according to alphabetical order except for MISCELLANEOUS, which appears at the end of section.

The following rules apply to the entries:

1. The first part of an entry represents the actual, latest title found on bindings, drawers, and boxes or within the series. Titles enclosed in brackets were generated by the surveyor. Information within single parentheses () completes the actual title or gives other titles found in the record series. Information within double parentheses (()) includes explanatory material or titles of several instruments found in the record series.
2. Dates generally represent inclusive filing dates or dates of entry. "ca." before a date indicates an approximation. N.D. means No Date.
3. The third piece of information gives the quantity and/or receptical of the record series. Absolute measurements were not obtained. A record series listed as 1/4 cu. ft., for example, indicates an approximate measure of loose documents. One drawer or three

boxes may indicate the total quantity of the record series or that the series is found in these containers.

4. Index: Within Series means that every volume or box within the record series contains an index. Index: Partial Within Series indicates that only a few volumes contain indexing. Indexes separate from record series are noted by title, dates, and quantity.

5. Floor and room locations represent areas of storage at the time of the inventory. The following code is used in the entries and appears after notation of indexing:
