# **FEMA Grants Individual Assistance to Five Counties More than \$1.25 Million in Assistance Approved**

In just one week, more than \$1.25 million in assistance has been approved to help lowans begin their recovery from the Missouri River flooding.

The assistance has been made available through FEMA's Individual Assistance Program. On Oct. 18 Governor Terry Branstad received notification that FEMA had granted lowa's appeal to make Individual Assistance funding available to eligible homeowners, renters and businesses in Fremont, Harrison, Mills, Monona and Pottawattamie counties.

As of Oct. 26, FEMA had received 431 applications. Of the \$1.25 million approved, the total amount disbursed is \$1.1 million.

"That is a significant amount of funding that has gone to lowans who were impacted by the flooding along the Missouri River," said Pat Hall, who is overseeing the state's joint disaster recovery activities with FEMA. "Residents who sustained damage in those five counties should register now if they haven't already."

The FEMA Individual Assistance program can provide homeowners, renters and businesses grants and low-interest loans to help pay for temporary housing, home repairs and other disaster-related expenses not covered by insurance or other aid programs.

## **Governor Forms Missouri River Recovery Task Force**

Governor Branstad has created the Missouri River Recovery Coordination Task Force to oversee the state's recovery efforts.

The Governor announced the creation of this task force on Oct. 17 and appointed Derek Hill, HSEMD administrator, as the chairman.

"Recovery from disaster is not only about rebuilding roads and buildings, but is ultimately about rebuilding communities and the lives of those who were changed by a disaster," said Hill. "That is why the Governor has created this task force and why its members will work to ensure communities and people are able to rebuild their homes, businesses,

## Missouri River Recovery Task Force

Hill said the task force has two goals:

- To coordinate the immediate and sustained disaster response to help individuals, families and businesses return to normal activities
- To reduce the continued loss of economic opportunities.

The task force will accomplish its goals through coordinating assistance, sharing information, monitoring progress, providing technical support, recommending recovery program funding needs, and reporting program recommendations or changes to the Governor.

The task force is comprised of members from local, state and federal governments, voluntary and non-profit agencies and privatesector business organizations.

The task force has been organized into 10 working groups:

- Interagency levee--will coordinate efforts related to flood control works
- Transportation--will coordinate recovery efforts related to city, county and state routes and the federal aid highway systems and railroad systems
- Agriculture--will coordinate recovery efforts directly to

agriculture and soil and water conservation programs

- Health and human services-will coordinate the various human services recovery programs
- Education--will evaluate the impact of school districts and the potential loss of students within the affected districts due to parents' job loss or job relocation
- Economic development-will coordinate efforts related to economic development programs and training
- Housing--will coordinate efforts related to housing and economic development
- Natural resources--will coordinate efforts related to the management and regulation of the state's natural resources
- Communications--will coordinate and provide information to citizens on the Missouri River flood recovery efforts
- •Utilities--will coordinate efforts related to repair and restoration of utilities services.

The task force has been meeting weekly to discuss progress and ensure recovery efforts are coordinated to avoid duplication and provide assistance in the most efficient way.  $\Omega$

## Nationwide EAS Test Scheduled for Nov. 9

The Federal Emergency Management Agency (FEMA) and the Federal Communications Commission (FCC) will conduct the first ever top-to-bottom nationwide test of the Emergency Alert System (EAS) on Nov. 9.

The purpose of the nationwide test, which will be held at 1 p.m. CST, is to assess the reliability and effectiveness of the EAS as a way to alert the public during nationwide emergencies. According to the FCC, although local and state components of the EAS are tested on a weekly and monthly basis, there has never been an end-to-end test or national activation of the system.

On Nov. 9, FEMA will transmit the EAS code for national emergencies and the EAS code and alert will be rebroadcast by broadcast stations and other service provides until it has been distributed throughout the entire country and U.S. territories.

According to FEMA, the test may resemble the monthly EAS tests Americans are familiar with, but there will be some differences in what viewers and listeners see and hear. Some differences to note:

• The audio message will be the same for all EAS participants, however, due to limitations, the video test message scroll may not be the same or indicate that "This is a test." This is due to the use of a Continued on Page 4...

## Federal Individual Assistance: How to Apply

Iowans whose homes, businesses and property were damaged during the Missouri River flooding between May 25 and Aug. 1, 2011, may apply for assistance by phone.

Citizens in the five declared counties may now call the Federal Emergency Management Agency (FEMA) toll-free at **1-800-621-FEMA** (3362) or **1-800-462-7585** (TTY) for the hearing- and speechimpaired. This phone line will be available from 7 a.m. to 10 p.m., seven days a week.

Application may also be made online at www.fema.gov, www.

**disasterassistance.gov**, or via smartphone at **m.fema.gov**.

When applying, applicants need to have the following information available:

- A phone number and a reliable alternative number
- The address of the damaged property
- Social Security number
- Current mailing address
- · Brief description of damages
- · Insurance information
- Bank account information Ω

### **Iowa Individual Disaster Assistance Grant Program**

Residents in Fremont, Harrison, Mills, Monona and Pottawattamie counties may no longer apply for the Iowa Individual Disaster Assistance Grant Program because the federal Individual Assistance Program supercedes the Iowa program. The

"live" code, the same one that would be used in an actual emergency.

- The text at the top of the television screen may indicate that an "Emergency Action Notification has been issued." This notification is used to disseminate a national alert and in this case, the test.
- The background image that appears on video screens during an

alert may indicate that "This is a test," but in some instances there may not be an image at all.

The test is expected to last for approximately three minutes.
