From the WIC Program Goals Manual – 120.10 Outreach Action Plan 2. Iowa WIC Rebranding

By August 31, 2012, a marketing plan for the new Iowa WIC logo will have been established which includes a time schedule for updating all outreach materials for use by State and local programs.

Rebranding the logo of the Iowa WIC Program will accomplish two purposes:

- 1. Differentiate the Iowa WIC Program from other state, Indian Tribal, and territorial WIC Programs and
- 2. Increase recognition of Iowa WIC nutrition services within the state.

The following activities are planned to meet this objective:

- By October 1, 2011 determine new WIC logo.
- By December 1, 2011, choose materials that will need to be printed and design a template that will be available for future printing with the new logo.
- By March 1, 2012 conduct focus groups to test the materials before distribution.
- By May 1, 2012 make any changes to the materials as a result of the focus groups.
- By July 1, 2012 materials will be printed and a template will be available for future printing.
- By August 1, 2012 materials will be available to agencies.
