From the WIC Program Goals Manual - 215.06 Automatic Terminations

Automatic terminations

The data system will automatically terminate WIC participants under specific circumstances. The table below lists examples.

Category	Automatic Termination		
Child	At the end of the month the child turns 5 years old		
Pregnant woman	Two months after expected delivery date		
Postpartum woman	At the end of the 6th month after actual delivery		
Breastfeeding woman	At the end of the 12th month after actual delivery		
All participants	The month after the certification end date		

Training

Online Nutrition Education Webinar

Training webinars to discuss online nutrition education in the Iowa WIC Program have been scheduled for August 1st at noon and August 2nd at 8:00 am. Local agency staff only needs to participate in one session as they both will cover the same content. Attendance for the webinar is required for each local agency as the training will include Iowa specific information such as Iowa policy requirements and best practice recommendations from the pilot agencies, Mid-Sioux Opportunity, Inc. and HACAP.

Edgerton Women's Health Center was honored to have a visit from Under Secretary Kevin Concannon on Thursday July 12, 2012. Below is a summary of the visit from Elaine.

Tom and I had a great visit with Mr. Concannon, Darlene Sanchez and David Von Behren. They were here from 1:30 until 3:00. I gave them a brief tour of our WIC office. It was a very casual meeting where Tom and I had the opportunity to discuss how this agency worked with other community agencies all to

benefit children. I had the opportunity to show off the divided plate our agency developed and had in production about 10 months before "MyPlate" came out.

I put in a plug for funding for technology so EBT cards can move forward and Carole Hahn and I both discussed the need for funding breastfeeding peer counseling. Mr. Concannon asked if the local hospital was "Baby Friendly". Carole was able to discuss the fact the hospital applied but was not given that status.

The morning round table at Community Action of Eastern Iowa consisted of Mr. Concannon talking the majority of the time on school lunch and SNAP programs. He briefly mentioned WIC stating 53% of all infants born in America are on WIC; there is a need to improve retention rate of children on WIC programs after age one and breastfeeding encourages and promotes breastfeeding.

Children cannot be certified for one year until after their first birthday. If you are certifying an infant that is 11 months and has not had its first birthday, that infant will be certified for six months.
