# **Policy**

# From the WIC Program Goals Manual - 215.08 Notification of Eligibility Status

Introduction

Applicants must be notified of their eligibility status at the time of certification. This policy describes the process of notification.

If eligible

When the applicant is found eligible at certification, follow these steps.

Step	Action
1	Print and review Your Rights and Responsibilities as a WIC Participant (see Policy 215.95A) with the participant or parent/caretaker, and obtain a signature.
2	Fill out a WIC Identification Card (see Policy 220.10A) and obtain the authorizing signatures for the participant or parent/caretaker.

#### If ineligible

Follow the steps in the table below for applicants found ineligible at certification.

Step	Action
1	Generate two copies of the Notice of Ineligibility form.
2	Give one copy to the applicant.
3	File the second copy by date with other printed materials that must be retained (e.g., check receipts, Your Rights and Responsibilities as a WIC
	Participant, proxy cards).

Applicants may be determined ineligible for services because:

- Reasons for ineligibility
- They failed to bring proof of identity,

• Household income exceeds the guidelines,

- They do not have a nutrition risk, or
- The Iowa WIC Program is serving only higher priority classes due to funding constraints.

Nutrition services may be provided Nutrition assessment and nutrition education may be provided to applicants who are found ineligible. Local WIC personnel are encouraged to offer these services along with appropriate referrals for health and other social services.

# Washington Update

#### FDA Bans BPA in Baby Bottles and Sippy Cups

Washington, DC, July 17, 2012 – The FDA announced today that the chemical bisphenol-A (BPA) is banned from baby bottles and sippy cups.

After manufacturers of these products previously ceased using the chemical, the American Chemistry Council filed a petition to the FDA to impose a ban in October, 2011.

BPA, present in numerous items such as plastic bottles, and metal food cans, has raised concerns following research findings of development and reproductive health problems in rodents and other animals exposed to large doses. The FDA previously stated that the research findings did not provide sufficient scientific evidence to ban BPA, and is currently continuing research to assess the chemical's health effects.

### EBT Update

# **Online EBT System**

Rebecca Tyree, the WIC Coordinator from the Barren River District Health Department in Bowling Green, Kentucky spoke on the EBT Clinic Advisory Conference Call this week about their online EBT system. Her agency was the pilot for the EBT system in October 2008. Rollout has continued to occur across the state with the last district in Kentucky implementing EBT last fall. Since their EBT system is an online system, clinics must be connected; however their agency has not experienced many issues with loss of connectivity. If a loss of connectivity does occur, their agency loads benefits to the card when connectivity comes back up. The card does not have to be present to load benefits with an online EBT system. The benefit list is then mailed to the participant.
