
# Drought persists, Gov. Branstad issues proclamation to assist livestock producers

On July 17, Gov. Terry Branstad and Lt. Gov. Kim Reynolds held a public meeting on the severe dry and drought conditions that have plagued lowa this summer.

The meeting featured officials from the Iowa Homeland Security and Emergency Management Division (HSEMD), Iowa Department of Natural Resources, Iowa Department of Agriculture and Land Stewardship, and the U.S. Department of Agriculture.

The discussion included the latest information and tracking metrics, how coordination is being handled between the state and federal levels, and potential action steps that may be taken.

"As the hot and dry weather continues in the state, Lt. Gov. Reynolds and I Continued on Page 3...

# Des Moines County CERT program recognized

The Des Moines County Community Emergency Response Team (CERT) received a 2012 Governor's Volunteer Award during a special recognition ceremony held June 29 in Cedar Rapids. The team was honored with a Five-Year Length of Service Volunteer Award.

The CERT program in Des Moines County has been in existence since April 2006. Team members provided more than 300 hours of volunteer service to the community in 2011. The team members provide assistance such as traffic and crowd control, emergency and non-emergency communications, security, and preparedness education at a variety of events.

In addition to Des Moines County Emergency Management Coordinator Gina Hardin, CERT members who attended the award session included Scott Gillis, Jared Sommerfelt, Colleen Roland, Andrew Wells and Chris de la Rosa.

Hardin said, "These individuals dedicate time on a monthly basis to receive training above and beyond their initial instruction so they are ready to assist in any type of disaster that may affect Des Moines County. They also give a tremendous amount of time to helping out local entities that need additional volunteers to assist with their local events."

This is the first time the Des Moines County CERT program has been nominated for a Governor's Volunteer Award. Several hundred volunteers are recognized each year with awards in one of several categories:



Individual, Group, Length of Service or Disaster Volunteer.

"I am very pleased to honor those who have given the precious gift of their time to make a difference and enrich lives in communities all across lowa," said Governor Terry Branstad. ...Continued from Page 1 want to ensure that the state of lowa is doing all it can to provide assistance to those who are impacted by the drought conditions," said Gov. Branstad in a letter posted on his website.

This week, conditions had not improved and on July 26, the governor issued a disaster emergency proclamation that will provide relief to lowa farmers hit hard by the drought being experienced in the state.

The proclamation took effect at noon July 26 and will be in effect for 60 days thereafter. The assistance comes in the form of a suspension of state laws and regulations affecting the transport of hay, straw and stover. The drought has destroyed or depleted sources of these products that are necessary for livestock production and feed.

Officials from HSEMD continue to work closely with local, state and federal partners to provide assistance should it become necessary.

# Missouri River Authority discusses hydrology, levee improvements at July 24 meeting

The State Interagency Missouri River Authority (SIMRA) met July 24 in Des Moines to discuss a possible hydrology work group, levee improvements, and other issues.

The Iowa Department of Natural Resources' (DNR) Tim Hall, recently chosen to coordinate hydrology efforts in Iowa, discussed his efforts to assemble an interagency work group of hydrology experts. Hall thinks the group will eventually provide a clearinghouse for water information including everything from stream levels to precipitation records to water use data.

Also on the agenda were updates from the floodplain management program, the U.S. Army Corps of Engineers and a committee working on Missouri River recovery.

HSEMD's Tom Oswald is the chair of the interagency levee work group. The group is concerned with recovery from the 2011 Mis-

souri River flood, with their efforts concentrated on the levee system along the river. Oswald says construction on the north side of Highway 2 in Fremont County (near Levee 575, which was breached in June 2011, causing massive flooding in the area) is progressing, but there are continuing acquisition issues on the south side of the highway, though he believes those issues will be resolved yet this construction season.

The new levee is being constructed along a two-mile stretch north of Highway 2 and one mile south of the highway. The levee has been moved farther away from the river to broaden the floodway of the river. This will reduce the level of flood risk along the stretch, and will be less expensive than completely repairing the existing levee. In order to achieve the desired flood risk reduction, the elevation of the new levee will be higher than the

roadbed of Highway 2 where they will intersect.

Local, state and federal agencies are working together to resolve the issue so Highway 2 can remain open and people and property can be best protected during flood conditions.

The Missouri River Authority is an interagency, interstate group that makes recommendations on policies affecting the Missouri River. Ω
