TOPSOIL SHALL BE STRIPPED FROM WITHIN THE PROJECT LIMITS AND SPREAD UNIFORMLY (MIN. 4" DEPTH) OVER ALL AREAS THAT ARE NOT COVERED BY GRANULAR MATERIAL. AREAS SHALL BE UNDERCUT PRIOR TO PLACING TOPSOIL. CROSS-SECTIONS SHOW FINISHED GRADELINE. THE CONTRACTOR IS TO FAMILIARIZE HIMSELF WITH IOWA LAW AS IT PERTAINS TO REMOVAL AND REPLACEMENT OF TOPSOIL WITHIN THE PROJECT AREA.
