IDPH Launches Anti-Bullying Effort: Governor Terry Branstad announced the launch of **Your Life Iowa** during the Governor's Bullying Prevention Summit in Des Moines on November 27. **Your Life Iowa** is a new "go-to" resource where youth, parents and educators can find needed information about bullying and youth suicide. Available 24/7, **Your Life Iowa** is a phone call, click or text away at www.Yourlifeiowa.org or 855-581-8111. Trained counselors provide guidance and support about bullying, and critical help to youth who feel they've run out of options and may be considering suicide. Your Life Iowa is funded by IDPH through a 2012 legislative appropriation and was implemented in partnership with Boys Town, the State of Iowa Youth Advisory Council, the Iowa Youth Congress and the Iowa Department of Education Bullying Prevention, Intervention and Reporting Initiative. Update on TB rules: New rules went into effect November 7 for substance abuse and problem gambling program licensure, stipulating required components for tuberculosis (TB) testing/risk assessment policies, as follows:

- Screen all employees (including volunteers and contract employees) starting employment on or after November 7, 2012 for TB before they start work
- Initiate TB testing for all residential clients within 72 hours of admission
- Conduct a facility risk classification once a year, with program risk determined by a count of infectious TB cases. No re-testing of employees or residential clients is needed if the program has a low risk classifications and no TB exposure.
