## Cerro Gordo County hosts Integrated Emergency Management Course

More than 50 people representing a variety of organizations participated in an exercise-based training course hosted by Cerro Gordo County Emergency Management Feb. 12-15.

The Community-Specific Integrated Emergency Management Course was delivered by the Emergency Management Institute (EMI) of the Federal Emergency Management Agency (FEMA). The course is designed to place local emergency operations center (EOC) personnel in realistic crisis situations in a structured learning environment.

During this course, participants had an opportunity to test their response to multiple incidents, including torrential rains, flooding, and a tornado. The training brought together participants from Mason City and Cerro Gordo County government, health, fire and law enforcement agencies, along

with emergency management coordinators from several nearby counties and representatives from state government agencies, including the Iowa Homeland Security and Emergency Management Division (HSEMD) and Iowa Department of Public Health.

"The course was fantastic," said Cerro Gordo County Emergency Management Coordinator Steve O'Neil, who hosted the course and worked with EMI and FEMA on the planning. "It was great to have so many EOC staff and responders from Cerro Gordo County show up for four days of training. Everyone left feeling they had learned a tremendous amount about the purpose and functions in the EOC during a disaster. The instructors were top of the line. I would highly recommend this to any county to participate if they can."

O'Neil said to prepare for the course, EMI sent representatives to Cerro Gordo County to meet with local responders, hospital

personnel and representatives of city and county facilities. O'Neil also provided EMI the county's comprehensive emergency operations plans, standard operating procedures, policies and other documents that would be referenced during a disaster. Although EMI staff brought quite a lot of the equipment used in the course, O'Neil said he also had to provide some equipment and a facility where the course could be conducted.

HSEMD provided equipment that was used for the course and guidance on the application process. Additionally, several HSEMD staff participated in the course itself. Ω

The goal of Severe Weather Awareness Week, which in past years has been held in April, is to provide Iowans a better understanding, and to increase awareness, of the state's spring weather hazards.

The highlight of Severe Weather Awareness Week is the annual tornado drill, scheduled for Wednesday, March 27, at approximately 10 a.m. Schools, businesses, state and local governments, the military, and individuals are strongly encouraged to participate in the drill. For each day during Severe Weather Awareness Week, a different subject will be highlighted:  
Monday--Flash Floods  
Tuesday--Weather Warnings  
Wednesday--Tornadoes  
Thursday--Severe Thunderstorms  
Friday--Family Preparedness

# Multi-State Partnership addresses livestock movement

A wide-area, high-consequence livestock disease remains one of the biggest threats to the economic stability of the food and agriculture sector.

The Multi-State Partnership for Security in Agriculture agreed last month to continue a nationally recognized project to permit movement of livestock between states during the early stages of a disease disaster. Project coordinator Susan Dixon of HSEMD's Preparedness Bureau said the project has produced templates, resource materials and workshops designed to facilitate interstate agreements that keep commerce moving during a disease outbreak.

Dixon and fellow Partnership project coordinator Mark Shearer, also of HSEMD's Preparedness Bureau, organize communications and projects for the 14-state consortium, which is celebrating its 10th anniversary this year. Iowa

has been the lead state for the Partnership since its inception.

During the Partnership's January planning meeting in Oklahoma City, the group toured the Oklahoma Stockyards, the largest surviving livestock auction that moves 10,000 or more cattle every week from feeding operations to finishers. Auctions are critical infrastructure in disease management because they are a mixing pot for livestock that are sold and sent to dozens of states within 24 hours.

While in Oklahoma, members of the Partnership reviewed and prioritized projects and planned future priorities. Besides permitted movement, high-profile projects of the Partnership include crisis communication workshops, "just-

## Projects receive funding through hazard mitigation grant

Hazard mitigation projects are important for reducing or preventing damage from future disasters. Federal funding for hazard mitigation projects is made available after each Presidential Disaster Declaration through the Hazard Mitigation Grant Program (HMGP).

As part of the HMGP in Iowa, 75 percent of eligible project costs is

paid by the Federal Emergency Management Agency (FEMA), 10 percent is paid by the applicant (state), and the remaining 15 percent is paid by the sub-applicant (local governments/communities, tribal governments, and certain eligible non-profits).

The following projects have been recently funded through HMGP:

**Lake Mills Community School Award:** \$1,130,010  
**Date:** Jan. 31, 2013  
**Project:** Tornado Safe Room

Construction to add a safe room to the school for the students/staff/visitors. Multi-use/pre-school and elementary activities and community functions with restrooms.

## HSEMD Legislative Update

The 85th Iowa General Assembly began their 2013 session on Jan. 14. In the early weeks of the session Governor Branstad delivered his

State of the State speech, Major General Timothy Orr addressed the condition of the Iowa National Guard, and Chief Justice Mark Cady spoke on the Condition of the Judiciary. As always, the first weeks of the session are about getting the protocols in order and the process of legislating started for the new year.

However, now that the formalities are out of the way, the Capitol building has begun to fall into a familiar rhythm. We have already seen a number of policy bills that will impact the emergency management community. The first of these is House Study Bill (HSB) 40/Senate Study Bill (SSB) 1033, which would convert HSEMD to a stand-alone state department. This is similar to a bill that passed the legislature last year but was vetoed by the governor for issues not related to the conversion.

Another bill that has returned from last year, Senate File (SF) 9, would create a public safety training and equipment trust fund. Last year this bill did not pass

both chambers but it is expected to engender vigorous discussion.

Other bills of interest include; HSB 44, dealing with extending disaster liability to architects that assist during disaster response and recovery; House File (HF) 74, dealing with firearms lawfully owned by citizens during a state of emergency; SF 147, dealing with drug testing for those receiving state financial aid; and HF 11, which would eliminate smart planning requirements from the Code of Iowa.

Finally, discussion has started about mass public notification. Some of the talk has centered around notifying hunters of possible missing persons in areas where they are hunting, notification to the public when a mentally-disabled or cognitively-impaired individual is absent from a care facility, and crime-related notifications dealing with situations similar to the young girls being abducted last year in Evansdale. I would expect to see this topic gain more steam as we move deeper into the session.

Each year, National Weather Service (NWS) meteorologists provide spotter training throughout the state.

The classes cover information about severe weather climatology, severe thunderstorm types, different severe weather threats and how to identify them, how to report severe weather, spotter safety and severe weather communications.

## Emergency Response Guidebook goes mobile

The U.S. Department of Transportation's Pipeline and Hazardous Materials Safety Administration (PHMSA) has announced the creation of a free, mobile web app of its Emergency Response Guidebook 2012 (ERG).

According to the PHMSA, this safety tool will provide emergency responders with fast, easily accessible information to help them manage hazardous materials incidents.

The PHMSA says the mobile ERG will make it easier for firefighters, police and other emergency responders to quickly

locate the information they need, thanks to an electronic word search function, and will ensure easy reading even during nighttime emergencies.



The 2012 version of the ERG includes new evacuation tables for large toxic gas spills and stan-

dard response procedures for gas and liquid pipeline incidents.

Links to download the ERG 2012 mobile app are available from Apple iTunes for iPhones and from Google Play for Android.

PHMSA and the U.S. Department of Health and Human Services National Library of Medicine joined forces to produce this mobile app.
