Policy

From the WIC Certification Policy and Procedure Manual – Policy 215.30 – Other Automatic Terminations

Termination notices must be printed for participants who are automatically terminated for the following reasons:

- Failed to reapply
- Failed to provide proof of income in 30 days.

The steps below describe how to print the notice:

Step	Action				
1	Click on the Print Term Notice button in the Termination group box.				
2	If a pop-up error message appears regarding the termination notice date not meeting USDA regulatory requirements, close the message.				
3	Fill in the effective date of the termination on the notice using a month/day/year format based on the termination reason:				
	• Failed to reapply: The date the certification ended,				
	• Failed to provide proof of income: 30 days after the provisional certification date.				
4	Check the appropriate reason for termination on the notice.				
5	Give (or mail) the notice to the participant or parent/guardian.				

The date field, Printed term notice date, will automatically be filled in with today's date. This is adequate documentation of providing notice.

Ineligible by Income Report

The Ineligible by Income Report shows participants who are found ineligible due to exceeding the income limits. This report documents the family ID, parent/guardian name, ineligible date, home phone number, the family's monthly income, household size, and address. This report can be used to identify and provide follow-up with families that might be eligible for services when the income guidelines change.

TITLE: F/T Dietitian WIC Program ENTRY SALARY: \$44,045/yr. (Plus Benefits)

ESSENTIAL FUNCTIONS:

Responsible and accountable as the competent professional authority for determination of Women, Infants, and Children (WIC) Program eligibility and certification based on nutritional risk. Provide nutrition assessment, education, referral, and care coordination services. Provide nutrition services to Maternal Health and other SDHD public health programming. Reports directly to Nutrition Director.

APPLICANTS MUST MEET THE FOLLOWING REQUIREMENTS:

Must possess Bachelor's Degree in nutrition, dietetics, food systems management or closely related field. Must possess Dietitian License as issued by the Iowa Board of Dietetic Examiners, or able to obtain license within 6 months of employment. Current Dietetic registration preferred through the Commission on Dietetic Registration for the Academy of Nutrition and Dietetics or eligible to take the registration exam, which must be completed within 6 months of employment. A minimum of 1 year experience in general dietetics is desired with experience in maternal/child nutrition preferred. Computer skills required. Must be a resident of Iowa or willing to relocate; must have valid Driver's License, ability to obtain car insurance at agency specified liability level, & reliable transportation. Physical ability to lift 50 lbs. A completed County application form, a resume, a copy of transcripts or diploma, and a copy of current Dietitian License (if applicable) are required.

Candidate for hire must successfully pass background checks, a physical exam and drug screening prior to employment. The employer will not refuse to hire a disabled applicant who is capable of performing the essential requirements of the job with or without reasonable accommodations.
