### General Information:

- Founded in 1887, under the motto "Iowa Forgets Not the Defenders of the Union."
- Sixth largest State Veterans Home in the nation.
- 609 residents, 986 employees.
- The beautiful campus spans almost 150 acres, with seven main resident care buildings.

### Admission

#### Requirements:

- Honorably discharged veterans and/or their spouse or widow;
- Demonstrated medical need;
- Eligible for VA medical treatment.

#### Cost of care:

- Eligible residents are admitted without regard to their financial status;
- Cost of care includes *all* services (listed below) available at IVH;
- Rate of payment is based on the actual cost of care and the individual's ability to pay using available resources.

## A Message from the Commandant

It's an honor to serve as the Commandant of the Iowa Veterans Home (IVH), Iowa's largest long-term care facility. Our staff takes great pride in striving every day to accomplish our mission: **To provide a continuum of care to Iowa's veterans and their spouses in an environment focusing on individualized services to enhance their quality of life.** We provide high quality care and our programs and activities are second to none.

As I write this message, there continues to be a great deal of renovation and new construction occurring at IVH. The \$36 million renovation of the Dack and Malloy buildings is continuing and will allow us to move more residents into private rooms with a private bath. We are building a transportation building and upgrading generators, with a projected cost of \$815,000. We are also replacing a boiler and updating the steam distribution system for \$946,000. All these projects are a federal/state match of 65/35%. We appreciate our partnership with the United States Department of Veterans Affairs.

We have many other partners that help us succeed in accomplishing our mission. Our dedicated volunteers, the community of Marshalltown and surrounding communities, and the many Veteran Service Organizations and Auxiliaries in Iowa, all provide great support to our residents.

The IVH team successfully completed FY2013, and we are perfectly positioned to have another successful year in 2014. We will continue to work to set the national standard for quality resident care. We will work to consistently achieve deficiency-free surveys from the federal and state agencies that provide regulation. We will continue our progress toward moving all residents into private rooms, as we want to provide the dignity these veterans and their spouses deserve.

I'm proud of the IVH team and our commitment to providing quality care and services for our residents. We're proud to be able to serve the brave men and women who have served to protect our freedoms.

## Meeting the Budget Challenge

In response to the state-wide fiscal challenge during FY13, the IVH developed a plan that included the following strategies:

- Reduce overtime, including comp time;
- Continue perfect attendance policy to help reduce OT
- Review all vacant positions for full impact to the mission
- Evaluate every procedure for full effect on the budget
- Adjust Medical Officer of the day scheduling
- Seek opportunities to collect outstanding debt
- Evaluate new opportunities for revenue generation

IVH sees this as an opportunity to be creative in meeting future budget challenges while continuing to provide quality care to our residents.
