1. SITUATION:

- a. Enemy Forces. Annex B, Intelligence.
- b. Friendly Forces.
- (1) Military. Commander Fifth United States Army (5USA) allocates personnel and resources of active and reserve components of the Army, not required for essential military missions, for the purpose of providing military support during civil defense emergencies. In coordination with Commanders, Central Air Force Reserve Region and Ninth Naval District, provides available personnel and resources of active and reserve components of Navy, Marine Corps, Coast Guard and Air Force.
 - (2) Civilian Agencies.
 - (a) Federal.

l. Defense Civil Preparedness Agency (DCPA) Region VI, DENVER, COLORADO provides to the State of Iowa that additional guidance, and assistance required to protect life and property, save lives, sustain survivors and repair essential utilities, achieve emergency operational capability and provide support in the management, distribution and use of available resources, during the immediate post-attack period.

2. Office of Preparedness (OP) Region 6, KANSAS CITY, MISSOURT will support civil government functions including emergency resource management, crisis management, continuity of government and strategic materials.

> Change Order No 2 24 June 1974

(b) State.

- 1. The executive office of the Governor of Iowa shall manage the resources of the State through existing departments and those agencies established in the Emergency Plan of the Iowa Civil Defense Division and the Emergency Resource Management Plan (ERMP) of the State of Iowa.
- 2. Departments of State Government. All resources and personnel of the various agencies and departments of the Government of the State of Iowa shall be considered as available for employment in event of an emergency within the State of Iowa. Such employment shall be in accordance with Emergency Plan of the Iowa Civil Defense Division and the supporting emergency plan of each department or agency.
- (c) Welfare and Relief Organizations. The American Red Cross and other voluntary agencies will provide assistance in accordance with the memorandum of understanding executed at the national or state level and in accordance with the detailed plans developed at the local level. See Part E, Chapter 13, Appendix 1, Federal Civil Defense Guide (E-13-1, FCDG).
- c. Attachments and Detachments. To be announced with implementing orders.

d. Assumptions.

- (1) Authority for execution of general war mobilization plans will be forthcoming prior to or immediately following a nuclear attack on the continental United States.
- (2) All reserve component units not already on active duty, including Headquarters Iowa National Guard (HQ ING) (Army & Air), will be called to Federal active duty at home stations, in conformance with the mobilization plans of their respective service, following a nuclear attack on the CONUS.
- (3) The post attack environment will be marked by wide spread fallout, disruption to communications, and great damage to facilities and installations.

- OPLAN 1, HQ Iowa Area Command, 1 September 1972
- (4) The post attack period will require mobilization of all forces available to assist the civil authorities in controlling resources and ensuring the ability of civil government at all levels to assume their respective responsibilities.
- (5) An attack upon the CONUS may incorporate use of conventional, chemical, and biological as well as nuclear weapons.
- 2. MISSION: In the event of a civil defense emergency beyond the capabilities of civil authorities, employ available military resources in support of the Emergency Plan, Iowa Civil Defense Division, to assist in restoring essential facilities, prevent unnecessary loss of life, and alleviate suffering; be prepared to take necessary action to restore civil control where it has become inoperative; be prepared to support Commanders, adjacent State Area Commands.

3. EXECUTION:

- a. Concept of Operation. Annex C.
- b. Sub-Area A Command. Conduct emergency operations in support of civil authorities in assigned Sub-Area with priority of effort to WATERLOO and DUBUQUE in the order named.
- support of civil authorities in assigned Sub-Area with priority of effort to DAVENPORT and CLINTON, in the order named.
- d. Sub-Area C Command. Conduct emergency operations in support of civil authorities in assigned Sub-Area with priority of effort to OTTUMWA and BURLINGTON in the order named.
- e. Sub-Area D Command. Conduct emergency operations in support of civil authorities in assigned Sub-Area with priority of effort to COUNCIL BLUFFS.
- f. Sub-Area E Command. Conduct emergency operations in support of civil authorities in assigned Sub-Area with priority of effort to SIOUX CITY.
- g. Sub-Area F Command. Conduct emergency operations in support of civil authorities in assigned Sub-Area with priority of effort to MASON CITY.

- h. Sub-Area G Command. Conduct emergency operations in support of civil authorities in assigned Sub-Area with priority of effort to FORT DODGE.
- i. Sub-Area H Command. Conduct emergency operations in support of civil authorities in assigned Sub-Area.
- j. Sub-Area I Command. Conduct emergency operations in support of civil authorities in assigned Sub-Area with priority of effort to DES MOINES, CEDAR RAPIDS, IOWA CITY and AMES in the order named.

- a. Each military organization located in the State of Iowa has been assigned a numerical priority indicating the probable availability for employment in support of civil defense operations. Priorities are as follows:
- (1) Priority I: Those forces that have a high probability of availability for civil defense support in the immediate emergency period. Army Policy: Units programmed in the TD Troop Basis.
- (2) Priority II: Those forces that have a lower probability to support civil defense in the post attack period. Army Policy: Units which deploy from M plus 3 months or later.
- (3) Priority III: Those forces least likely to be available for civil defense support operations because of the high priority of their combat and combat support missions. Army Policy: Units that deploy from M through M plus 2 months.
- b. Availability of forces will be evaluated during the immediate post attack period based upon assessment of the sitution.
- 4. CAPABILITIES BY CATEGORY: Task force organization indicates the appropriate capabilities of each unit, category letters for capabilities are as follows:

A Emergency support of those tasks for which military personnel have an inherent capablilty to accomplish in varying degrees by virtue of their organization and general military training. Such tasks include but are not restricted to:

treatment of casualties; Maintenance of law and order, to include general police and law enforcement operations, emergency highway traffic control and supervision, security, and protection of vital facilities and resources, and enforcement of economic stabilization measures; and recovery, collection, safeguarding and issue of food, essential supplies, and critical items.

Other supporting tasks require specialized skills and the identification of forces with specific capabilities will be categorized as follows:

- B Restoration of facilities and utilities, including transportation, communications, power, fuel, water, and other essential facilities.
- C Explosive ordnance disposal.
- D Medical treatment of hospitalization of casulties, recovery of critical medical supplies and the safeguarding of public health. This may involve sorting and treating of casualties, and preventive measures to control the incidence and spread of infectious diseases.
- E Recovery, identification, registration and disposition of deceased personnel.
- F Radiation monitoring and decontamination to include identifying contaminated areas.
- G Movement control to include plans and procedures for essential movements.
- H Emergency provision of food and facilities for food preparation, should mass or community subsistence support be required.
- I Damage assessment of facilities, utilities and communications.
- J Provision of interim communications utilizing available mobile military equipment to provide command and control.
- K Fire Fighting.

- 1. SUMMARY OF ENEMY SITUATION: An aggressor is capable of creating an emergency by threatening or initiating a nuclear, chemical, or biological attack on any part of the United States with or without warning.
- 2. MISSION: To produce and disseminate to higher, lower and adjacent headquarters intelligence pertaining to an emergency, or potential emergency, which may require military support.
- 3. ESSENTIAL ELEMENTS OF INFORMATION:
 - a. What is the nature of the emergency?
- b. Where is the location of the catastrophe or emergency and how large an area does it cover?
 - c. How many people are affected and what are their needs?
 - d. What measures are being taken by local civil authorities?
- e. Will the situation be beyond the capabilities of the local authorities or resources? If so, what additional estimated manpower and/or material will be needed?
- f. What conditions or potential threats exist that could cause further damage or destruction?
- 4. INTELLIGENCE ACQUISITION TASKS:
 - a. General.
- (1) Request for information or intelligence from 5USA, installations, federal agencies at national level, state agencies and adjacent state area commands will be submitted to G-2, Iowa Area Command.
- (2) Intelligence reports and summaries furnished to this headquarters from all sources will be disseminated on a need-to-know basis.

- b. Tasks for subordinate commanders.
- (1) Collect pertinent information pertaining to critical points, installations and areas, to include analysis of roads, bridges and terrain.
- (2) Maintain a current estimate with regard to potential conditions or emergencies which may require the use of military forces to assist civil authorities within assigned areas of responsibility.
- (3) Conduct necessary reconnaissance and observation to insure familiarity with potential areas of operation and mission requirements.
- (4) Be familiar with emergency plans of supported civil authorities.
- (5) Develop intelligence capabilities and resources in support of the mission.
- (6) Assemble Basic Area Intelligence and such information pertaining to:
- (a) Billeting to include fallout shelter for military personnel.
 - (b) Transportation.
 - (c) Local Area Maps.
 - (d) Brochures.
- (e) Vital facilities for power, communications, transportation and water.
- (7) Conduct intelligence activities as required by CG, Iowa Area Command upon implementation of this plan.
 - c. Coordinating Instructions.
- (1) Upon implementation of this plan, direct communication between investigative agencies, higher, lower, and adjacent headquarters is authorized and encouraged.

 - (2) Military Sources of Information.
 - (a) Enemy Personnel.
- (b) Personnel at higher, lower and adjacent military elements.
 - (3) Civilian Sources of Information.

 - (c) News Media.
- (d) Utilities, transportation and communications organizations.
 - (e) Welfare, charitable and service organizations.
 - (f) Federal and State Agencies.
- (4) Reports of damage assessment will be disseminated to appropriate civil authorities and this headquarters.
- 5. SUPPLEMENTAL INTELLIGENCE ACTIVITIES:
- a. Captured documents and material. Disposition instructions for such items will be provided upon notification of capture.
 - b. Maps.
- (1) Distribution of maps 1:250,000 and larger scale, will be made by this headquarters to all military elements. Appendix 1.
- (2) Initial distribution of maps is designed for planning purposes and will be retained for operational use. Use for other than Military Support of Civil Authorities is not authorized.
- (3) Iowa Highway Commission Maps may be procurred from Iowa Highway Commission or Iowa Highway Patrol.

(4) City, County, and other maps required for detailed planning and operations may be secured from local agencies without reimbursement from this headquarters.

c. Security.

- (1) This headquarters will disseminate classified information as required in accordance with Department of the Army Policy (AR 380-5).
- (2) Security and further dissemination or release of classified information, documents, and materials will be in strict accordance with departmental regulations and policy.
- (3) Implementation of this plan or any portion thereof will not reduce the requirement for safeguarding classified information.
 - d. Counterintelligence. To be announced.
 - e. Weather.
 - (1) Supporting Services.
- (a) Weather Division, Iowa Department of Agriculture.
- (b) National Weather Service, U.S. Department of Commerce.
 - (c) Federal Aviation Agency.
 - (d) Air Force Weather Service.
 - (e) Emergency Broadcast System (EBS).
- (2) The National Weather Service, Department of Commerce has the primary responsibility for collection and dissemination of weather and upper fallout (UF) data for civil agencies.
- f. Other Intelligence Support. Intelligence support will be provided by CG, 5USA on an "As Available Basis".

- 1. GENERAL: Headquarters Iowa National Guard will be mobilized as HQ Iowa Area Command. The Adjutant General of Iowa will become Commander HQ Iowa Area Command, as such he will be responsible to Commander 5USA for the operational employment of those forces made available for and engaged in Military Support of Civil Defense.
- a. Control of operations will be exercised through task organization established within each of the nine sub-areas of Iowa; Annex D, Areas of Responsibility.
- b. Military Support of Civil Authorities in a civil defense emergency is a responsibility second only to combat operations. Measures to insure continuity of operations, troop survival and the rehabilitation of essential military facilities will take precedence over military support of civil defense. Military forces (active and reserve) within the State of Iowa will be employed as required in performing either essential military missions or civil defense support missions.
- c. The association or identification of specific military units with civil defense contingency plans and priorities does not eliminate their predominate and traditional roles. Such identification is a prerequisite to development of effective plans for a contingency.
- d. Planning for military support of civil defense will be directed toward the most disastrous contingency, that of a nuclear attack with minimum warning.
- e. Damage or danger areas in the continental United States may be so extensive that evaluation of operational priorities will be required prior to the allocation of forces for civil defense tasks.
- f. All units will conduct training for military support of civil defense in accordance with appropriate service directives.

- g. Military support will complement and not be a substitute for civil participation in civil defense operations.
- 2. MISSION: In event of a civil defense emergency, beyond the capabilities of civil authorities, employ available military resources to assist in the restoration of law and order, alleviate suffering, protect lives and property, and be prepared to support commanders adjacent state area commands, Susa. 3. LIMITING FACTORS:

- a. Availability of forces may be limited due to a priority commitment for combat or combat support missions. A firm determination of availability of forces can be made only after the attack.
- b. Limited availability of heavy duty equipment and transportation facilities may preclude or limit utilization of the forces made available: The last and dark the control of the contro
- c. Military assistance to civil authorities is temporary in nature. The duration of support will extend only until such time as the civilian capability is restored on a minimum essential basis.
- d. The lack of formal civil defense organizations at Sub-Area level will require independant coordination with municipalities as directed in task assignments.

 4. SUPPORTING OPERATIONS:

- a. Civil authorities at all levels have the responsibility for combating civil defense emergencies at their respective levels within the State of Iowa. Such plans must recognize that civil resources will be the first resources used to support civil requirements, with military resources being used only when essential to supplement the civil resources. - b. Support will be provided the State of Iowa from Annual Property resources of Federal Agencies.
- c. The American Red Cross will provide support in accordance with their Federal Charter and State Agreements.

5. ACCOMPLISHMENT:

- a. The commander of each Sub-Area is responsible to the Adjutant General of Iowa for preparation of preattack plans for military support in a civil defense emergency and for the operational employment of forces temporarily made available for support in such an emergency.
- b. Each headquarters will be responsible for developing the capability to implement plans created by the Commander of the Sub-Area. Forces listed in this plan and all supporting plans will be prepared to respond, as required, consistent with military requirements existing at the time.
- c. The Adjutant General of Iowa will receive from 5USA, listings of military forces of all components located in the State of Iowa, such listings will indicate the priority and capabilities of each unit as defined in Annex A. Priorities for availability will be assigned in accordance with DOD guidance and departmental plans.
- d. All military forces, active and reserve, within the State of Iowa are considered as potentially available to provide temporary emergency support to civil authorities during civil defense operations at any location within 5USA area. All elements should plan for Priority I availability assignment during the immediate postattack period. Priority I and II Reserve Component units of the Army may be considered as immediately available for Military Support of Civil Defense.
- e. Request for military support normally will be accepted no lower than the State Military Headquarters level from the State Civil Defense Director. In cases of imminent seriousness a military commander will provide immediate assistance, within his capabilities, to civil authorities in a civil defense emergency without prior approval of higher headquarters when the urgency of the situation precludes awaiting instructions. Such actions without prior authorization will be taken only in situations beyond the capabilities of civil authorities to preserve law and order and protect lives and property. CIDER report, Appendix 1 to Annex H, will be prepared and submitted through existing command channels to 5USA as soon as possible. Such assistance will continue until:
 - (1) Relieved by higher headquarters, or

 - (2) Effective civilian capability is reestablished.
- f. In the event of a civil defense emergency, within the State of Iowa, all forces not previously mobilized will assemble in accordance with alert and mobilization plans of their respective services. Where radiation or threat of radiation is present personnel will seek shelter in accordance with unit and/or local civil defense plans. Notification of such emergency from any competent source will be sufficient basis for commanders to take action in the absence of instructions from higher headquarters.
- g. After having been declared available for military support of civil defense by 5USA such forces will report their situation to this headquarters and to the task organization commander at the earliest possible time by the most expeditious means available, using the format prescribed in Appendix 3 to Annex H. Survivial Report.
- h. After insuring continuity of operations, force survival, and rehabilitation of essential military facilities, forces made available will be employed as required in support of civil defense.
- i. Support will be provided utilizing elements of task organizations and prearranged plans, where possible. Such support shall be coordinated with and be supplementary to the capabilities of local government.
- j. Task force commanders will respond directly to the mission type requests of the supported civil defense jurisdiction.
- k. Requests for military support will be accepted only on the basis of "mission type" requirements, with the decision resting with the military commander as to the necessity, amount, duration, and method of employment of the support rendered.
- 1. When local military resources are inadequate to meet essential support needs, requests for augmentation will be submitted by the local military commander to the next higher headquarters. The next higher headquarters will coordinate priorities with the counterpart civil defense agency when requirements exceed availability.

- m. Forces will be withdrawn from support missions when the support requirement no longer exists or when higher priority missions dictate withdrawal. The supported level of government shall be notified prior to or concurrent with the withdrawal.
- n. Utilization of forces will be in accordance with capabilities as designated in Appendixes 1 through 9, Annex A.
- o. Military commanders when duly authorized will impose martial rule in accordance with AR 500-50. See Appendix 1 for sample proclamation. Martial Rule will be:
- (1) Limited to the area in which civil authority is ineffective.
- (2) Applied only when superior civil authority can not provide interim control.
- (3) Imposed on the commander's own initiative only when communication to any higher military authority is impossible or when the exigencies of the situation make it manifestly improper to delay.
- (4) Immediately abrogated upon reestablishment of civil government.

6. DEVELOPMENT OF PLANS:

- a. Military contingency plans for operations in a civil defense emergency role will provide for employment of forces under each of the following conditions:
- (1) Support of civil authorities which are still functioning and are capable of controlling minimum essential operations, but not performing all of them.
- (2) Assuming complete control of operations in the event civil control has been destroyed or overwhelmed. See paragraph 5 o above.
- b. Although plans for a civil defense emergency must be sufficiently flexible to permit operations under any foreseeable condition, priority of planning will be given to operations in centers of population.

- c. Insofar as practical, plans will provide for maintaining the integrity of units committed in a civil defense support role to facilitate their withdrawal and employment on other missions when required.
- d. Plans will include provisions for the withdrawal of military forces engaged in civil defense support operations, if it becomes necessary to employ such forces in the conduct of military operations or when they are no longer required for civil defense missions.
- e. Plans for military support will be based on and complement plans developed by civil authority.
- 7. COMMAND AND COORDINATION: Guidance contained herein does not modify or alter responsibilities or command channels established for the military forces of Iowa.
 - a. Pre-attack Planning Relationship. Appendix 2.
- (1) The Adjutant General of Iowa as Executive Director of the Department of Public Defense will serve as the military and civil defense advisor to the Governor of Iowa.
- (2) Sub-Area Commands will have no command authority over forces reported as potentially available for MSCD.
- (3) Sub-Area Commands have no logistical or administrative planning responsibility for units reported as potential tially available for MSCD
- b. Post-attack Relationship. The Adjutant General of Iowa will assume command of Iowa Area Command and will be responsible to Cdr, 5USA for the operational employment of all military forces made available for military support of civil defense. The state of the s
- (1) Operational employment of military forces engaged in civil defense, trans and post-attack, will be conducted in two phases: Note that the property of the contract of the c
 - (a) The Initial Automatic Response Phase, Appendix 3.
 - (b) The Follow-on Controlled Phase, Appendix 4.

- (2) The Initial Automatic Response Phase is the transattack and initial post-attack phase. It is not possible to set a time length for this phase. It will be characterized by lack of information by military and civil authorities at all levels and by a limited or complete absence of communication capability between the various echelons of military and civil authorities. Military support during this period will be provided at a local decentralized level. Operational employment of military forces will be in accordance with the following concepts.
- (a) Military commanders at all levels must first assess their own requirements for survival, recovery, and reconstruction, and for the conduct of their assigned military missions. Damage assessment reports, including the status of forces, will be reported to the next higher head-quarters to the extent that communication will permit.
- (b) Since communication to higher headquarters will probably be disrupted or severely limited, military forces of all services will, as permitted by their own situation and the requirement for military operations, respond to requests for assistance from local civil authorities and the Sub-Area Headquarters. All such activities will, when possible, be reported through Sub-Area Headquarters to HQ Iowa Area Command.
- (c) During this phase of operations all headquarters will be making continuous estimates of the situation and will be working closely with state and local authorities to determine requirements for military support of civil defense.
- (d) Emphasis will be placed upon determining the status of forces then engaged in military support of civil defense activities, the development of means of communication and determining the survival of military forces within the Sub-Area.
- (e) Reserve components of the Army with a Priority I or II on the list of forces potentially available for military support of civil defense may be considered as immediately available for military support of civil defense.
- (3) Follow-on Controlled Phase. This phase will begin when communications permit this headquarters to coordinate the employment of military forces made available for military

support of civil defense within the State. Normally this coordination will be accomplished through the Sub-Area Head-quarters as conditions permit. Operational employment of forces made available for military support of civil defense will be in accordance with the following concepts.

- (a) Consistent with the requirements of 7b (2) (a) above, all commanders will provide, as required, to the Sub-Area Headquarters a summary report of those forces which could be made available for military support of civil defense and the limitations and conditions of the forces' availability. This should be an oral report and amended as necessary on a daily basis, if required. Sub-Area Headquarters will furnish this information to this headquarters. Insofar as may be practical this information will be submitted through command channels.
- (b) Consistent with the limitations or conditions of availability, this headquarters will have the authority to assign tasks and missions to units made available for military support of civil defense. Units or installations will be released by this headquarters or the Sub-Area Headquarters when the mission is accomplished, if not earlier withdrawn by parent service.
- (c) Interstate support not provided for in approved Sub-Area plans will be coordinated by the Commander, 5USA with the appropriate service planning agent(s).
- (d) Parent services may withdraw forces from lists of available forces as necessary to accomplish military operations. Changes in availability will be reported through channels to Commander, 5USA. Withdrawal of forces actually engaged in a military support mission at the time will be coordinated, if feasible, with the headquarters assigning the mission or exercising operational employment.
- (e) In many situations it may be desirable to form multiservice task forces for accomplishment of single missions, or multiple missions in the same geographical area. The senior officer from the forces composing the task force will be designated as the Task Force Controller to control the operations of the task force. Each service having forces assigned will designate an officer to command forces of that service in the task force. Task Force Controller will accept and respond to missions assigned until such time as the task

force ceases to exist or that services' forces are withdrawn from the task force or released from assigned missions.

- (f) Each service is responsible for logistical support of its own forces committed to military support of civil defense. The logistical support responsibilities of this headquarters and Sub-Area headquarters are limited to their own requirements and to the coordinating of logistical support of forces engaged in military support of civil defense as will facilitate operations.
- (g) This headquarters and Sub-Area Headquarters will coordinate requirements of the military forces with civil officials to secure civil resources required to support forces employed.
- (h) The responsibility of this headquarters and Sub-Area Headquarters is limited to rendering such operational and status reports on military operations as may be required by higher headquarters.
- (i) The anticipated flow of requests for military support of civil defense is illustrated at Appendix 4 to this The commander (normally, this headquarters or the Sub-Area commander) accepting a support request, from civil officials will resolve a task-type mission and will then select a force to accomplish the task. Selection will be based on the force's reported availability, capability and proximity to the area in which the support is required. The force to accomplish the mission may be that of the commander receiving the request, especially in the initial automatic response phase as depicted in Appendix 3. The task-type mission will be passed to the commander of the force selected. If the force is in fact available (determined in accordance with this concept) and capable of performing the mission in whole or in part, the commander will accept the mission and accomplish it to the limit of his capabilities.
- (j) Military assistance as provided for in this Annex does not encompass nor authorize the use of military forces to enforce state or local laws, including riot control and/or suppression of insurrection, unless so ordered by Presidential Proclamation as provided for in 10 USC 331 or Martial Rule is proclaimed. This does not preclude a military commander from protecting his own force or resources. That portion of Category A, Capabilities by Category, para 4 to Annex A as pertains to maintenance of law and order and

general police and law enforcement operations is a capability only, and will not be construed to be a mission under this plan. Such law enforcement support will be provided in accordance with AR 500-50.

(k) The operational employment relationship between a force and this headquarters or a Sub-Area commander will extend from the time the force departs its home station to the time of: completion of the task within capabilities, withdrawal by a commander in the normal chain of command, or assumption of the task by civil forces. The operational employment relationship between this headquarters or Sub-Area commander and the force will then cease. Before and after a force is operationally employed in military support of civil defense it will be involved in attaining readiness for its wartime mission. The force's survival, reconstitution, logistical and administrative support, training, movement, and use for military operations will be the responsibility of commanders in the normal chain of command.

To the people of the counties of:

State of Iowa.

Whereas, the armed forces of have attacked the United States; and

Whereas, (Name and Rank) , Commanding General, 5th U.S. Army, by Proclamation dated the day of , 19 , has declared that martial law shall be in effect in the above named counties, and has appointed the undersigned martial law commander of such counties with authority to issue such proclamations, rules and orders and to take such actions as may be necessary during the present emergency;

Now, therefore, I (Name, Rank, Official designation), do hereby announce to the people of the above named counties that, in compliance with the above proclamation, I have taken charge of the governments of the above named counties, of the preservation of order therein, and of putting the area in a proper state of defense.

All persons within the area, whether or not residents thereof or citizens of the United States, are warned that by reason of their presence here they owe during their stay a duty of obedience to the United States, and that they are bound to refrain from giving, by word or deed, any aid or comfort to the enemies of the United States, and from interfering with the recovery operations to be carried on within this area. Any violation of these obligations will be punished by the severest penalties.

The troops under my command, in putting down any disorder and in preventing any aid to the enemy, will act with such firmness and vigor and will use such arms as the accomplishment of their task may require.

The imminence of further attack by the enemy by air and other means, the destruction wrought in the State of Iowa,

and the possibility of invasion make necessary a stricter control of your actions then would be necessary or proper at other times. I shall, therefore, shortly publish general orders governing the conduct of the people of the above named counties with respect to the showing of lights, circulation, meetings, censorships, possession of arms, ammunition, and explosives, the sale of liquors, employment, rationing food and other essential materials, and other matters.

In order to resist in repelling the threatened invasion of this country and to restore order from the chaos of this unprecedented destruction of life and property, good citizens will cheerfully obey this proclamation and the general orders to be published; others will be required to do so.


IOWA AREA COMMAND SUB-AREAS



- Annex E (Service Support) to OPLAN 1, Military Support of Civil Defense, Iowa Area Command, 5USA
- 1. GENERAL: This plan provides guidance for the service support of Military Forces of Iowa in providing support to the Civil Authorities upon implementation of this plan. Insofar as conditions will permit all elements will utilize existing procedures set forth in departmental and multi-service plans.
- 2. PERSONNEL AND ADMINISTRATION: Appendix 1, Administration.
- 3. MATERIEL AND SERVICES:
- a. Normally logistical support will be provided by the nearest military installation. In the immediate post attack period it is possible that the highly developed logistic systems will not be operative. The absence of such systems cannot be permitted to delay operational commitment. Initially local commanders may be required to provide for all of the essential needs of his unit without recourse to his superior headquarters or to predesignated supporting units or installations. See Annex I, Fiscal.
 - b. Appendix 2_{I} Logistics.
- 4. MEDICAL EVACUATION AND HOSPITALIZATION: Appendix 3, Medical.
- 5. CIVIL AFFAIRS:
- a. Military elements will establish necessary liaison with supported civil agencies. Annex \mathbf{G}_{ℓ} Liaison.
- b. Military elements will respond to the mission requirements of civil authority within capability and availability of forces.
- c. In event of civil strife, maximum effort will be expended for the protection of governmental offices, records, personnel and facilities.

Annex E to OPLAN 1, Iowa Area Command, 1 September 1972

- d. Martial law will be imposed only in the event of complete inability of civil governments to maintain law and order. (Appendix 1, Annex C).
- e. Assistance will be provided civil government in maintaining public order and safety in accordance with plans of supported civil authorities. Law enforcement tasks will be performed only in accordance with AR 500-50.
- f. Maximum coordination will be accomplished at the lowest echelon for use of local resources and facilities to support this plan.

g. Economics.

- (1) Protection of Resources. Essential resources may require protection to prevent sabotage, looting or unauthorized use.
- (2) Price Control and Rationing. Assistance may be requested by the civil authorities for implementation and enforcement measures.
- (3) Vital industries may require supplemental protection necessary to continue production following an attack upon the United States.

h. Sociological.

- (1) Public Health. Available medical personnel and resources will be utilized in promoting health measures and in the protection of public health.
- (2) Public Welfare. Mass feeding of civilians authorized if beyond capability of local government. Rations and supplemental assistance to be provided by local civil authorities.
- (3) Displaced Persons. Housing will be accomplished in available shelters in accordance with local civil defense plans and the assistance of welfare agencies.

- 1. GENERAL: Rapid mobilization of reserve component elements will require that commanders of such elements be completely familiar with essential administrative tasks and be capable of implementing the procedures required by their respective service mobilization plans with little or no warning.

2. PERSONNEL:

a. Reports.

- (1) Strength Reports. Strength reports will be submitted through normal command channels in accordance with respective service policy.
- (2) Morning Reports of Army Elements and strength reports of other services will be submitted in accordance with departmental policy. (Army Elements AR 680-1 and para 4-10, AR 135-300).
- b. Replacements. Personnel replacements will be secured through parent service. The following conditions will apply:
- (1) Priority will be given to elements engaged in higher priority missions.
- (2) Recruitment of personnel will terminate upon mobilization if not specifically permitted in departmental plans.

c. Personnel Management.

- (1) The procedures of the respective active services will be implemented upon mobilization.
- (2) Personnel processing and updating of records will not interfere with the performance of assigned missions. Maximum advantage will be taken of any period of increasing world tensions to accelerate personnel processing and in updating essential records.

 - (3) Civilian Personnel.
- (a) Policies for the employment of civilian personnel to be announced.
- (b) Category I, civilian support personnel designated to perform duties of an essential nature during a civil defense emergency shall have in their possession Standard Form 138 (Federal Emergency Assignee Identification Card). Military personnel shall be aware of this identification and its authority to pass the bearer through civil defense lines.
 - d. Development and Maintenance of Morale.

- (d) Welfare organizations may be utilized as required for assistance in personal problems.
 - (2) Graves Registration.
- (a) Collecting points. Collecting points to be established in vicinity of each committed force.
- (b) Cemeteries Use will be made of existing facilities.
- (c) Mass Burial Mass burial of military personnel on authority this HQ.

- (d) Contaminated remains. Request for disposition submitted to this HQ.
- (e) Collection and burial of civilians is the responsibility of civil authorities.
 - e. Maintenance of Discipline, Law and Order.
 - (1) UCMJ applies for all military personnel.
- (2) Personnel awaiting trial for civil or military crimes and offenses will continue to perform duties with units, providing such duty will not violate security requirements.

3. MISCELLANEOUS:

- a. The development and acquisition of adequate publications, blank forms and other administrative support materials or equipment will be in accordance with service policy.
- b. This plan shall not be used as an authority to requisition, store or maintain supplies or equipment which does not conform with service policies and procedures.
- c. The maintenance of a unit log or record of events is encouraged to facilitate the preparation of After Action Reports and to support fiscal programs.
- d. The potential of implementing this plan with no warning requires that all military elements maintain their mobilization plans in an up-to-date condition and will require more frequent review to assure currency of plans.
- e. The degree of coordination required between HQ 5USA this headquarters and other controlling headquarters indicates a need for maximum cooperation on the part of participating elements by providing this headquarters with

- 1. GENERAL: Resource management plans have been developed at National, Regional and State levels for the control of specific resources and economic stabilization measures. These have been developed in twelve broad categories. Of specific importance to military organizations is the impact of a general "freeze order" which will impose rigid controls over the distribution and acquisition of specific resources required by the military to satisfactorily perform missions incorporated in this plan. Military organizations, while performing assistance to civil authorities in accordance with this plan, are considered as prime claimants upon local resources.
- 2. PROCEDURES: Requests for essential items contained within the "freeze order" must be submitted by the military commander, or his authorized representative, to the local supplier in accordance with the following:
- a. The request or order must contain the following statement "This is an essential order authorized by the State of Iowa".
- b. Order must be signed by the unit commander or his authorized representative.
- c. Order must be approved by the local civil executive authority in accordance with the local resource management plan. This individual may be the Mayor, Civil Defense Director or the Chairman of the local Resources Board.
- d. Order for resources will be surrendered to the local supplier at the time of purchase.

Graphic and data service is provided on an individual basis. The AUTOVON is a component of the Defense Communication System (DCS).
- 2. FACILITIES: Facilities are available at the following locations:
 - a. 132nd ADW, Municipal Airport, DES MOINES, (Voice Only).
 - b. 185th TFG, Municipal Airport, SIOUX CITY, (Voice Only).
 - c. 133rd Tac Con Sqdn, FORT DODGE, (Voice Only).
 - d. State Adjutants General, (Voice Only).
 - e. All active military installations in 5USA Area.
 - f. OTAG Iowa and USP&FO Iowa, CAMP DODGE, (Voice Only).
- 3. VOICE PRECEDENCE SYSTEM: Users of long distance AUTOVON service will be affected by the voice precedence system containing the following precedence categories, listed according to importance:
- a. FLASH. Flash precedence is reserved for alerts, warnings, or other emergency actions having immediate bearing on national, command or area security. Its use is generally restricted to announce an alert; opening of hostilities; land, sea, or air castastrophies; high priority intelligence reports, and implementation of emergency action procedures. Calls of this category have precedence over other telephonic calls of lower precedence and pre-empt calls of a lower precedence.

- b. IMMEDIATE: Immediate precedence is reserved for vital communications having an immediate effect on tactical operations, rescue operations, initial reports of damage due to enemy action, natural disasters, and immediate operational traffic. - c. PRIORITY: Priority precedence is reserved for calls which require prompt completion for national defense and security, the successful conduct of war_{v} or to safeguard life or property which do not require a higher precedence. Normally this will be the highest precedence which may be assigned to administrative matters for which speed of handling is of paramount importance. Calls of this category have precedence over calls of a lower precedence and pre-empt calls of a lower precedence.
- d. ROUTINE: Routine precedence is reserved for all other official communications. Routine calls have no precedence over any other calls and are handled as placed by the calling party.
- 4. PRE-EMPTION: Pre-emption permits designated agencies and AUTOVON assistance operators to place higher precedence calls in accordance with priorities listed in para 3 above. Pre-emption procedures provide for automatically disconnecting conflicting circuits without warning.
- 5. DIRECTORIES: Directories are available at each entry point.
- 6. ENTRY: Switchboard operator at OTAG, CAMP DODGE, provides interconnects. Pre-emption capability can not be implemented by the local operator.



- 1. GENERAL: The ISHCS is a reliable and extensive 2 frequency, high band, FM two way radio communication system utilizing a system of repeater stations and base stations providing state wide coverage.

Each base station will be provided with a fallout protection factor of 100. - 3. MISSION: The mission of the ISHCS is to support the following:
 - a. Notify all ISHC employees of an enemy nuclear attack.
- b. Direct and carry out necessary rehabilitation of damaged or destroyed highway systems.
- c. Traffic control and regulation essential to route traffic around contaminated or damaged facilities.
- d. Radiological monitor reporting from ISHC monitoring facilities.

- 2. DESCRIPTION: RACES is composed of volunteer radio operators who, through their state organization, have agreed to provide communications support to civil government in all emergencies.
- 3. The RACES network will be activated in event of an emergency within the State of Iowa and will provide support in accordance with the Iowa RACES Communication Plan. Military personnel and equipment are not authorized to operate in the RACES Nets, however communication support as required will be provided to all agencies employed in civil defense missions. The frequency 53.20 MC (FM) is the nationally assigned frequency for use in emergency areas when required to make initial contact with military units and for communications with military stations on matters requiring coordination.

2. RESPONSIBILITY:

- b. Sub-Area, organizational and unit commanders should be active members of local committees planning for the eventualities of all types of emergencies in order to assure that civil authorities are aware of:
 - (1) Capabilities and limitations of forces.

3. PROCEDURES:

a. Iowa Area Command will:

- (1) During the planning phase maintain liaison with State government in civil defense matters through State Civil Defense Director. During operations a liaison representative will be dispatched to State EOC.
- (2) Maintain liaison with Sub-Area command of adjoining states when the emergency crosses state boundaries.
- (3) Maintain official multiservice liaison with designated officials of Navy, and Air Force Commands. Appendix 3.
- b. Sub-Area Commanders will maintain planning liaison with any designated field representative of the Iowa Civil Defense Division within the Sub-Area and/or the Civil Defense director of priority cities in the Sub-Area. Operational liaison will

- c. Quantity and type of military supplies. Amounts and types of military (Army, Navy, Air Force, Reserve Components) supplies and equipment committed during the reporting period.
- d. Degree to which civil agencies have committed their resources.
 - e. Source of request for military assistance.
- f. Actual or estimated casualties and fatalities of both military and civilian personnel.
- g. Degree to which DCPA, State and Local authorities have assumed responsibilities and are operating in the affected area.

3. REPORT FREQUENCY:

- a. Initial Report.

1. PURPOSE:

- a. The purpose of this plan is to provide guidance in areas related to funding and financial services, to support military forces, in a federal status, performing duty in support of this plan.
 - b. Objectives. The objectives are to:
- (1) Insure that lack of funds does not impede required operations.
- (2) Insure that military pay and disbursing services are adequately provided during periods of emergencies.
- (3) Supplement the fiscal administration capabilities of elements of the state with personnel of available finance units/elements.

2. RESPONSIBILITY:

- a. Each commander is responsible for implementing procedures necessary to produce effective fiscal support and fiscal accounting in accordance with procedures established for each service.
- b. Cdr. FORT MCCOY, WISCONSIN has been give the responsibility of providing fiscal support to Army elements employed in accordance with this plan.

3. FUNDING:

a. In the event communication is reduced or disrupted entirely, the lack of locally available funds will not preclude appropriate commanders from obligating funds for required operations. Commanders at all levels will be prepared to exercise independent judgement in carrying out Military Support operations and financial management related thereto.

- b. Cost reporting systems will be developed by those elements having supervisory responsibility to properly identify emergency costs.
- c. Fund Estimates. Fund estimates will be submitted to Cdr. FORT MCCOY, WI. by this headquarters upon implementation of this plan.
- d. Commanders are cautioned that the degree of applicability of policy enumerate herein is affected by existing area conditions and is announced to permit commanders to initiate emergency rehabilitation measures as the situation may dictate without impediment of financial restraints. As time and conditions permit every effort will be made to reinstate operations under appropriate laws and regulations at the earliest practical date.

4. PROCEDURES:

- a. Class A Agent Officers.
- (1) Reserve components of the Army will follow procedures set forth in AR 135-300 for the appointment of Class A Agent Officers. This headquarters will publish orders and furnish copies of the orders to the servicing FAO and to each Class A Agent designated. Financial procedures and funding guidance provided in AR 135-300 will be used as a guide. Whenever possible, cash payment for small purchases from vendors will be provided by the agent officer.
- (2) Reserve components of the Air Force will be guided by procedures set forth in Chapters 4 and 5, AFM 45-2.
- (3) Marine Corps reserve elements will be guided by those procedures set forth in Marine Corps Reserve Mobilization Standing Operating Procedure.

- b. Adequate records will be maintained in accordance with service policies to account for funds expended in support of missions assigned.
- c. Obligations may be incurred on a deficiency basis under conditions of a properly declared emergency.

5. PAY OF PERSONNEL:

- a. Members of Reserve Components of the Army who reside in Iowa and who are called to active duty to support the Iowa Area Command, when engaged in Military Support to civil authorities for civil defense, will be paid active duty pay and allowances by the FAO, Fort McCoy, Wisconsin.
- b. Members of the active Army will continue to receive their regular pay and allowances from the FAO which normally services them. Participating troops of other services will continue to be paid their regular pay and allowances by finance officers of their respective service.
- c. Commanders of active Army members required to participate in military support to civil defense should assure that each member has made adequate emergency provisions for support of his dependents in his absence by use of Class E, Class L, or Class Q Allotments. Where an Army member has not made adequate emergency provision for support of his dependents, a locally paid Class X allotment should be established under the provisions of Section V, Chapter 5, AR-37-125; Table 6-2-7, DODPM and Chapter 25, SectionIII, AR 37-104-2, Comparable Air Force and Navy regulations will be used to provide emergency payment to dependents of members of those services.
- 6. FINANCE SERVICE: Available finance personnel and units will be assigned functions in support of this plan as required.

- 1. SITUATION: Para 1, OPLAN 1.
- 2. MISSION: Provide a system and establish policies for accurate and timely release of information pertaining to Command and Public Information to support the Military Support Concept, use of the Emergency Broadcast System and Implementation of Field Press Censorship.

3. EXECUTION:

a. Concept of Operation. Command and Public Information programs are vital to a complete understanding, on the part of military and civilian personnel, of civil defense and the concept of providing military support during emergencies. Emphasis at all times will be keyed to allay fear and prevent panic. Maximum release of information at each echelon is authorized and encouraged within the policies announced herein. Information releases will be as complete and factual as possible within the general guidance and policy announced in this plan.

(1) Public Information.

- (a) Pre-Mobilization. Adequate liaison will be maintained with civil authorities (Annex G) to ensure understanding of the mission and role of the military in providing assistance to civil authorities during emergencies.
- (b) Post-Mobilization. The release of information must recognize the needs of the public at all times. Information of the following categories is considered appropriate for release to news agencies:
- l. Public Safety. This may include radiation levels, precautions on eating or consuming potentially contaminated food and water, hazardous conditions on roads, in buildings or specific areas of the community.
- 2. Law and Order. Curfew regulation if established, restrictions on travel or entry into specific areas, penalties for looting or other violation of curfew or existing law.

- 3. Medical Care. Location of facilities where the public may receive medical care or secure required medications and prescriptions.
- 4. Food. Location of available food products or mass feeding points, requirements to be met in event rationing of food products is required and precautions to be followed in securing or preparing food.

- 6. Public Utilities. Actions to conserve power and restrictions on the use of such utilities, actions to prevent extensive damage such as cutting electrical and gas service at entry points into the homes and offices or other buildings in event of extreme emergencies.

- Annex L (Definitions) to OPLAN 1, Military Support of Civil Defense, Iowa Area Command, 5USA
- 1. PURPOSE: The purpose of this annex is to define terms used in this plan and in general use in emergency plans of Federal and State Agencies.
- 2. DEFINITIONS: When used in this plan, the following terms will have the meaning indicated:
- a. Accelerated Mobilization. Mobilization at a rate faster than programmed or planned, requiring entry on active duty of units without regard to planned schedules.
- b. Available Military Resources. Those resources under control of the military forces which are available to a military element for use in assigned missions, as opposed to resources the use of which is restricted to specific mission.
- c. Civil Authority. Those duly elected or appointed civil officials who have the responsibility for control and operations at Federal, State, County or Municipal level.
- d. Civil Defense. All those activities and measures designed or taken to:
- (1) Minimize the effects upon the civilian population which would be caused by an enemy attack upon the United States.
- (2) Deal with the immediate emergency conditions which would be created by any such attacks.
- (3) Make emergency repairs to, or the emergency restoration of, vital utilities and facilities destroyed or damaged by any such attack.
- e. Civil Defense Emergency. An emergency situation resulting from the devastation created by an enemy attack and requiring emergency operations during and following the attack. The emergency may be proclaimed by the President in anticipation of or following an attack, or declared by

concurrent resolution of the Congress, when it appears that the National Safety requires the invocation of the extraordinary authority contained in Title III of the Federal Civil Defense Act of 1950.

- f. Committed Forces. Those military elements, made available for Military Support to Civil Defense Missions, by CG, 5USA, who are actively engaged in such a mission by assignment, or with the approval, of the operational headquarters.
- g. Continuity of Operations. The uninterrupted progress of operations made possible by advance designation of lines of succession for operational headquarters and to positions of responsibility therein.
- h. Federal Agency. Any department, independent establishment, Government Corporation, or other agency of the Executive Branch of the Federal Government (except the American National Red Cross).
- i. Imminent Seriousness. An emergency condition of immediate urgency in which it would be dangerous to delay necessary action by waiting for instructions from higher authority despite the fact such instructions are requested through command channels by the most expeditious means of communication available.
- j. Iowa Area Command. A multiservice military organization created by DOD Directive 3025.10 for the purpose of planning and conducting operations in support of the civil authorities for civil defense. The operational headquarters is composed of the mobilized portions of HQ and HQ Detachment, Iowa Army National Guard and the HQ Iowa Air National Guard, commanded by the Adjutant General of Iowa. Operational elements will consist of all military forces, within the State, made available by CG, 5USA.
- k. Local Authorities. Those individuals or agencies responsible for the operation of government at County or Municipal level.
- 1. Local Resources. Those resources readily available for use in the local area, to include resources owned or controlled by individuals, firms or the government within the locality, the use of which has not been restricted by superior authority.

- m. Martial Rule. Assumption of control over the civilian population by military forces by proclamation of the military commander. Normally accomplished only by proclamation of the President.
- n. Military Forces. Organized elements of the Army, Navy, Air Force, Marines and Coast Guard, both active and reserve components and those civilians employed by such services in accordance with DOD Policy.
- o. Military Resources. Includes personnel, equipment and supplies of Department of Defense agencies, including the Army, Navy, Air Force, Marine Corps, and Defense Supply Agency.
- p. Military Support. Any actions undertaken by Military Forces to assist civil authorities in the performance of their legal functions.
- q. Military Support of Civil Defense. Use of the personnel, materiel, facilities, and other resources of the military departments and defense agencies to support state and local authorities in emergency operations to overcome the effects of a civil defense emergency situation.
- r. Mobilization. Entry into Active Military Service of the United States of Military Forces of the Reserve Components.
- s. Operational Employment. Coordination and control exercised in the employment of military forces in support of civil authorities in a civil defense emergency, it includes the authority necessary to assign tasks and missions to military forces made available for military support and the designation of post-attack objectives for such forces in providing military assistance to civil authorities in a civil defense emergency. This authority may be exercised by the Army Area Command, the Commander, HQ Command, or the Commanders of the State Sub-Area HQ. In accomplishing tasks and missions in support of civil defense the forces made available will remain under the command of the parent military service.

- t. Resources. The supplies, materiel, equipment, facilities, utilities and manpower available for use in a given area.
- u. Resource Management. The management and control of essential resources to ensure their most effective use and equitable distribution in an emergency situation.
- v. State Agency. Any department, agency, division, board, commission or similar structure created to assist in the operation of State Government.
- 3. SUPPLEMENTAL DEFINITIONS: The following terms are in general use by agencies involved in Civil Defense and Emergency Planning and Operations.
- a. Air Defense Emergency. An emergency condition confirmed by either CINCORAD or CINCONAD or higher authority, which exists when attack upon the CONUS by hostile aircraft or missiles is considered probable, is imminent, or is taking place. This condition establishes the highest state of preparedness of military forces and civilian agencies. This condition accomplishes the transition of the air defense system from peace to war, and is the authority to implement approved military and civilian plans and agreements for defense of CONUS, Alaska and Canada.
- b. Air Defense "Red". Attack by hostile aircraft or missiles is imminent or taking place.
- c. Air Defense "Yellow". Attack probable, hostile aircraft or missiles are suspected of being enroute to CONUS.
- d. Air Defense "White". Attack by hostile aircraft or missiles is not considered immediately probable or imminent.
- e. Apple Jack. Air Defense EXERCISE term used to portray Air Defense condition "Red".
- f. Attack Warning. A three to five minute wavering tone on sirens or short blasts on horns or other devices, repeated as deemed necessary. The attack warning signal shall mean that an actual attack against this country has been detected and that protective action should be taken immediately.

- g. Attention or Alert Signal. A three to five minute steady tone. It shall be activated under such circumstances including tornadoes and flash flood, as determined by local officials. It shall mean that all persons should "Listen for essential emergency information".
- h. Checkerboard. EXERCISE term used by the Iowa Civil Defense alert. It is comparable to Air Defense term "Lemon Juice".
- i. Fade Out. Term used by the Civil Defense agencies to announce the termination of a Civil Defense Exercise. It is comparable to Air Defense Exercise Term "Snowman".
- j. Faker. EXERCISE term used by the Iowa Civil Defense Division to portray simulated aircraft.
- k. Foresight. EXERCISE term the first and last word used in transmitting information pertaining to exercises conducted by the Iowa Civil Defense Division.
- 1. Lemon Juice. Air Defense EXERCISE term used to portray Air Defense Condition "Yellow".
- m. Public Shelter. A structure or a group of structures or space therein which, as a minimum, meets DOD standards for the protection of occupants from radiological fallout.
- n. Protection Factor (PF). The degree of radiation attenuation afforded by a shelter, expressed as a ratio of radiation intensity inside a shelter; thus a PF 100 indicates that the radiation intensity inside a shelter is 1/100th of the radiation intensity outside the shelter. PF 40 indicates that 1/40th of the outside radiation would be received inside the shelter.
- o. Snowman. Air Defense EXERCISE term used to portray Air Defense Condition "White".
