Housing in Iowa: 2011

The Fair Housing Act was signed on April 11, 1968, just one week after the assassination of Dr. Martin Luther King, Jr. This landmark bill, Title VIII of the Civil Rights Act of 1968, resulted from the hard work and leadership of Dr. King and others in the civil rights movement and was an important step toward confronting discrimination against minorities in housing. To help celebrate this, April has been designated Fair Housing Month.

The number of housing units in rural lowa in 2009. In 2000, 48.7% of all rural housing units were in incorporated places; 51.3% were outside of incorporated places; including 13.3% on farms.

The 2009 homeownership rate in Iowa. This compares to a U.S. rate of 65.9%.

The 2007 homeownership rate in urban lowa. This compares to a 81.9% rate in rural lowa

The median gross rent in Iowa in 2007. In the U.S. the median gross rent is \$789.

The percentage of owner households who spend 30% or more of their household income on housing costs.




