#### Legislative wrap-up

The first session of the 86<sup>th</sup> General Assembly came to a close on June 5. The Governor completed his actions on the 142 enrolled bills sent to him by the Legislature on July 2. Attached please find the Legislative Summary of Enacted Bills of Public Health Interest.

## CHNA & HIP 2015 progress reports

In the late '80s, IDPH began its first statewide needs assessment and planning effort. At that time, staff traveled to each county with notebooks and pencils. Iowa was the first state to undertake this approach to public health and some questioned its value. Today, it is clear the process of Community Health Needs Assessments & Health Improvement Planning (CHNA & HIP) is a fundamental piece of statewide health planning and represents local action to promote and protect the health of Iowans. This year, local public health agencies submitted progress reports on their implementation efforts. Again this year, agencies are using solid, evidence-based strategies and innovative approaches to improve their community's health status. Please take time to review these locally-based initiatives. Local public health agencies welcome inquiries about their work.

## SBIRT app

The new <u>Screening, Brief Intervention and Referral to Treatment</u> (SBIRT) Iowa app is now available. This new tool, available free of charge, provides important on-the-go substance use information to Iowans, including alcohol and drug screening; information for a loved one; and a treatment facility locator. ## **Program success**

After six years of providing much-needed colorectal cancer education and screenings to Iowans, federal funding of the <u>Iowa Get Screened Colorectal Cancer Program</u> is coming to an end. Over the last six years, a total of 255 precancerous polyps were removed, 1,353 Fecal Immunochemical Tests (FITs) and 270 colonoscopies were provided to Iowans who would not have had access to these vital services without the program. The Iowa Get Screened Program will continue to operate on a smaller level utilizing state funds, and will provide screening services in <u>Polk County</u> and <u>Black Hawk County</u>.


# Monthly data snapshot

## Insurance Coverage among Women of Reproductive Age

According to the 2013 American Community Survey, almost 12 percent of 15-44 year old women in Iowa

old women in Iowa report having no health insurance, compared to the U.S. average of almost 20 percent. Coverage was higher for non-Hispanic women than for minority women in Iowa, which is true of the U.S. as a whole. Almost 90 percent of non-Hispanic White women report having health insurance,
