Legislative Summary

SUMMARY OF LEGISLATION APPROVED BY

THE FIRST REGULAR SESSION OF THE SIXTY-FIFTH IOWA GENERAL ASSEMBLY

MEETING IN THE YEAR 1973

ISSUED BY THE IOWA LEGISLATIVE SERVICE BUREAU

This summary of legislation has been prepared for the use of legislators and other interested persons. The classifications of legislative enactments under specific subject headings and the summary descriptions are the work product of legislative staff personnel. It is recognized that the legislative enactments contained herein may logically fall under more than one subject heading in certain instances and perhaps differences of opinion may arise as to the summary descriptions. However, it is believed that the purpose of this compilation—that of providing interested persons with a quick reference to legislation enacted in specific areas and generally informing them of the contents of the legislation—will be served by this publication.

This compilation contains only bills and resolutions approved by the First Regular Session of the Sixty-fifth Iowa General Assembly meeting in the year 1973.

The various Legalizing Acts passed during the 1973 session are not included in this summary.

AGRICULTURE

- H.J.R. 1 By Pellett and Strothman. Petitions President Nixon, Secretary of Agriculture Butz, and the members of the Iowa Congressional Delegation to release funds being withheld for the Rural Electrification Administration Loan Programs, the Rural Environmental Assistance Program, and the Rural Emergency Loans Program.
- H.F. 32 By Committee on Agriculture. Updates specifications and standards for cheese and cheese products to meet the most recent federal standards. The Act also abolishes the Iowa Butter Control Board which no longer operates and authorizes disposition of their records.
- H.F. 203 By Committee on Agriculture. Deletes the requirement that the Department of Agriculture furnish dealers with a certified copy of the results of tests of their motor vehicle fuel.
- H.F. 210 By Committee on Agriculture. Prohibits the sale, offer for sale, or distribution of teasel or teasel seeds and provides for a fine of up to \$100 for violation.
- H.F. 262 By Stromer. Changes from November 1 to September 1 the date when notification of the termination of a farm tenancy must be delivered to the tenant.
- H.F. 270

 By Committee on Agriculture. Creates an Iowa Egg Council composed of producers, processors, and one hatchery man to promote research and marketing of poultry and poultry products. A referendum procedure is established to determine if egg producers favor the establishment of the Council and the imposition of a tax of not more than five cents for each thirty dozen eggs sold by a producer. If the tax is approved at the referendum, the tax to be set by the Council shall be deducted from the price paid to the producer at the time of delivery to a purchaser for resale. A producer can apply for a refund of the tax. The Act also allows producers to terminate the establishment of the Council and the tax by petition and referendum vote.
- H.F. 375

 By Committee on Agriculture. Directs the Iowa Development Commission to pursue the development of an Iowa grain alcohol motor fuel industry and collect pertinent information on the subject. The Act also requires that any inventor who receives state funds for research in the subject area must assign to the state a portion of his rights to a letter patent.
- H.F. 383 By Committee on Agriculture. Authorizes the Iowa State Commerce Commission to exercise general supervision over the business operations of grain dealers. The Act requires licensing of grain dealers who must have a net worth of \$5,000 or more and requires that a bond be filed with the Commission

in the penal sum of \$15,000 per license. License fees for issuance and renewal are \$25 per year and registration fees of not less than \$5 nor more than \$10 for each vehicle used by a license holder in transporting grain are set by the Commission. Penalties are provided for violation of the Act. The Act is effective September 1, 1973.

- H.F. 402 By Committee on Agriculture. Removes requirement that permit numbers must be printed on containers and labels of Iowa agricultural seeds.
- S.F. 291 By Committee on Agriculture. Establishes a swine tuberculosis eradication program in Iowa under the Department of Agriculture, financed in each county from excess moneys in the bovine tuberculosis eradication funds.
- S.F. 444

 By Committee on Agriculture. Authorizes the Department of Agriculture to establish state-approved feedlots and grazing areas and to consign imported cattle to these areas. Before the removal of condemned cattle for slaughter, the cattle must be tagged after testing. The Act also relates to the destruction of infected herds and quarantines.
- S.F. 571 See Taxation. Relates to removal of tax on livestock.

APPROPRIATIONS

- H.J.R. 19

 By Committee on Appropriations. Appropriates to the Legislative Service Bureau, \$8,000 to contract with the firm of Milliman and Robertson, Inc. to provide detailed cost analyses of legislation relating to no-fault motor vehicle insurance. The Chairmen of the Committees on Commerce in consultation with the Commissioner of Insurance are directed to negotiate and enter into a contract. (Emergency: Effective)
- H.F. 242

 By Committee on Appropriations. Appropriates \$2,891.60 to the Board of Architectural Examiners for the remainder of the current biennium and deletes the requirement that any funds in excess of \$15,000 remaining in the Board of Examiners Fund will revert to the General Fund of the state. (Emergency: Effective April 27, 1973)
- H.F. 291 By Committee on Appropriations. Appropriates to the Commission on Aging, \$35,650 for the first year of the biennium and \$38,830 for the second year of the biennium for salaries, support, maintenance, and miscellaneous purposes.
- H.F. 403 By Committee on Appropriations. Appropriates \$613,000 for the first year of the biennium and \$630,000 for the second year of the biennium from the Iowa Public Employees' Retirement System Fund to the Employment Security Commission for the costs of the administration of the Iowa Public Employees' Retirement System.
- H.F. 572 By Committee on Appropriations. Appropriates money to pay the legislative members of the IPERS Advisory Investment Board \$40 per diem for attendance at meetings of the Board during the last interim. The Act also fixes \$40 per diem pay for legislative members of the Board by law so that separate appropriation bills will no longer be needed.
- H.F. 574 By Committee on Appropriations. Appropriates to the named professional or occupational licensing boards from the funds named for salaries, support, maintenance, equipment cellaneous purposes the following amounts: Board of Funeral Directing and Embalming Examiners Fund, \$5,740 for the first of the biennium and \$6,270 for the second year of the biennium; Board of Dentistry Fund, \$34,750 for the first year the biennium and \$35,220 for the second year of the biennium; State Board of Optometry Examiners Fund, \$9,380 for the first year of the biennium and \$9,510 for the second year of the biennium; State Board of Medical Examiners Fund, the first year of the biennium and \$83,230 for the second year of the biennium; State Board of Examiners for Nursing Home Administrators Fund, \$19,230 for the first year of the biennium and \$19,430 for the second year of the biennium; Chiropractic Examining Board Fund, \$11,570 for the first year

of the biennium and \$12,130 for the second year of the biennium; Board of Nurse Examiners (Nurses Fund), \$202,790 for the first year of the biennium and \$174,560 for the second year of the biennium; and State Board of Physical Therapy Examiners Fund, \$2,630 for the first year of the biennium and \$2,690 for the second year of the biennium. The remainders of each of the funds is appropriated for contingencies. Contingency is strictly defined.

- H.F. 612 By Committee on Appropriations. Appropriates \$10,202.97 for expenses incurred on account of inaugural ceremonies and reception. (Emergency: Effective May 25, 1973)
- H.F. 625 By Committee on Appropriations. Appropriates \$55,000 for each year of the biennium to the Bonus Board for the War Orphans' Educational Aid Fund.
- H.F. 682 By Committee on Appropriations. Appropriates to the Higher Education Facilities Commission, \$300,000 for the first year of the biennium and \$325,000 for the second year of the biennium for scholarships. The Act also appropriates \$40,000 for the biennium for vocational-technical tuition grants for students enrolled in an area school and \$10,000 to administer the vocational-technical tuition grant program.
- H.F. 683

 By Committee on Appropriations. Appropriates to the Higher Education Facilities Commission, \$115,040 for the first year of the biennium and \$118,520 for the second year of the biennium for salaries, support, maintenance and miscellaneous purposes and \$95,560 for the first year of the biennium for the medical student tuition loan program to continue loans to medical students who received loans during the 1971-1973 biennium.
- H.F. 703

 By Committee on Appropriations. Appropriates from the Primary Road Fund to the State Highway Commission for salaries, support, maintenance and miscellaneous purposes; funds to match federal safety funds; equipment, inventory and replacement equipment; unemployment compensation; merit system administration; and highway beautification: \$65,212,177 for the first year of the biennium and \$66,609,506 for the second year of the biennium. The Act provides for 4,266 permanent, full-time persons for the first year of the biennium and for 4,270 for the second year of the biennium with a possible variance of 1%.
- H.F. 716 By Committee on Appropriations. Appropriates from the Marine Fuel Tax Fund to the State Conservation Commission, Division of Lands and Waters, the portion of the Motor Fuel Tax Fund attributable to motor fuel used in watercraft to be used for the Recreational Boating Program. Up to 15% of the Fund may be used by the Commission for repairs and improvements in existing state parks.

- H.F. 720 By Committee on Appropriations. Appropriates to the State Conservation Commission, \$3,000,000 for the biennium for construction, replacement, development, and alterations to state parks and preserves, state forests, and state waters. Approved projects must be reported to the Governor and the State Comptroller.
- H.F. 721 By Committee on Appropriations. Appropriates to the Iowa Reciprocity Board, \$227,700 for the first year of the biennium and \$231,450 for the second year of the biennium for salaries, support, maintenance and miscellaneous purposes.
- H.F. 735 By Committee on Appropriations. Appropriates funds to certain agencies and persons for settlement of claims against the state.
- H.F. 736

 By Committee on Appropriations. Appropriates to the Iowa Merit Employment Department, \$460,253 for the first year of the biennium and \$481,053 for the second year of the biennium for salaries, support, maintenance and miscellaneous purposes. The Act also requires that payments made by covered departments which operate in whole or in part from other than general fund appropriations be deposited in the general fund of the state.
- H.F. 737

 By Committee on Appropriations. Appropriates to the Department of Soil Conservation, \$155,320 for the first year of the biennium and \$158,790 for the second year of the biennium for salaries, support, maintenance and miscellaneous purposes. The Act also appropriates to the Soil Conservation Committee \$1,565,055 for the first year of the biennium and \$1,612,512 for the second year of the biennium for soil conservation work, personnel, watershed planning and development, and conducting soil surveys on lands within the state.
- H.F. 739 By Committee on Appropriations. Appropriates to the Department of Social Services for the operation of the following institutions for Family and Children Services: State Juvenile Home, Toledo, \$1,310,525 for the first year of the biennium and \$1,353,845 for the second year of the biennium; Boys Training School, Eldora, \$2,350,074 for the first year of biennium and \$2,428,609 for the second year of the biennium; Girls Training School, Mitchellville, \$832,145 for the first of the biennium and \$859,443 for the second year of the biennium; Annie Wittenmyer Home, Davenport, \$1,638,900 for the first year of the biennium; and for community-based pilot programs, \$100,000 for the first year of the biennium. The funds are appropriated for 373 full-time persons and no more full-time positions can be authorized, with a variance of 1% in numbers. Maintenance recovery is available and receipts from farm products may be used for farm expenses and repairs. The Department of Social Services is directed to develop a plan for the closing of the Annie Wittenmyer Home and submit

the plan to the Legislative Council for transmission to the Standing Committees on Human Resources and the Human Resources Subcommittees of the Committees on Appropriations.

The Department of Social Services is required to develop a plan for consolidation of the operations of the mental health institutes and for the most efficient and economical future use of the mental health institutes and shall report to the Legislative Council no later than December 15, 1973.
- H.F. 748 By Committee on Appropriations. Appropriates for deposit in the Vehicle Dispatcher's Depreciation Fund, \$80,000.
- H.F. 750 By Committee on Appropriations. Appropriates to the Moneys and Credits Replacement Fund, \$2,500,000 for each year of the biennium for payments to counties.

H.F. 752

By Committee on Appropriations. - H.F. 547 See Law Enforcement. Relates to employment of police chiefs and fire chiefs.
- H.F. 609 By Committeee on Ways and Means. Permits municipally-owned utilities to join with other utilities in the ownership and operation of joint facilities for the transmission or generation of electric energy. The Act also clarifies the powers of municipal utilities to participate in joint projects and to finance their share of the cost.
- H.F. 803 By Committee on Ways and Means. Permits cities owning television translator facilities to finance modifications and improvements upon approval through a referendum election.
- H.F. 807 See Appropriations. Relates to payments to municipalities of funds for sewage works construction.
- S.F. 3 By Griffin. Amends the Home Rule Act to permit special assessments to be levied and improvement bonds to be issued for property within three miles outside of any city's boundaries upon petition of all property owners involved. Approval of the county board of supervisors and the city development board is required.
- S.F. 39 See State Government. Relates to copies of the Code for city assessors.
- S.F. 202 See Transportation. Relates to filing street budget reports.

 By Willits. Permits a sanitary district which lies wholly or partly within a city or town, or whose depository is a municipal sanitary sewage system, to be conveyed to the city or town, upon agreement by the city or town to assume the duties and functions of the district. A petition must be filed with and approved by the county board of supervisors, after notice and hearing.
- S.F. 448 See Transportation. Relates to establishment of urban mass transit agency.

- S.F. 452 By Rodgers. Allows a city or town to join with a township to build and maintain a memorial building.
- S.F. 453 By Kelly. Provides that any increase in the compensation of city councilmen will go into effect for all city councilmen on the first of January following the next election of councilmen.

Corporations

- H.F. 318 By Hill. Deletes the requirement that annual reports of corporations be acknowledged or verified.

Permits foreign life insurance companies admitted to do business in Iowa to become Iowa corporations upon complying with Iowa insurance and corporate requirements and payment of a transfer tax equal to 25% of the premium tax paid to Iowa in the last year or \$10,000 whichever is less.
- S.F. 239 By Committee on Commerce. Increases the total amount of obligations which a development corporation may have to its members from \$8 for each \$1 paid in to \$10 for each \$1 paid in on the outstanding capital stock of such corporation.
- S.F. 289 By Bergman, Priebe, Scott, Rabedeaux, Junkins, Curtis, Briles, Hultman, Shaff, Schwengels, Taylor, Kinley, Rodgers, Coleman, Heying, Winkelman, Tieden, Blouin, Miller of Marshall, and Nolin. Reduces from 75% to 66 2/3% the percent of the membership of a cooperative required to amend the articles of incorporation. It also allows the members to mail in ballots.

Insurance and Banking

- H.J.R. 19 See Appropriations. Relates to study of cost analyses of no-fault motor vehicle insurance.
- H.F. 30 By Holden. Allows real estate brokers acting as salesmen to deposit down payments, earnest money deposits, and other trust funds in the common trust account of the broker for whom he acts as salesman.
- H.F. 156

 By Freeman, Ewing, Oakley, Schroeder, and Menke. Provides that a group life accident or health policy may include in the term "employees" the board of directors of a corporation. The Act also provides that all group accident or health insurance shall contain a provision that persons whose policy ceases by reason of termination of employment shall be entitled to

obtain an individual or family policy without evidence of insurability.

- H.F. 186

 By Committee on Commerce: Provides that the Commissioner of Insurance shall regulate rates charged for credit life or credit accident and health insurance. A charge of not more than seventy-five cents per year per one hundred dollars of the initial amount of decreasing term credit life insurance, or its actuarial equivalent for credit life insurance written on other than the decreasing term basis, is conclusively presumed to meet the requirements of the Commissioner of Insurance. The rate of interest is set at five percent per year unless the parties agree to a different rate not to exceed nine percent.
- H.F. 222 By Committee on Commerce. Grants the Insurance Commissioner the authority to promulgate rules to administer all of the insurance laws of this state.
- H.F. 400 By Drake, Stanley, and McCormick. Allows the city treasurer when so directed to invest retirement funds for policemen and firemen in bank deposits in the same way as the Treasurer of State and other public treasurers may make such investments.
- H.F. 642 By Committee on Commerce. Provides for the regulation of variable contracts of annuities and life insurance. This Act is modeled after the Model Variable Contracts legislation recommended by the National Association of Insurance Commissioners. It amplifies present law and provides more detailed regulation of variable annuity contracts.
- S.F. 3 By Griffin. See Cities. Relates to special assessments and improvement bonds for cities.
- S.F. 9 By Kelly. Changes the rate of interest for all money due or judgments and decrees from 5% to 7% per year.
- S.F. 22 By Doderer and Curtis. Includes all abandoned utility deposits and refunds within the provisions of the Uniform Disposition of Unclaimed Property Act rather than only those in excess of \$50.
- S.F. 123 See Taxation. Relates to taxation of profits of ocean marine insurance.
- S.F. 203 By Committee on Cities and Towns. Repeals the chapter of the Code which requires a semiannual comparison between deposit records of the treasurer of each political subdivision and the bank which serves as public depository.

CONSUMER PROTECTION

- H.F. 186 See Commerce. Relates to regulation of credit life insurance.
- By Committee on Commerce. Regulates the sale, offer for sale, attempt to sell, or lease of land located in another state to the public in this state. The subdivider must file an application containing detailed information with the Iowa Real Estate Commission. Sales may only be made through a licensed real estate broker or salesman. Investigation and inspection powers are given to the Real Estate Commission or the Attorney General. Penalties are provided.
- By McCartney, Kinley, Gluba, Blouin, Bergman, Curtis, Rabedeaux, Briles, Lamborn, Kennedy, Robinson, Rodgers, Gallagher, Priebe, Orr, Taylor, Kelly, Murray, Miller of Des Moines, Miller of Marshall, Potter, Hansen, Tieden, Van Gilst, Winkelman, Coleman, Nolin, Scott, Willits, Palmer, Heying, Andersen, Ramsey, Griffin, Junkins, and Schwieger. Requires that persons selling, leasing, or renting consumer goods or services by means of door-to-door sales provide a written receipt to the buyer informing him that he may cancel the transaction within the following three days if the purchase price is in excess of \$25.

- H.F. 198 By Committee on Human Resources. Removes a reference to the Board of Control of State Institutions.
- H.F. 209 By Committee on Judiciary and Law Enforcement. Makes necessary corrective changes in the Code relating to inaccurate section references and references to abolished boards and departments.
- H.F. 655 By Committee on Transportation. Corrects internal references in the law relating to billboards.
- H.F. 693 By Committee on Natural Resources. Corrects Code references relating to the issuance of bonds for sanitary disposal projects.
- H.F. 762 By Committee on Appropriations. Clarifies present law to specify that the moneys of the Operators Certification Fund are appropriated to the Department of Environmental Quality.
- S.F. 93 By Committee on County Government. Removes a reference to use of marginal entry on mortgages. The Sixty-third General Assembly requires the abandonment of marginal entries on mortgages.
- S.F. 107 By Committee on Judiciary. Corrects a Code section relating to the penalties for violating the law regarding the advertising and sale of courses of instruction to specify in the title to the Act that a penalty is provided.
- S.F. 550

 By Committee on State Government. Makes corrective changes in H. F. 287 which increases benefits under the Iowa Public Employees' Retirement System. The Act changes a section reference and corrects the effective date clause.

COUNTY GOVERNMENT

- H.F. 28 See State Government. Relates to distribution of the Code to county boards of supervisors.
- H.F. 37 See Military Service. Relates to duties of county assessors.
- H.F. 135 See Transportation. Relates to filing of federal tax liens on motor vehicles.
- H.F. 175

 By Committee on County Government. Eliminates fees paid to the sheriff for boarding and washing prisoners and allows the county board of supervisors to reimburse the sheriff for the actual cost of board furnished prisoners. The Act also allows the board of supervisors to furnish supplies to the sheriff and to contract for necessary goods and services for the sheriff.
- H.F. 439 See Law Enforcement. Relates to the establishment of a civil service commission for county sheriffs' deputies.
- S.F. 265 See Taxation. Relates to certification by county auditor for homestead tax credits and military service tax credits.
- S.F. 375 By Committee on County Government. Allows recalculation of amounts payable to counties from the moneys and credits tax replacement fund for errors in calculation of aggregate taxable values and provides for payment of overpayments or underpayments over a three-year period.
- S.F. 441 By Committee on County Government. Provides a ten percent salary increase for members of the boards of supervisors and mileage may be reimbursed up to an aggregate of \$1,000 per supervisor per year. Supervisors paid on a per diem basis shall receive \$40 per day up to a maximum of \$5,500 per year. The annual compensation of the county auditor, treasurer, recorder and clerk of the district court is increased above their annual salary as of January 1, 1973. The annual salary of the sheriff is increased from \$2,000 to \$2,500 annually, depending on county population. The annual salaries of the county attorneys are increased, based on county population, from \$1,000 to \$3,000 annually. The county attorney salaries are minimum salaries and may be increased by the board of supervisors. The board of supervisors is also authorized to provide group insurance, health or medical service for the elected county officers.

COURTS AND THE JUDICAL PROCESS

- H.F. 28 See State Government. Relates to distribution of the Code to judges and juvenile referees.
- H.F. 34 By Hill, Fisher of Greene, Norpel and Jesse. Strikes the listing of fees to be charged by the Supreme Court and provides that the Supreme Court will set its fees by rule in the same manner as the Rules of Civil Procedure are promulgated.
- H.F. 108 By Committee on County Government. Amends the law relating to destruction of original court records by allowing matters dismissed with prejudice before judgment or decree to be kept for one year after the dismissal after reproduction.
- H.F. 116 By Nielsen. Changes the law relating to the appeal of condemnation awards so that whichever party appeals is the plaintiff. Presently the landowner is always the plaintiff irrespective of the party who appeals.
- By Bittle, Doyle, Stanley, Jesse and Fischer of Grundy. H.F. 223 the salaries of full-time shorthand reporters from \$12,000 to \$16,000 per year. Shorthand reporters employed emergency basis are to be paid \$40 per day. Compensation of shorthand reporters serving district associate judges identical to that of those serving district court judges. joint order of the district court judges in a district, the compensation may be increased 5%. The expenses of shorthand court reporters are increased from \$15 per day to \$20 per day. The Act allows shorthand reporters to participate in a group plan. The charge for reporting in cases insurance increased from \$8 per day to \$15 per day.
- H.F. 585 By Committee on Judiciary and Law Enforcement. corrective amendments to the Unified Trial Court Act. The Act removes indictable misdemeanors from the jurisidction of fulltime judicial magistrates for the year beginning July 1, 1973 and ending July 1, 1974; provides that effective July 1, 1974 judicial magistrates shall be required to be full-time attorneys and that their jurisdiction at that time shall that of district associate judges; provides that vacancies occurring in the office of full-time magistrates are to filled by a nomination process through the county judicial magistrate appointing commissions with appointment by the district judges in the election district; provides that the pay of full-time judicial magistrates shall be \$17,200 until 1974, thereafter \$19,500; clarifies procedures July relating to the filing and trying of small claims and traffic violations; replaces the discretionary review procedures contained in the original Act for nonindictable misdemeanors with a trial de novo provision before a district judge with direct appeal to the Supreme Court; provides that jurisdiction of district associate judges shall be that of

H.F. 741 Provides condemnation proceedings, delivery of notice of appeal to the sheriff for his subsequent delivery to the proper person commencement of the appeal proceedings; provides constitutes that if the sheriff fails to make proper delivery, appeal may still be heard if the property owner makes application to the proper district court for further directions as to service within twenty days after delivery of notice of appeal to the sheriff; and provides that any condemnation proceeding pending 1, 1972 which was dismissed for or filed after December failure to serve notice on the proper persons within the required time period shall be reinstated by the court after hearing.
- H.F. 792 See Appropriations. Relates to increase in per diem expenses of judges.
- H.F. 801 By Committee on Appropriations. Increases the salaries of the Supreme Court Justices in 1973-74 to \$30,000 and for 1974-75 to \$33,000 with the Chief Justice receiving \$31,000 and \$34,000. The Act also increases the salaries of the district court judges to \$26,500 for 1973-74 and \$29,000 for 1974-75 with the chief judge of a judicial district receiving \$27,000 The salaries of chief probation officers are and \$29,500. limited to \$16,000 per year, and the salaries οf deputy probation officers and probation officers serving more than one county are limited to \$14,000 per year. Secretarial clerical help needed in the administration of a probation office are limited to compensation of \$9,000 per year.
- S.F. 7 By Committee on County Government. Clarifies present law regarding the information required on a return of marriage document.
- S.F. 26 By DeKoster and Riley. Provides that courts may defer ments in criminal cases under certain conditions; provides that a confidential record of deferred judgments shall the office of the Supreme Court; provides limits retained in on the length of probation periods; provides standards the determining length of probation; makes presentence investigations mandatory in all felony cases after provides rules regulating discharge from probation and the expungement of court records of persons successfully completing probation after judgment was deferred; provides that a plan of restitution must be prepared by the defendant and his probation officer for any victims of the defendant's criminal activity and which the court shall make a condition of probation basing its decision on certain factors provided in the Act; provides that before granting of parole the Board

of Parole may make restitution a condition of parole; alters the time within which judgment must be rendered in criminal cases; and validates judgments deferred prior to passage of the Act.

- S.F. 32 By Potter. Permits the use of an official ink stamp in place of the seal required to be used by a notary public.
- S.F. 199 By Committee on Judiciary. Establishes a 7-member Commission on Judicial Qualifications to review charges brought against district court judges or district court associate judges and hold hearings on the charges. The Commission can apply to the Supreme Court for the discipline, involuntary retirement, or removal of the judge concerned.
- S.F. 514 By Committee on Judiciary. Makes corrective amendments to the rules proposed by the Iowa Supreme Court. Provides that a general verdict, special verdict, or answers to interrogatories may be rendered by five-sixths of the jurors or less until the jurors have deliberated for a period of not less than six hours after the issues to be decided have been submitted to the jurors.
- S.F. 536 By Committee on Judiciary. Requires that a hearing be held before any property may be seized pursuant to the replevin statutes, to accord with both State and U.S. Supreme Court decisions.

EDUCATION

- H.F. 359 By Committee on Education. Amends the state school foundation program to remove miscellaneous income from the computations so that it will not reduce state aid or limit the overall general fund budget. Also, the \$200 per pupil minimum state aid will be in effect only for the school years beginning in 1973 and 1974. Schools are given the option of enrollment in January or September, whichever is larger, and may count in their enrollment students for which they tuition to attend an area school, but not those students attending a laboratory school. Allowable growth for the school year beginning in 1973 is set at 5% and may not exceed 5% in 1974, although a district below state cost may increase by an extra one-fourth or up to state cost. State cost and the determination of a base district cost are modified to of miscellaneous income from the reflect the removal The School Budget Review Committee is given calculations. specific authority to modify allowable growth for individual districts for a number of reasons, depending on whether costs in a district are too high in relation to other factors, or whether unusual circumstances create a need for additional expenditures.
- H.F. 395 By Kreamer. Permits a school district to acquire real estate within or adjoining a municipal airport and to construct a technical school to carry on vocational instruction in aviation mechanics and other aviation programs on the real estate.
- H.F. 401 By Committee on Education. Allows the State Board of Regents, in its function as the board in control of the Iowa Braille and Sight-saving School and the Iowa School for the Deaf, to transfer patients to the University Hospitals for treatment and care without obtaining an order of court.
- H.F. 551

 By Committee on Education. Allows the State Board of Regents to receive state aid under the regular foundation program for students enrolled in laboratory schools within a state university and to transmit those funds to the state university. The laboratory schools presently receive tuition from the schools of residence of the pupils.
- H.F. 594

 By Committee on Education. Requires local public school districts to provide auxiliary services to students attending nonpublic schools in the district, for those services being provided to public school students in the district. Plans must be approved by the Department of Public Instruction and payment of up to \$30 per child will be made on the basis of claims filed by the public school district.
- H.F. 682 See Appropriations. Relates to establishment of a vocational-technical tuition grant program.

- H.F. 705 By Committee on Education. Makes Iowa a party state to the Interstate Agreement on Qualification of Educational Personnel. The Act authorizes the making of contracts by the designated educational person in Iowa to provide reciprocity with other states on acceptance of teacher qualifications.
- H.F. 726 By Committee on Education. Allows school districts to acquire and equip a building for use as a school lunch facility to enable school districts to fulfill conditions for federally-aided school lunch programs.
- H.F. 774 See Appropriations. Relates to Iowa joining the Education Commission of the states.
- H.F. 775 See Appropriations. Relates to expansion of liberal arts curriculum at area schools and clarification of tuition payments of high school students at area schools.
- H.F. 776 See Appropriations. Relates to establishment of unified budgeting and accounting system by the Board of Regents.
- S.F. 219 By Committee on Schools. Establishes uniform statutory distances for required transportation of public school students of two miles for elementary students and three miles for high school students. Allows school boards discretion in transporting students who live within the statutory distances allows boards to charge students the pro rata cost of transportation. The Act allows boards to furnish a bus and driver to senior citizens groups, children's groups, and handicapped persons' groups when the bus is not needed for transportation of pupils and provides for cost reimbursement. The Act also requires school boards to purchase liability insurance for use with the board given discretion in insurance coverages and limits. The Act also requires buses when in use to have their headlights turned on. The board may also transport senior citizens, children, and handicapped persons and collect the pro rata cost of transportation.
- S.F. 586 See Appropriations. Relates to abolishment of the Permanent School Lunch Revolving Fund and clarification of organizations eligible to receive funds from the Vocational Youth Organization Fund.

ELECTIONS

- By Committee on State Government. Revises, clarifies and up-H.F. 745 dates the basic Iowa election laws, with the following major effects: (1) requires statewide permanent registration of voters (heretofore required only in counties of over 50,000 population and cities of over 10,000 population) and makes the necessary changes in election and related laws to reflect this requirement, which takes effect January 1, 1975 although opportunities to register will be offered continuously until that time; (2) incorporates in election laws numerous specific provisions implementing 1972 legislation making county auditors (who are designated county commissioners of elections) responsible for conducting nearly all elections, inprovides cluding city and school elections: (3) canvassing of most elections by county board of supervisors rather than various local governing bodies; and (4) reflects in law the 1972 constitutional amendment lengthening the terms of governor and other major state officials to four years, and makes a similar change in the term of office of the secretary of agriculture, whose term is not set by the Constitution.
- S.F. 313 By Committee on Judiciary. Allows a single election for approval of a bond issue to provide joint facilities between a county and cities or towns within the county. If the bond issues for each will be separate, a vote on the separate bond issues must be provided.
- S.F. 501 By Committee on Human Resources. Provides that polling places be selected with consideration given to their accessibility to elderly persons and physically disabled persons. S.F. 583 See State Government. Relates to filing compaign expenditures after elections.

GENERAL ASSEMBLY

- H.J.R. 22 See Human Resources. Relates to report to General Assembly on intent and objectives of programs at juvenile institutions.
- H.J.R. 23 By Committee on Appropriations. Apportions the legislative salary between the estate of the late Representative Delbert Trowbridge and Representative Rollin Howell who was elected to take his place.
- H.F. 549 By Committee on Rules. Allows members of the General Assembly to employ persons related by blood or marriage as their clerks retroactive to January 1, 1973.
- H.F. 572 See Appropriations. Relates to payments to legislative members of the IPERS Advisory Investment Board.
- H.F. 739 See Appropriations. Relates to report to General Assembly on closing of the Annie Wittenmyer Home.
- H.F. 747 See Appropriations. Relates to report to Legislative Council on consolidation of the operations of the mental health institutes.
- H.F. 785 See Appropriations. Relates to study of Civil Rights Commission by the Legislative Council.
- H.F. 796

 By Committee on Appropriations. Provides an increase in salaries of regular members of the General Assembly from \$5,500 per year to \$8,000 per year and from \$6,500 to \$9,500 per year for majority and minority floor leaders; provides an increase in the expense allowance for members of the General Assembly during the time the General Assembly is in session from \$15 per day to \$20 per day with members from Polk county receiving \$10 per day; provides that travel expenses for members shall be as provided for other employees of the state; provides that the salary of the lieutenant governor and speaker of the house shall be \$12,000 per year; and provides that the per diem allowance for the lieutenant governor and speaker of the house shall be \$60 per day for state business when the General Assembly is not in session.
- H.F. 802 See Appropriations. Relates to report to Legislative Council from Department of Social Services and Department of Health on cooperation in visits to health care facilities.
- S.F. 115 See Law Enforcement. Relates to establishment of a Confidential Records Council composed of members of the General Assembly and others.
- S.F. 476 By Committee on State Government. Increases the membership of the Legislative Council from sixteen to twenty members by adding the chairman and minority party ranking members of the

Appropriations Committees of the General Assembly; provides for a division of the Legislative Council into at least three committees: the Legislative Service Committee to determine policies relating to the Legislative Service Bureau, the Legislative Fiscal Committee to detetermine policies of the Legislative Fiscal Bureau and to direct the performance of audits and visitations, and the Legislative Administration Committee to perform duties as assigned by the Council; provides for specific duties of the Legislative Fiscal Committee: establishes the Office of Legislative Fiscal Bureau, providing for its administration, functions, duties, procedures; provides for a procedure for visitation by subcommittees of the Legislative Fiscal Committee to offices; abolishes the Budget and Financial Control Committee and redelegates its duties and functions.

- S.F. 537 See Appropriations. Relates to report to the General Assembly by the Iowa Drug Abuse Authority.
- S.F. 539 See Appropriations. Relates to report to the Legislative Council of the Department of Social Services of future plans for adult corrections.
- S.F. 540 See Appropriations. Relates to report to the General Assembly by the Commission on Alcoholism on grants to local units or facilities and people served.
- S.F. 581 See Appropriations. Relates to establishment of Legislative Liaison Committee to review the operations of the Crime Commission.
- S.F. 600 See Appropriations. Relates to establishment of Police Communications Review Committee.
- S.F. 604 See Appropriations. Relates to report to General Assembly on expenditure of funds for aid to Indians residing on a settlement.

HUMAN RESOURCES

- H.J.R. 22 By Committee on Appropriations. Directs the Department of Social Services to specify the intent and objectives of the programs being carried out for young persons at Mitchellville, Eldora, Toledo, and the Annie Wittenmyer Home and report to the General Assembly, including recommendations for administrative and legislative changes designed to accomplish program objectives.
- H.F. 240 By Committee on Human Resources. Establishes more detailed requirements for the placement of individuals who have been admitted or committed to state institutions for the mentally retarded to be transferred to other facilities for continued care, treatment, or training. The Act requires appointment of an independent advocate to assist in evaluating a placement arrangement for those who have no parent or guardian or whose parent is unable or unwilling to act. Responsibility for the patient remains with the State Director.
- H.F. 401 See Education. Relates to transfer of patients at the Braille and Sight-saving School and School for the Deaf to University Hospitals.
- H.F. 459 By Committee on Human Resources. Changes qualifications for appointment to the position of Commissioner of Health from a physician specially trained in public hygiene and sanitation to a person qualified in the general field of health administration.
- H.F. 691 By Committee on Human Resources. Provides that the county's liability for 120 days care or treatment for mentally ill persons applies whether the 120 days is subsequent to a single admission or accumulated as a consequence of two or more admissions.
- H.F. 789 By Committee on Appropriations. Makes necessary changes in present laws to provide for replacement of the federally-aided categorical assistance programs, Old-Age Assistance, Blind Assistance and Aid to the Disabled, with a single Supplemental Security Income program administered directly by the federal government. The Act is effective January 1, 1974.
- H.F. 739 See Appropriations. Relates to closing of the Annie Wittenmyer Home.
- H.F. 802 See Appropriations. Relates to cooperation between Department of Social Services and Department of Health on visits to health care facilities.
- S.F. 6 By Committee on County Government. Allows commissions of hospitalization to commit alcoholics and drug addicts to private facilities designated by the Commission on Alcoholism or

the Drug Abuse Authority or any hospital accredited to give psychiatric care, upon approval of the county board of supervisors or upon agreement of the patient or responsible relatives to pay the costs of treatment.

- By Rabedeaux, Schwieger, Andersen, Griffin, Palmer, S.F. 25 and Authorizes the establishment and provides for the regulation of health maintenance organizations (HMOs) in Iowa. Under the Act, an HMO is any person, as defined in Chapter 4 Code, who provides either directly or through arrangements with other persons, health care services enrollees of the HMO for a fixed prepaid fee and undertakes direct responsibility for the provision, availability, accessibility of those services. The HMO may offer indemnity and other benefits through insurers, medical or health service corporations, or otherwise in emergency situations arising while the enrollee is outside the HMO's service area or in other unusual circumstances. The authority to regulate the HMOs in terms of solvency and to issue, deny, suspend, or revoke a certificate of authority to operate an HMO rests with the Commissioner of Insurance, but determinations made by the Commissioner of Public Health in regard to the quality of health care services provided by the HMO shall be binding upon The bill also the Commissioner of Insurance. procedures to be followed by an HMO in obtaining a certificate authority, in issuing and filing evidences of coverage offered to enrollees and in obtaining approval of charges imposed on enrollees. The Commissioner of Social Services is authorized to contract with HMOs for the provision of health care services to Medicaid recipients.
- S.F. 50 By Hansen and Doderer. Abolishes the Basic Science Law and terminates the terms of members of the Board of Basic Science Examiners.
- S.F. 106 By Riley and Potter. Removes the statutory prescription for the amount of compensation and expenses paid to members of commissions on hospitalization and to examining physicians and provides for the amount to be set by a majority of the district court judges in the judicial district in which the commitment hearing is held. In addition, mileage at the rate of ten cents per mile will be allowed.
- S.F. 122 By Murray and Hansen. Establishes by statute the Iowa Drug Abuse Authority, which has functioned by executive order of the Governor since 1971. The Authority is responsible for planning and coordinating drug abuse functions within the state and is directed to work collaboratively with community groups, state agencies and the federal government. Its functions are subject to periodic review by the General Assembly and appropriate federal agencies. Under the Act, a plan for assimilation of the Iowa Drug Abuse Authority by one or more state agencies, or for extension of the life of the Authority,

must be filed by June 30, 1977 and the Authority is to go out of existence one year later.

- S.F. 149

 By Committee on Human Resources. Clarifies settlement of child residing in an institution. The child assumes the settlement of his parent and retains the settlement he has on his eighteenth birthday until he is discharged from the institution and acquires his own settlement.
- S.F. 276 By Curtis. Terminates orders for commitment of delinquent, dependent, or neglected children which were entered before the age of majority was lowered.
- S.F. 383 By Robinson. Amends the Uniform Support of Dependents Law to broaden the definition of child, to clarify that the liability of the natural father shall not be enforceable if the child is born out of wedlock unless he has been adjudicated to be the child's father by a court of competent jurisdiction or has acknowledged paternity; and allows transfers between counties in Iowa for proceedings initiated in other states.
- S.F. 459 By Committee on Human Resources. Authorizes a city or county hospital to sell or lease any property not in hospital use for use as a physician's office, medical clinic or other health related purposes.
- S.F. 570 See Taxation. Relates to state takeover of countys' cost of welfare programs.
- S.F. 598 By Committee on Appropriations. Establishes family practice residency training programs in communities throughout the state for the purpose of providing for the training of resident physicians on the community level. The Act establishes a Family Practice Education Advisory Board and provides an appropriation to pay salaries and support. Appropriates \$925,000 for implementing the program.
- S.F. 604 See Appropriations. Relates to eligibility for Aid to Dependent Children payments.

LABOR AND EMPLOYMENT

- H.F. 503

 By Clark of Lee, Husak, Egenes, Jesse, Drake, McCormick, Stanley, DeJong, Grassley, and Wells. Increases from one week to two weeks the amount of vacation time to which an employee of the state is entitled during his first year's employment.
- H.F. 687 By Committee on State Government. Allows agents of the Employment Security Commission to inspect certain reports required by the Commission of employers on their employees.
- H.F. 751

 By Committee on Appropriations. Allows state agencies, boards, commissions, and departments, except the Board of Regents and the Fair Board, to submit bills to the State Comptroller for payments made to state employees in lieu of contributions for unemployment compensation from moneys in the state treasury not otherwise appropriated.
- S.F. 175 By Nystrom. Extends workmen's compensation coverages to employees at state universities involved in agricultural work of a research or experimental nature.
- S.F. 495 By Committee on Human and Industrial Relations. Adds ployment compensation coverage for domestic and casual employees after July 1, 1974 who earn \$200 or more in any calendar quarter; adds coverage for agricultural employees who earn \$2,500 in the preceding calendar year; makes furnishing physical rehabilitation mandatory and removes any restriction on the amount of medical coverage; adds coverage for life in death cases to widows, and provides a lump sum benefit of two years' benefits in case of remarriage; removes any restriction on the length of the healing period; provides a new formula of spendable income not to exceed 66 2/3% of the state average wage; repeals the 300 day rule; provides provisions for arriving at the 80% of spendable rate; provides for increased occupational disease coverage; and provides for increased coverage for workers working outside the state of Iowa.
- S.F. 512 By Committee on Human and Industrial Relations. Provides 8 enumerated paid holidays off work for state employees and allows for two other holidays to be designated by the Executive Council. The Act also authorizes the Executive Council to designate other days off from employment with pay in addition to those enumerated.
- S.F. 618 See Appropriations. Relates to increases in salaries of state employees.

LAW ENFORCEMENT

- H.F. 61 By Committee on Judiciary and Law Enforcement. Removes provision which allows county attorneys and the Attorney General to retain a portion of the fine recovered under an antitrust suit.
- H.F. 175 See County Government. Relates to payments for boarding prisoners.
- H.F. 405 See Natural Resources. Relates to penalties for violation of water quality standards.
- H.F. 439 By Committee on County Government. Establishes a civil service commission in each county or combination of counties for the purpose of preparing civil service classifications for deputy sheriffs. The sheriff and his chief deputy are exempt from classification, except that in counties with a population of more than 100,000, a chief deputy and two second deputies are exempt from classification and in counties with a population of more than 200,000, the chief deputy and four second deputies are exempt from classification. If a county presently has a civil service commission, this commission will serve as the commission created by law.
- H.F. 547

 By Committee on Cities and Towns. Eliminates the requirement that a police chief must be a member of the civil service system of the appointing authority before becoming chief; standardizes requirements for the positions of chief of police and chief of the fire department and the civil service status for those positions; and transfers retirement benefits and civil service seniority for members of the police and fire department who transfer employment from one city to another to become chief.
- H.F. 694 By Committee on Transportation. Brings the Iowa law relating to the regulation of motor vehicle odometers into conformity with the recently enacted federal law.
- S.F. 66 By Glenn, Lamborn, Doderer, Kennedy, Kelly, and Schwieger. Allows furloughs for inmates of up to 14 days for illness in the family, interviews for jobs, or for training programs. Furloughs may also be granted to allow the inmate to participate in programs or activities that serve rehabilitative objectives. The Act also allows inmates to be released to the supervision of a responsible person to participate in family and selected community, religious, educational, social, civic, and recreational activities for up to twelve months.
- S.F. 75 By Lamborn, Doderer, Glenn, Kennedy, Kelly, and Schwieger. Provides that Iowa join the Interstate Corrections Compact

which authorizes contracts for the transfer of inmates between states. A hearing procedure is provided if the inmate objects to the transfer.

- S.F. 108 By Lamborn. Legalizes certain forms of gambling activities certain conditions. It allows games which are under essentially midway games and bingo at fairs, amusement parks, and civic celebrations with a maximum wager of \$1 and a maximum merchandise prize of \$25. It allows fairs to conduct raffles. It allows games, bingo, and raffles to be conducted by qualified organizations which dedicate proceeds to certain educational, civic, public, charitable, patriotic. religious uses, subject to restrictions. It allows certain kinds of company games, pinball machines, and social gambling. A license from the Department of Revenue is required for some activities. Penalties are provided. (Emergency: Effective June 2, 1973)
- S.F. 115

 By Milligan. Regulates the dissemination and redissemination of criminal history and intelligence data by the Department of Public Safety and criminal justice agencies. The Act creates a council to monitor, review, and make recommendations. Citizens may examine their own records and challenge their accuracy. Civil and criminal sanctions are provided.
- S.F. 224 By Committee on Judiciary. Allows peace officers to exercise their authority in any county, municipality, or township to which they are assigned as part of a mutual assistance agreement.
- S.F. 482 By Committee on Human Resources. Provides for the establishment of community-based correctional programs and services designed to rehabilitate persons charged with or convicted of a felony or indictable misdemeanor and persons on parole or probation. Programs are to be established by judicial districts with the assistance of the Department of Social Services which shall provide for allocation of state funds.
- S.F. 600 See Appropriations. Relates to use of low band and high band frequencies in police communication.

LICENSING AND FEES

- H.F. 229 By Egenes, Stanley, Lippold, Ewing, Roorda, and Drake. Increases the renewal fee for registered architects from \$15 to \$25 annually and allows the Board of Architectural Examiners to retain all funds collected in their trust fund.
- H.F. 292 See Natural Resources. Relates to establishment of a wild turkey hunting license.
- H.F. 383 See Agriculture. Relates to licensing of grain dealers.
- S.F. 178 See Natural Resources. Relates to issuance of trapping licenses.
- S.F. 522 By Committee on Ways and Means. Provides permit and inspection fees for amusement rides and devices, concessions, and electrical equipment. Annual permit fees are \$5; the mechanical and electrical inspection fees for amusement rides and devices is \$35 per inspection; the electrical inspection fee for booths and concessions is \$10 each; and special inspectors fees are \$2 each. The fees are allocated directly to the general fund of the state. The appropriation to the labor bureau for fiscal year 1973-74 is \$53,259 to administer the inspection program.
- S.F. 556 See Appropriations. Relates to fee increases for licenses for movable lunch stands and restaurant kitchens.

LIOUOR

- H.F. 127 By Fisher of Greene. Includes beer in the provisions of the law allowing the purchase of reduced liquor control licenses for veterans organization clubs.
- H.F. 629 By Committee on State Government. Requires the local authority to retain the permit application for a retail beer permit and to send a certified copy of the receipt for the permit fee to the Beer and Liquor Control Department.
- S.F. 144 By Griffin, Kennedy, Blouin, Miller of Des Moines, Gluba, Shaw, and Tieden. Provides that clubs, hotels, motels or commercial establishments which derive more than fifty percent of their gross income in goods and services other than alcoholic beverages or beer may sell alcoholic beverages or beer on Sunday for consumption on the premises only during the hours between 12:00 noon and 10:00 p.m. if the city or town or county governing body approves such Sunday sales within their appropriate jurisdictions. For this additional authority licensees must pay an additional license fee equal to twenty percent of the amount of the original license. All such fees will be deposited in the county menta1 health institutional fund and used only for the treatment of alcoholics in the county. Licensees which place restrictions on membership on the basis of sex, race, religion or national origin are not eligible for the additional authority provided for in the Act.

MILITARY SERVICE

- H.F. 27 By Wells, Harper, Hansen, Edelen, Norpel, Wyckoff, Fischer of Grundy, and DeJong. Returns the obervance day of Veterans' Day from the fourth Sunday in October to November 11.
- H.F. 37 By Committee on Ways and Means. Repeals provision requiring assessors to keep updated lists of children of deceased soldiers who served in the United States Armed Forces.
- H.F. 148 By Wyckoff. Changes the name of the Soldier's Relief Fund to the Veteran Affairs Fund since the fund aids all veterans.
- H.F. 261 By Holden. Allows disabled veterans who receive a grant to buy an automobile or other conveyance from the federal government to receive the registration plates for whatever conveyance they choose to buy from the state without charge. Only automobiles now qualify.
- H.F. 656

 By Committee on Appropriations. Provides compensation for persons serving in the armed forces as follows: For those who actually served in Vietnam at any time from July 1, 1958 until August 4, 1964, \$17.50 per month served not exceeding \$500; for those who served in Vietnam at any time from August 5, 1964 until July 1, 1973, \$17.50 per month for each month served in Vietnam and \$12.50 for each month served elsewhere, not exceeding \$500; for those who did not serve in Vietnam but were in active service from August 5, 1964 until July 1, 1973 at any time, \$12.50 for each month of active military service, not exceeding \$300. Heirs of veterans will be entitled to receive whatever the veterans would receive.

NATURAL RESOURCES

- H.F. 166

 By Committee on Natural Resources. Permits the taking of "chubs" as minnows. Also removes the requirement that basket traps be made of wood and increases the legal size of basbet traps from twenty-four to thirty-six inches in length. Requires that minnow traps have a metal tag attached which identifies the owner of the trap.
- H.F. 174 By Committee on Natural Resources. Requires that game birds and animals kept as pets must be obtained from a licensed game breeder or legal source outside the state.
- H.F. 253 By Committee on Natural Resources. Abolishes permission to release native pen-reared game without a permit.
- H.F. 292 By Committee on Natural Resources. Allows the Conservation Commission, on its own motion, to alter, limit, or restrict the hunting of wild turkeys. Drawings may be held for wild turkey licenses and the special wild turkey hunting license fee is \$10. The Act also provides that the special turkey licenses are not required and turkey hunting limits do not apply on game breeding and shooting preserves.
- H.F. 405 By Committee on Natural Resources. Provides a uniform method for the Department of Environmental Quality and its commissions to conduct administrative searches. It also amends Water Quality Commission's authority to conform to the Federal Water Pollution Control Act Amendments of 1972. Penalties for violations of the water quality standards are increased substantially; civil penalties up to \$5,000 day of per violation and criminal penalties up to \$10,000 per day o f violation.
- H.F. 657 By Committee on Natural Resources. Amends the law relating to the reporting of boating accidents to meet the requirements of the Federal Boat Act of 1971. Requires the filing of a report for any accident or collision with results in property damage in excess of \$100.
- H.F. 779 By Committee on Appropriations. Abolishes the Department of Mines and Minerals and transfers responsibilities of the Department relating to the rehabilitation of land disturbed by surface mining to the Department of Soil Conservation. The Act also appropriates \$23,500 for each year of the biennium to the Department of Soil Conservation for administering its added duties.
- S.J.R. 4 By Winkleman, Tieden, Nystrom, Scott, DeKoster, Schwieger, Priebe, Blouin, Rodgers, Gallagher, and Ramsey. Directs that the United States Army Corps of Engineers be advised that Iowa urges compliance with requirements that approved soil

conservation practices be used in the watershed of multipurpose dams prior to construction of the dams.

- S.F. 178 By Tieden. Prohibits the issuance of a trapping license to nonresidents and aliens. The provisions of the Act are retroactive to January 1, 1973 and fees collected must be refunded.
- S.F. 519 See Appropriations. Relates to functions of county conservation boards.
- S.F. 553 See Appropriations. Relates to permit fee to divert, store, or withdraw waters.
- S.F. 574 See Appropriations. Relates to soil conservation projects.
- S.F. 577 See Appropriations. Relates to acquisition of open space land.

RETIREMENT PROGRAMS

- By Committee on State Government. Legalizes public employee retirement policies which prescribe retirement at age sixty-five years. (Emergency: Effective March 23, 1973)
- H.F. 287 By Committee on State Government. Adds two members of tο the Iowa Public Employees' Retirement System Advisory Board and increases the per diem for service to \$40; increases the covered wages from \$7,800 to \$10,800 annually; reduces the number of years required to become a vested member from 8 to 4; provides a prior service credit for persons who were members of the Iowa Old Age Survivors Insurance System and allows those who withdrew their funds from the abolished system to buy back; provides for service after age sixty-five although a public employers can adopt a policy that requires retirement after age sixty-five; permits retroactive payments; increases the membership benefit formula from 1.45% to 1.57%; changes the method of computing the rate of interest credit for members, and increases from 10% to 25% the percent of the total cost price of common stocks that can be held by the retirement fund. (Emergency: Effective May 24, 1973)
- H.F. 717 By Committee on Cities and Towns. Reinstates the pension benefits under chapter 410 to those persons who were participating in the program before July 1, 1971. A policeman or fireman must pay the city the amount of the fees or assessments he would have paid since July 1, 1971 to July 1, 1973.

STATE GOVERNMENT

- H.F. 28 By Monroe. Provides for the distribution of a free copy of the Code of Iowa to each county board of supervisors, and to each juvenile referee and two free copies of the Code for each judge of the Supreme Court and each judge of the District Court.
- H.F. 307 By Bittle, Stanley, Lippold, Egenes, and Drake. Clarifies and corrects sections of the Code of Iowa relating to the duties and responsibilities of the Director of the Department of General Services. These amendments relate to the Director's authority concerning the maintenance and assignment of space in the State House and other buildings of the capitol complex, the state communications system, the centralized printing operation, the centralized purchasing system, the maintenance and disposal of state-owned personal property, the leasing of property, and the purchase, maintenance and disposition of automobiles. This Act also authorizes the Attorney General to suspend any provision of law relating to the functions of the Department of General Services, if such provision will cause the denial of federal grants or services.
- H.F. 373 By Holden. Requires each township clerk to forward to the Auditor of State a listing of all receipts and disbursements of his office for the preceding two years within 7 days after the day on which a general election is held.
- H.F. 459 By Committee on Human Resources. Abolishes the requirement that the Commissioner of Health be a physician and requires that he be qualified in the field of health administration.
- H.F. 498 By Schroeder and Jesse. Requires the State Comptroller to furnish standard budget request forms to each department or agency of state government.
- H.F. 670

 By Committee on State Government. Removes a reference to the State Printing Board which has been abolished and requires the Executive Council to settle printing disputes on the publishing of notices. The Act also increases the fees for publication of notices from 20 cents to 24 cents for one insertion and from 13 1/3 cents to 16 cents for each subsequent insertion.
- H.F. 696 By Committee on State Government. Allows the State Comptroller to reissue outdated warrants.
- H.F. 704 By Committee on Appropriations. Sets \$40 per diem and payment of actual and necessary expenses and travel for members of statu ry boards and commissions in this state.
- H.F. 751 See Human Resources. Relates to unemployment compensation paid by state agencies, boards, commissions, and departments.

- H.F. 779 See Natural Resources. Relates to the abolishing of the Department of Mines and Minerals.
- S.F. 39 By Committee on Ways and Means. Requires the Superintendent of Printing to furnish city assessors with copies of the Code of Iowa and the session laws.
- S.F. 45 By Doderer. Allows the federal government to be represented on the Midwest Nuclear Board without a vote if federal law provides for it.
- S.F. 82 By Committee on State Government. Lowers the age of majority for most actions from 19 years of age to 18 years of age.
- S.F. 196

 By Hultman, Lamborn, Rabedeaux, Shaw, Murray, Curtis, Coleman, Palmer, and Griffin. Creates an Iowa Library Department headed by a State Librarian. The Act also creates a State Library Commission, consisting of the Supreme Court Administrator and four members appointed by the Governor to administer the Department. The Department is divided into the Medical Library Division and the Law Library Division.
- S.F. 271

 By Kelly. Establishes a regional library system governed by seven regional boards of trustees elected at the general election. Regional boards are authorized to provide direct library service, and other services, by contracting to utilize the strengths of the seven existing public library agencies. Governmental subdivisions are required to maintain a certain millage levy for the support of public libraries receiving services through regional boards. The Act provides an appropriation of \$165,000 for the first year of the biennium and \$230,000 as a replacement for any federal funds which are no longer available as a result of executive action.
- S.F. 396 By Committee on County Government. Requires thirty-day notice by a state agency of any proposed change in rules or regulations relating to local governments.
- S.F. 447 By Riley and Van Gilst. Reduces the number of members serving on the Commission on the Aging, increases the required number of meetings, adds a per diem to be paid to Commission members and provides for the appointment of an executive officer. The Act also requires the Commission to seek resources to provide direct service programs and services to the aging.
- S.F. 583

 By Committee on State Government. Requires the filing of financial statements and reports of all receipts and disbursements by any person, candidate, and political committee supporting or opposing the campaign of any person for public office. Reports are to be filed with the State Commissioner of Elections and the county commissioner of elections. A Campaign Finance Disclosure Commission is created which is responsible for review of the reports and statements filed. Persons violating the provisions of the Act are subject to a

fine not to exceed \$1,000 or imprisonment in the county jail for not more than 30 days. The law also provides for an income tax checkoff to allow taxpayers to contribute \$1.00 to the party of their choice.

S.F. 590 By Committee on Appropriations. Sets the maximum salaries for heads of state departments, agencies, and commissions and sets the salaries of elected state executive officials.

TAXATION

- II.F. 122 By Committee on Ways and Means. Eliminates the exemptions from the use tax of tangible personal property used in interstate transportation or interstate commerce. (Emergency: Effective May 30, 1973)
- H.F. 208

 By Committee on Ways and Means. Clarifies the property tax exemption for cemeteries to include burial grounds, mausoleums, and buildings and equipment owned and operated by nonprofit cemetery associations.
- H.F. 219

 By Committee on Ways and Means. Provides a method for collecting special assessment deficiencies on unimproved property, when the property is subsequently improved by a developer. The city council assesses and collects a deficiency assessment.
- H.F. 314 By Committee on Ways and Means. Subjects the sale of tobacco products to the sales tax and clarifies present law regarding exemptions for products which have been previously subject to a special tax.
- H.F. 315

 By Committee on Ways and Means. Strikes the provision which allocates during the last quarter of a fiscal year ten percent of two-thirds of the sales tax receipts collected during a fiscal year to the Road Use Tax Fund and provides for depositing such receipts in the General Fund of the State commencing July 1, 1975, except that for the fiscal year commencing July 1, 1974 the amount shall be transferred only if the unencumbered balance in the General Fund of the State plus receipts to the General Fund of the State during the fiscal year beginning July 1, 1973 total \$883,000,000 or more.
- H.F. 328 By Committee on Ways and Means. Defines little cigars and subjects them to the same tax imposed on cigarettes and requires them to be stamped as cigarettes are. (Emergency: Effective May 4, 1973)
- H.F. 359 See Education. Relates to changes in the school foundation program.
- H.F. 740

 By Committee on Ways and Means. Provides for the phase-out of the personal property tax in nine steps. Personal property tax assessments in each assessing jurisdiction are prohibited from exceeding the assessments as of January 1, 1973. Each year the state's general fund revenues increase by 5.5%, the State Comptroller and Director of Revenue are required to adjust the personal property tax credit so that each taxpayer will receive a larger personal property tax credit. After nine such increases, all personal property taxes are repealed and the state shall provide replacement moneys not to exceed \$68,000,000 annually.

- H.F. 798 See Commerce. Relates to payment of transfer tax by foreign corporations.
- S.F. 48 By Committee on Ways and Means. Requires cooperative associations to file income tax returns on or before the fifteenth day of the ninth month following the close of the taxable year, which is the same as the requirements for the federal tax return.
- S.F. 64 By Committee on Ways and Means. Allows corporate income tax returns to be signed by the president and a duly authorized officer in the corporation. The Act is effective for tax periods commencing January 1, 1973.
- S.F. 76 By Committee on Ways and Means. Provides that the Department of Revenue shall have six months after notice from a taxpayer of the final disposition of any taxation matter between such taxpayer and the Internal Revenue Service to examine and determine any change in taxpayer's liability to the state. A copy showing final disposition of the federal adjustments shall be attached to the notice to the Department.
- S.F. 123 By Hansen and Griffin. Taxes the underwriting profits generated by the sale of ocean marine insurance written in this state and removes the gross premium tax currently enforced on this type of insurance.
- S.F. 124 By Committee on Ways and Means. Allows purchasing contractors/retailers who hold a retail sales permit to purchase items of tangible personal property without liability for the tax if the property will be subject to the tax at the time of resale or when it is withdrawn from inventory for construction purposes.
- S.F. 131 By Murray and Ramsey. Accelerates time for payment of inheritance tax from within a period of eighteen months after the decedent's death to within a period of fifteen months after the decedent's death.
- S.F. 234 By Committee on Ways and Means. Raises the income level from \$1,000 to \$2,000 for requiring the filing of an individual tax return. Exempts from state income tax those persons whose taxable income is \$4,000 or less. (Effective for tax periods beginning on or after January 1, 1973.)
- S.F. 265 By Committee on County Government. Requires the county auditor to certify only the total amount of dollars, listed by taxing district in the county, due for homestead tax credits claimed and allowed and the total amount of dollars, listed by taxing district in the county, due for military service tax credits claimed and allowed.
- S.F. 375 See County Government. Relates to corrections to payments to counties for moneys and credits tax replacement fund.

- S.F. 376 By Committee on Ways and Means. Provides a property tax reimbursement for persons 65 years of age or older or totally disabled, whether the homestead is owned or rented, and providing they have a household income of less than \$6,000. Renters compute 20% of rents paid as rent constituting property taxes paid. Eligible persons will be able to file a claim for reimbursement of property taxes paid or rent constituting property taxes paid according to a graduated schedule which allows a greater percentage of reimbursement for persons at lower income levels than at higher income levels.
- S.F. 473 By Committee on County Government. Changes the delinquency date for dog license fees to coincide with the delinquency date for personal property taxes.
- S.F. 516 By Committee on Ways and Means. Subjects all property of a municipally-owned electric utility which is held under joint ownership to taxation.
- S.F. 557 By Committee on Ways and Means. Provides that the taxable value of an electric power generating plant placed in commercial service after December 31, 1972 be apportioned, commencing in 1973, as follows: The first \$12,000,000 of taxable value is apportioned to the taxing districts in which the electric power generating plant is located and the remaining taxable value is apportioned proportionally to each taxing district in which electric operating property is located. If the owner is a municipal electric utility, the remaining taxable value is allocated proportionally to each taxing district in which the municipal electric utility is serving customers on the basis of operating electric meters.
- S.F. 570

 By Ways and Means. Removes from the Code the requirement that counties pay a portion of the cost of Aid to Dependent Children, Aid to the Blind, Aid to Disabled and foster care for children under the care of the Department of Social Services, to be effective January 1, 1974. To insure that the benefits of this step are passed along to county property taxpayers, a maximum levy for the support of the poor in each county for the extended fiscal year beginning January 1, 1974 and ending June 30, 1975 is established by reducing the millage rate of 1972 by one and one-half times the amount charged to the counties for these programs in 1972, and for each fiscal year following, at two-thirds of the maximum levy for the extended fiscal year.
- S.F. 571 By Committee on Ways and Means. Exempts all livestock from property taxation and provides a tax credit for each taxing district in the state for each head of livestock that was assessed as of January 1, 1973, in that district. There is appropriated \$4,000,000 for the first year of the biennium and \$8,000,000 for each succeeding fiscal year, or so much thereof as may be necessary, to finance the tax credit.

TRANSPORTATION

Roads and Highways

- H.F. 18 By Committee on Transportation. Requires drivers to yield right-of-way when making a left turn into an alley, private road, or driveway, as well as an intersection.
- H.F. 19 By Committee on Transportation. Substitutes language recommended in the Uniform Vehicle Code for present law relating to driving on the right hand side of the roadway.
- H.F. 22 By Committee on Transportation. Requires road workers engaged in work to be subject to the laws relating to reckless driving and operating a motor vehicle while intoxicated or drugged.
- H.F. 109 By Committee on Appropriations. Allows construction of a rest area facility on the scenic overlook at Loveland in Pottawattamie County and limits expenditures for the facility to \$111,000.
- H.F. 189 By Committee on Transportation. Allows the movement of truck trailers not exceeding 70 feet in length and 10 feet in width manufactured in the state from the point of manufacture or assembly to another point of manufacture or assembly.
- H.F. 193

 By Committee on Transportation. Allows movement of vehicles and loads of excessive size and weight under permit from sunrise to sunset, rather than during the daylight hours, and allows movement until noon on Saturdays and until noon on days preceding holidays and holiday weekends. The holidays are defined.
- H.F. 220 By Committee on Transportation. Prohibits the operation of a motor vehicle, trailer, or semitrailer with a metal track on a paved highway and allows the issuance of special permits to allow the operation of traction engines and tractors having movable tracks on highways.
- H.F. 542

 By Committee on Transportation. Provides for the controlled movement of construction machinery between construction projects and repair shops. The Act provides that this type of equipment may be moved by single-trip permit on designated routes and shall be subject to all other controls as set out in the law relating to movement of vehicles of excessive size and weight.
- S.F. 202 By Committee on Cities and Towns. Removes the requirement that cities and towns file street budget reports with the Highway Commission.
- S.F. 448 By Committee on Cities and Towns. Allows cities, towns, counties, and school districts as public agencies to jointly create a separate public agency for the purpose of establish-

ing or acquiring an urban mass transit system and to maintain and operate the system which is to be governed by a board of trustees representing public agencies which are members. (Emergency: Effective May 26, 1973)

Motor Vehicles

- H.F. 41 By Committee on Transportation. Provides that penalties for violation of temporary restrictions of weight and load limits, imposed by local authorities, shall be computed by dividing the difference between the actual weight and the maximum weight by 100 and mutiplying the quotient by \$2. Resolutions of local authorities must be for a specified period of time and farm tractors are exempt. Mandatory special permits must be issued for trucks moving farm feeds or fuel necessary for home heating purposes.
- H.F. 48 By Committee on Transportation. Defines tandem axle and clarifies present law to allow a 3% tolerance to be allowed on the weight of a tandem axle. (Emergency: Effective April 20, 1973)
- H.F. 135 By Committee on Transportation. Requires that federal tax lien notice on motor vehicles be filed with the county recorder rather than the county treasurer. The lien must be noted on the certificate of title or it is not valid against a good-faith purchaser without knowledge of the lien.
- H.F. 191 By Committee on Transportation. Allows persons owning special mobile equipment which is registered to haul the equipment on a transport vehicle registered for the empty weight of the transport vehicle.
- H.F. 197 By Committee on Transportation. Provides penalties for fraudulent alteration of registration plates, certificates, and permits for motor vehicles issued by county treasurers.
- H.F. 608

 By Committee on Transportation. Specifies that the length of vehicles transporting passenger vehicles, light delivery trucks, panel delivery trucks, pickup trucks, travel trailers, boats, farm and industrial tractors and self-propelled farm implements, and self-propelled vehicles cannot exceed an unladen length of 60 feet, but the passenger vehicles, light delivery trucks, pickup trucks, or boats being transported may extend up to 3 feet beyond the bumpers of the transporting vehicles for up to 65 feet.
- H.F. 694 See Law Enforcement. Relates to motor vehicle odometer regulation.
- H.F. 793 By Committee on Appropriations. Provides that the cost of supplies and materials for manufacturing motor vehicle regis-

tration plates, decalcomania emblems, and validation stickers be paid from the Road Use Tax Fund.

- S.F. 130 By Priebe and Schwieger. Requires the county treasurer to issue for each truck or truck tractor two emblems designating weight limitation to be applied to both sides of the vehicle. The Act also requires the county number to be on all registration plates for all vehicles. (Effective: January 1, 1975)
- S.F. 219 See Education. Relates to school bus transportation.
- S.F. 481 By Committee on State Government. Revises the motor vehicle inspection law. Repeals the authority of the Commissioner of Public Safety to revoke an inspection permit and provides that a person whose vehicle has been inspected may file a complaint with the Commissioner within 15 days of the inspection or before the vehicle has been driven 500 miles. Complaints are to be heard by a hearing officer in the county the complaint is filed. Appeals of a suspension or revocation of an inspection permit may be made to a review board.
- S.F. 602 By Committee on Appropriations. Provides that only those funds in excess of \$20,000 which are remaining in the Motor Vehicle Inspection Fund at the end of each fiscal year shall revert to the General Fund.
