## 2015 Priority Issues

As the 2015 Legislative Session gets underway, the Office of the State Long-Term Care Ombudsman has already identified a number of issues to watch that may potentially impact the lives of residents and tenants residing in Iowa's long-term care facilities. These include:

- Closures, whether voluntary or involuntary, of longterm care facilities;
- 2. Staffing levels at long-term care facilities;
- 3. Recruitment and retention of direct care workers;
- 4. Training to meet level-of-care needs of residents;
- 5. Licensure and training requirements for assisted living program directors and staff; and
- 6. Due process rights for tenants of assisted living programs and elder group homes.

Look for future issues of *The Advocate* to include details of any legislation or rules proposed during this Legislative Session that deal with any of these priority issues or other key policies affecting the health, safety, welfare or rights of long-term care residents and tenants.

# Nursing Facility Leaders Asked to Participate in Rights and Information Survey

In an effort to identify educational topics and resources that would be beneficial to residents of nursing facilities, the Office of the State Long-Term Care Ombudsman is conducting a Rights and Information Survey and respectfully requests all administrators and employees in leadership roles to participate.



Full participation requires completion of two surveys within a oneyear period. If you agree to complete the first survey you will be contacted by a representative of the Office of the State Long-Term Care Ombudsman in approximately one year to complete a second survey. Each survey will take approximately five minutes to complete.

Individual survey responses will not be shared with anyone outside the Office of the State Long-Term Care Ombudsman. Personally identifiable information (name, title, facility) will be used solely for the purpose of contacting participants in the future for the second survey.
