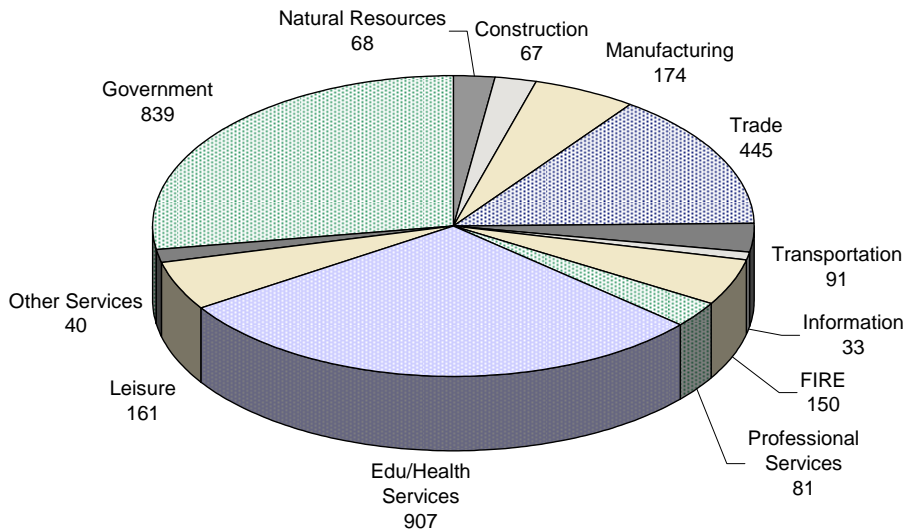
Executive Summary

As of 2003, Calhoun County's largest industry was Education & Health Services, representing 29.68 percent (907) of the county's total covered employment of 3,056. Although the county's total employment decreased by 2.43 percent since 2002, the average annual wage increased by 1.13 percent to \$21,162 for all industries.

Calhoun County's average weekly wage for all industries was \$407 for 2003. This was an increase of 1.24 percent since 2002. The highest average weekly wage for a private sector was in Wholesale Trade, averaging \$665 with gross total wages of almost \$4.6 million. Between 2002 and 2003, the Transportation & Utilities sector had the largest percentage increase in average weekly wage of 20.15 percent (\$81).

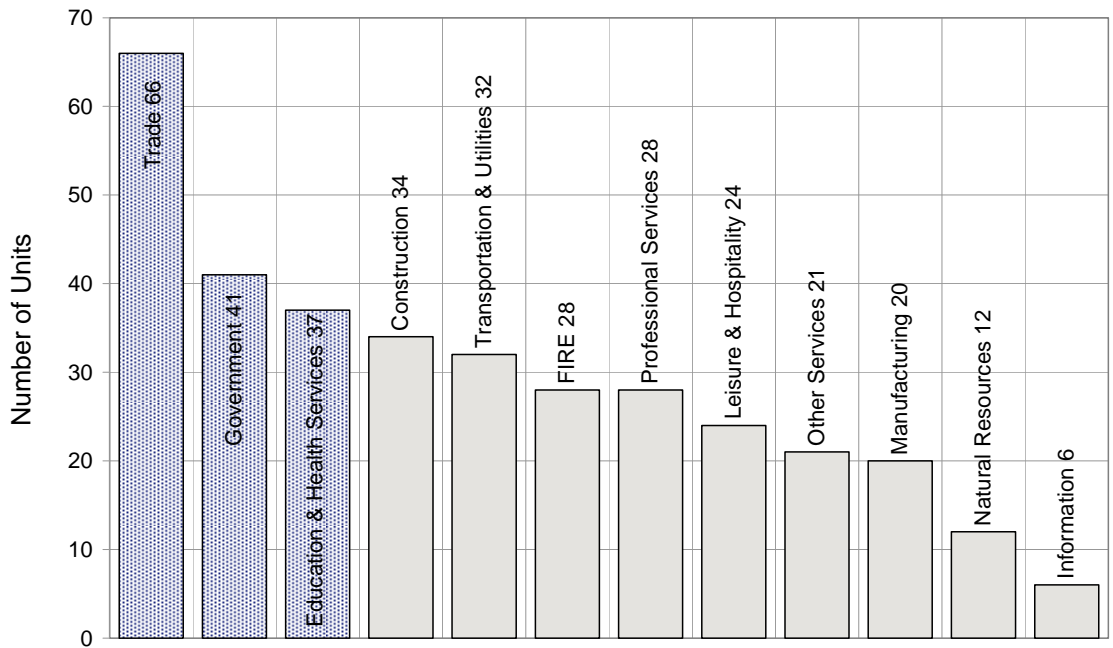

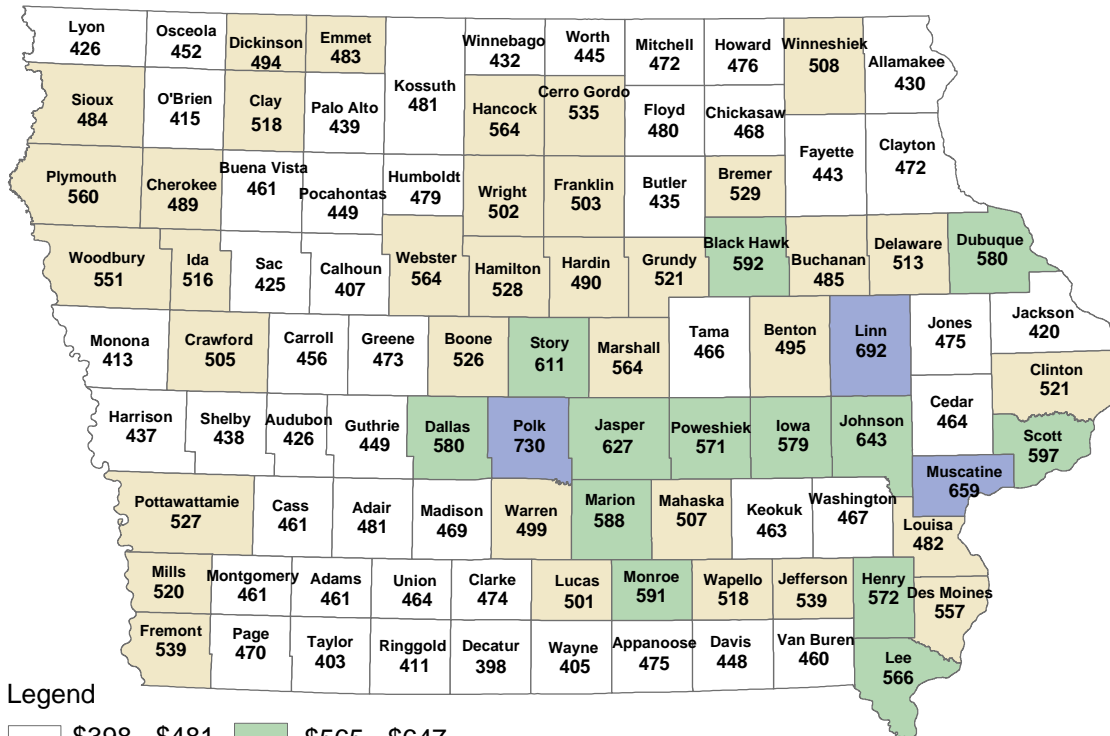

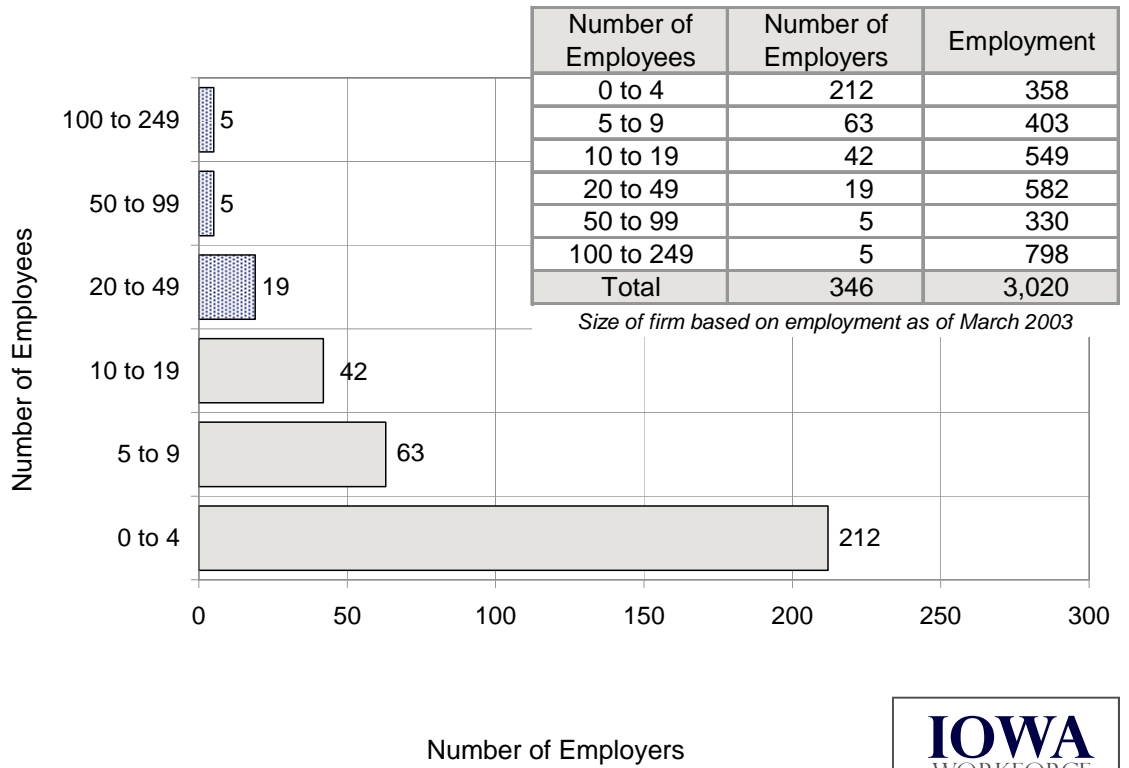
