Spotlight on Melanie Kempf: Long-Term Care Ombudsman!

Melanie has served as a Long-Term Care Ombudsman (LLTCO) for 5 years, covering 13 counties in central and southern lowa.

She grew up in southwest Iowa and now resides in Urbandale with her family. Her husband is Bruce and they have one daughter, Ellison, who will be two in October. About her family, she says: "There is never a dull moment as a parent, and I am reminded of this every day!" She enjoys spending time with family and friends, traveling, doing anything Iowa State, playing volleyball, and running.

About her position, Melanie says: "Our most vulnerable citizens in lowa's long-term care facilities need an advocate; someone they can trust to listen to them, support them, and work on their behalf to resolve their concerns. As a LLTCO, I am an advocate for the resident and feel I can play an important role when there are disagreements between what a resident wants versus what facility staff, family, and/or other legal representatives want or don't want for them. I love the variety in this position: no day is ever the same!"

About our volunteers, she says: "Volunteer ombudsmen are an important piece in advocating for those who reside in Iowa's nursing facilities, so thank you for being a part of our mission in helping maintain and enhance residents' quality of life! As a LLTCO, my time is often spent working on complaint-driven cases, so volunteers serve as the eyes and ears and create a more prominent presence in facilities when I am unable to do so. I see all of our volunteers as assets: you are an extension of myself and the Office of the State LTC Ombudsman, and I appreciate you!"

Volunteer Ombudsman Program Facts

Currently there are 75 Certified volunteers in the program. Together they serve at 66 facilities across 31 counties. There are 54 new volunteers getting ready to start in the program. Since September of 2013, volunteers have made 578 visits to facilities. This amounts to 861 total hours served. The value of an hour of volunteerism in lowa is currently \$20.93 (according to the Independent Sector), together our volunteers have donated more than \$18,000 of their time to advocating for the right of lowa's long-term care residents.
