Auditor of State Mary Mosiman today released a report on the University of Northern Iowa, Cedar Falls, Iowa for the year ended June 30, 2015. The University of Northern Iowa previously released its annual financial report for the year ended June 30, 2015.

The University of Northern Iowa is governed by the Board of Regents. For the fiscal year ended June 30, 2015, the full-time equivalent student enrollment was 9,765 with an average cost per student of \$14,960 compared to 10,024 students and an average cost per student of \$14,471 for the fiscal year ended June 30, 2014.

The University of Northern Iowa (University) is a part of the State of Iowa and, as such, has been included in our audits of the State's Comprehensive Annual Financial Report (CAFR) and the State's Single Audit Report for the year ended June 30, 2015.
