Time Critical Conditions Updates

BETS recently updated the Time Critical Conditions Service Area Map, further refining service areas based on local feedback. The talking points document was also updated. To view the changes, check out the <u>BETS Partnership Development page.</u>

Lucas Assist Device for Cardiac Arrest Program Update

Earlier this year, BETS received a grant from the Leona M. and Harry B. Helmsley Charitable Trust to provide Lucas chest compression system devices in ambulances and hospitals across the state, and to provide training for their use. The device provides automated chest compressions, meaning CPR can be performed longer and more consistently.

The devices were first made available to eligible agencies in Northwest Iowa through an application process. Twenty-five hospitals and 57 EMS services in Northwest Iowa received a Lucas device through this grant.

BETS staff, working with Physio Control, the device's manufacturer, completed a series of 12 training classes in September for the EMS services and hospitals receiving the devices through the first-round of the grant award. More than 220 people attended the training sessions.

Applications for other areas of the state are staggered to be able to more effectively manage distribution of the devices and the training. Contact program coordinator Chris Vitek at chris.vitek@idph.iowa.gov for more information.

Iowa EMS Calls Data

The Bureau of Emergency and Trauma Services (BETS) staff reviewed EMS call data submitted to the Department from January 1, 2014 through December 31, 2014. A total of 267,560 calls from 272 lowa service programs were reviewed. Some highlights are:

Preparedness Program Notes for FY16-17

Technical Assistance Visits

Since this is the last year of the project period, all preparedness capabilities must be completed by June 30, 2017. BETS staff will be scheduling technical assistance visits with each coalition to be conducted before December 31, 2016. These visits are to assist coalitions in completing each capability, and to provide any assistance or resources needed to fully implement the capability.

Spending and Claims Submission

BETS staff will also be working with coalitions to make sure they are on track with spending. BETS' desire is to have 75 percent or more of the preparedness funds spent by May 1, 2017. BETS requires coalitions to submit monthly claims in accordance with the contract, or notify us when there are no expenses for the month. Coalitions that routinely fail to submit monthly claims may be subject to corrective action, up to and including termination of their contract.

Federal Sub-Recipient Reporting

Coalition fiscal agents that receive federal funding for the current budget year are required to complete the Federal Subrecipient Addendum, also known as the FAFTA. Only the fiscal agent needs to complete this form. The form asks for some specific information including the ZIP+4 code, congressional district, and a DUNS number. Check with John Hallman if you have questions on completing the form.

Preparedness vs. Response

When your agency bills staff wages/benefits to one of the emergency preparedness grants, please remember that time spent responding to actual emergencies like tornadoes, flooding, infectious disease outbreaks, etc. isn't allowed. The PHEP and HPP grants can support costs for planning and preparing for many kinds of emergencies. However, once the planning turns into response to a

specific event, the costs are no longer eligible for PHEP/HPP funding. Check with your BETS program contact if you have questions.

FY17-18 Hospital Preparedness Program Comment Period
