Becky Heil will host a panel of Iowa librarians sharing some of what they learned in St. George.

Library HR and the Law = January 23 (1:00-2:30PM) Mandy Easter and Maryann Mori present another legal-information webinar covering the most-asked questions from librarians. This time they will do an overview of human resources laws, rules,

and best practices. Do I need background checks? Are break times mandatory? Can trustees sub for library employees? Can I employ teens? What do I do with that difficult employee? This is the first in a series of HR-related presentations the State Library is planning in 2018.

From Michael Scott

Transitions to the State Library's reference services are well underway. As previewed last month, State Librarian Michael Scott explained needed changes prompted by a new [5-year strategic plan](#) now in place. State Library management has evaluated and re-focused the agency's reference services in order to meet this goal **"Iowans will have access to quality information resources."**



Michael has more: *"...For a number of years, the State Library has maintained two public service points: the Main Library in the Ola Babcock Miller Building and the Law Library at the State Capitol. Starting Monday December 18, we will be consolidating our reference services to one location in the Law Library. The public service desk at the Main Library Miller Building will close and all public reference and information services will move to the Law Library. The Miller building will continue to house our administrative offices and program staff.*

We are excited about this opportunity to restructure our reference and information services program at the State Library. By consolidating these services to the highly visible and iconic Law Library, we hope to see more use while maintaining the high quality services our customers have come to expect. We also want to emphasize that libraries will notice minimal, if any, changes to the services we offer; we are communicating this change to the public and wanted to make you aware as well..."
