# Released Today: Choosing Quality Child Care Core Knowledge Materials

Over the past 6 months Child Care Resource and Referral and the ECI Public Engagement Component Group (Parent Engagement Work Group) collaborated to convened early childhood professionals from various agencies and child care providers in lowa to create materials for parents who are looking to choose quality child care. The goal of this project was to take the most important lowa regulations and best practices of child care and present them in a way that could be used by any agency to develop

educational resources for parents. As professionals, we can use the new core knowledge document to narrow down topics to make selecting child care easier for parents.

Along with the core knowledge document, there are other supporting educational resources about choosing quality child care including a PowerPoint presentation, 15 minute video and 5 minute video. All of these resources were created using the core knowledge document.



The document is not intended to ever be used in its entirety. Instead, it is a guide to develop smaller communication pieces to educate families and communities. If planning to use the core knowledge document, first identify the following:

Target Audience: This is selecting "WHO" to communicate to. It is best to be as specific as
possible when selecting your target audience. For example: First time parents ages 18-24 or
Grandparents caring for their grandchildren full-time. A very specific audience will help narrow
down the message and identify key items to select form the Choosing Quality Child Care Core
Knowledge.

- Medium: This is deciding "WHAT" method to use to communicate to the target audience. For
  example: brochure, flyer, booklet, social media, Power Point, television, radio, etc. Choosing a
  medium will direct the message.
- Message: This is narrowing down "HOW MUCH" information will be used to communicate to
  the target audience using the chosen medium. The amount of information included in the
  message must be appropriate for the type of medium selected. For Example: 10 pages of
  information from the Choosing Quality Child Care Core Knowledge document will not fit on a
  one page brochure.

Selecting the **WHO**, **WHAT** and **HOW MUCH** will help narrow down what information to use from the Choosing Quality Child Care Core Knowledge.

#### **Shared Visions Awardees Announced**

The lowa Department of Education has announced the Awardees for Shared Vision Programs. The competitive grant application process resulted in a total of 67 applications being awarded funding out of the 89 total received. Final award amounts are contingent on the finalization of the state appropriation. FY16 grants are awarded with a renewal option of up to five years provided grantees meet program requirements. The next competitive grant process for Shared Visions Preschool Programs will be for FY21.

# A Message from Sylvia Mathews Burwell, U. S. Health and Human Services Secretary

This year marks a historic milestone for Head Start: its 50<sup>th</sup> anniversary. Since it was created 50 years ago, Head Start has provided more than 32 million children with comprehensive early learning

experiences, including school readiness, health, mental health, nutrition, and family engagement supports. This year alone, that number will be over a million.

Thanks to the work done every day at Head Start centers across America, children's lives have been changed. Millions of kids will learn

to love reading and graduate on time; they will grow up a little more secure, stay out of trouble with the law, and find jobs.

I'm passionate about Head Start for many reasons, but one of them is personal: Head Start helped me.

In my rural home town of Hinton, it was one of the only early educational opportunities around. With an excellent teacher, Mrs. Rita Pack, I learned to love learning, and that love has stayed with me my whole life.

That's a foundation that all children can have.

Today, more than 16 million children in the United States live in families with incomes below the federal poverty level. And that includes a disproportionate amount of children of color: nearly 40 percent of black children and 35 percent of Hispanic children.

In light of these facts, and on this historic anniversary, now is the time to rededicate ourselves to the cause of a head start for those children who need it most. By strengthening the program—through new grants, performance standards, and the funding increases in President Obama's budget—we can continue to keep this promise to our nation's children. Our budget proposal requests over \$10 billion to provide more children with more intensive high-quality Head Start services. That is over \$1.5 billion over this year's enacted budget and a nearly \$4 billion increase over the course of President Obama's time in office.

Additionally, we've announced that Blanca Enriquez, a Head Start leader with 28 years of experience, will also be joining the Office of Head Start as director later this month. She is an excellent addition to our team and we are excited to have her.

Head Start and Early Head Start are crucial to fighting poverty and building up our next generation. They were founded on the principles that education is the door to opportunity; that poverty doesn't have to be a family legacy; and that everyone, no matter their background, deserves a shot at a productive life. That is the core of the American Dream.

Here's to serving our nation's children for another 50 years and beyond! Happy anniversary, Head Start!

# From the National Research Center on Hispanic Children & Families: Guide to healthy marriage and responsible fatherhood programs

Many fatherhood programs serving Hispanic men do not reflect Latinos' unique needs. For example, though a high proportion of low-income Hispanic fathers live with their children, some programs focus on nonresidential fatherhood. This is one finding from a new brief by the National Research Center on Hispanic Children & Families. The Center's guide summarizes aspects of programs on healthy marriage, relationship education, and responsible fatherhood. The Center is led by Child Trends and Abt Associates, with university partners.
