Federal Agencies Draft Policy Regarding the Inclusion of Young Children with Disabilities

On May 12th at a special plenary federal panel at the 2015 Frank Porter Graham Inclusion Institute, the U.S. Departments of Education and Health and Human Services debuted a **draft policy statement** with recommendations to states, local educational agencies, schools, and public and private early childhood programs for increasing the inclusion of infants, toddlers, and preschool children with disabilities in high-quality early childhood programs.

"The federal interagency policy statement on inclusion is a significant milestone for all of us in the field of early development and education," said FPG senior scientist Pamela J. Winton. "By building upon the **2009 position statement on inclusion** developed by the two early childhood professional organizations, the Division for Early Childhood and the National Association for the Education of Young Children, the recommendations in the new policy statement solidify the federal commitment to moving the implementation of inclusion beyond the current status quo."

The new draft policy statement defines inclusion as the practice of including children with disabilities (regardless of the level of disability) in early childhood programs with their peers without disabilities. The statement recaps research in support of inclusion's benefits to children with and without disabilities, outlines the legal foundation for inclusion, points out specific challenges to inclusion, and makes several state and system recommendations.

"What we know from implementation science suggests much work needs to be done to ensure the statement is more than just another piece of paper," said Winton, who chairs the Inclusion Institute. "'Who is in charge of next steps?' and 'How do we mobilize the passion and energy of individuals and groups on this topic?' is an interesting set of questions that I hope can be addressed by leaders in the field."

ACF to Release Final Report Highlighting Significant Accomplishments by State Advisory Councils (SAC) on Early Childhood Education and Care

I am pleased to share that we will soon release a final report highlighting significant accomplishments by State Advisory Councils (SAC) on Early Childhood Education and Care. State Advisory Councils were a dream of the late Senator Edward M. Kennedy. His early vision was to spur states on to better coordinated and higher quality early care and education. With his support, the SACs were authorized in the Head Start Act of 2007 with a goal of promoting partnerships between Head Start Agencies, State and local governments and the private sector.


They were first funded through the American Recovery and Reinvestment Act (ARRA) of 2009. ACF awarded nearly \$100 million of ARRA funding to 45 states, Washington, D.C., Puerto Rico, Virgin Islands, Guam, and American Samoa in the form of SAC grants. This three-year funding was the administration's first investment in building the early childhood infrastructure for the President's Early Learning Initiative.

Many states had already begun to develop early childhood development systems prior to receiving the grant. The SAC grant propelled further improvements in the quality of early childhood programs, better coordination among existing early childhood programs, and streamlined service delivery.

Through the SACs 'work, states developed an unprecedented level of cooperation among agencies and programs and successfully built efficiencies into program service delivery for children and families.

Councils are following the national direction set by Congress and the Administration. The Race to the Top-

Early Learning Challenge and Preschool Development grants required states to maintain an active, fully functioning SAC that meets federal requirements. The reauthorization of the Child Care and Development Block Grant (CCDBG) in November 2014 requires consultation with the



State Advisory Councils. The Strong Start bill recently announced also includes the SACs and the systemic role in the state's early learning efforts.

We are pleased to share this report that illustrates the accomplishments of the State Advisory Councils as they forged ahead to eliminate existing barriers between programs and support stronger early childhood systems. Communication between federal and state funded entities is necessary to ensure quality and access to early care and development for young children across our country.

2015-2016 Nomination Form

The Early Childhood Iowa Stakeholders Alliance is accepting nominations for At-Large members on the ECI Stakeholders Alliance Steering Committee.

There are three categories of ECI SC membership including:

The co-chairpersons of the ECI SA component groups;

A minimum of three at-large members to ensure representation based on a variety of factors including but not limited to geographic, racial/ethnic identity, gender and early childhood sector (i.e., early learning, family support, special needs/early intervention, health, mental health and nutrition). These at-large members shall be nominated by the ECI SA membership or self-nominated. As is true with the component group co-chairpersons, these at-large members shall serve three year terms with a maximum of two terms served consecutively and;

Members designated to meet the requirements of the State Advisory Council initiated through the Head Start federal legislation (42 USC 9801, Section 642B) and the following;

- The Early Childhood Iowa Office lead staff person or designee;
- The staff person responsible for the implementation of the Early Childhood
 Comprehensive Systems Grant or designee, as long as that grant is in effect; and
- A member of the Early Childhood Iowa State Board if and when his or her participation is possible.

The Steering Committee is charged with organizing, managing, and coordinating the activities of the ECI Stakeholders Alliance and component groups which it does during monthly Steering Committee meetings held in Des Moines.
