# FROM THE DIRECTOR



Compiling Iowa College Aid's Annual Report is always a time of reflection for us as an agency. This year, however, is especially meaningful for me as I plan to retire during the next fiscal year, so this report will be my last.

When I came to Iowa College Aid 15 years ago, the agency was just beginning to move beyond its traditional role as an administrator and guarantor of financial aid. Understanding that finances are not the only barrier Iowans face as they make their college plans, we have adopted and created new programs to improve students' access to college and their chances of success once they get there.

In my time here, we have continued our administration of state-funded student aid—almost \$64 million in FY19—even as we transitioned out of our role as a federal loan guarantor. I'm proud to say that we have become a true advocate for the students and families of Iowa at every step on their path toward higher education.

Today Iowa College Aid receives federal GEAR UP and AmeriCorps grants. We oversee school- and community-based programs including Local College Access Networks, the Course to College program, and the Iowa College & Career Readiness Academy. We authorize institutions to offer courses to Iowans, and we ensure that students receive the consumer protections that Iowa law affords them. We conduct research to evaluate both our own programs and the state's progress toward its education goals. We reach tens of thousands of Iowans with information, both digital and print, to promote college awareness and demystify the college-going process.

In my first Annual Report, I wrote, "We are mindful that our work is not done." Fifteen years later, despite the many accomplishments of this agency, that statement remains true. Continuing education beyond high school has never been more important to the success of individual Iowans or to our state than it is today.

In 2012-13, we adopted the motto "Because College Changes Everything." I believe those words. This agency and its staff work every day to enhance the lives of Iowans through education.





## **JULY 2018**

- Staff attended and presented at the NCCEP National Conference in Washington, D.C. Four GEAR UP Iowa students attended the Youth Leadership Summit.
- We awarded Local College Access Network (LCAN) grants to six Iowa communities: Estherville, Franklin County, Mason City, Muscatine, Ottumwa, and Sioux City.
- The expanded Course to College program for 2018-19 opened, offering five initiatives and two levels of involvement.
- The Health Care Loan Repayment Program began.
- The FAFSA became a requirement for the Iowa National Guard Educational Assistance Program.

#### **JUNE 2019**

- Nearly 50 representatives of Local College Access Networks and staff gathered in Des Moines for the 2019 LCAN Convening.
- Division Administrator Julie Ntem graduated from the Iowa Certified Public Manager program.
- Governor Kim Reynolds announced \$16 million in funding for the Future Ready Iowa initiative, including \$13 million for the Last-Dollar Scholarship and \$1 million for the Future Ready Iowa Grant.
- The first cohort of the Iowa College & Career Readiness Academy completed their certificates.

- We released the GEAR UP Iowa Year 7 College Partner Grant Request for Proposals.




# FINANCIAL AID

Iowa College Aid supports students and families as they plan, prepare and pay for higher education. Part of that support in FY19 was the administration of more than \$63 million in Iowa General Fund appropriations under 11 need-based scholarship, grant, and loan forgiveness programs.

## Scholarship & Grant Reserve Fund balance

Iowa College Aid administers the Scholarship and Grant Reserve Fund authorized in Iowa Code Section 261.20 "to alleviate a current fiscal year shortfall in appropriations for scholarship or tuition grant programs that have the same nature as the programs for which the monies were originally appropriated." The maximum balance is 1 percent of the funds appropriated to the Iowa Tuition Grant and Iowa Vocational-Technical Tuition Grant programs.

**lowa Tuition Grant Not-for-Profit** Need-based assistance for Iowa residents in undergraduate programs at Iowa's not-for-profit private colleges and universities.

**Skilled Workforce Shortage Tuition Grant** (Kibbie Grant) Needbased assistance for Iowa residents in high-demand career or technical programs of study at Iowa community colleges.

**lowa National Guard Educational Assistance** (to be renamed National Guard Service Scholarship for FY20) For members of Iowa Air and Army National Guard units in undergraduate programs at Iowa colleges and universities.

**All lowa Opportunity Scholarship** Need-based assistance for students at risk of not pursuing higher education because of social and financial barriers.

**lowa Vocational-Technical Tuition Grant** Need-based assistance for Iowa residents in career or technical programs of study at Iowa community colleges.

Rural lowa Primary Care Loan Repayment For graduates of Des Moines University or the University of Iowa who practice in specified rural Iowa communities for up to five years.

**Health Care Professional Recruitment** (DMU) For Des Moines University graduates who practice in high-need communities in Iowa for up to four years.

**Teach lowa Scholar** For highly qualified Iowa teachers who teach in designated shortage areas in Iowa for up to five years.

**lowa Tuition Grant For-Profit** Need-based assistance for Iowa residents in undergraduate programs at Iowa's for-profit private colleges and universities.

**Health Care Loan Repayment** (formerly Registered Nurse & Nurse Educator Loan Forgiveness) For nurse educators teaching full-time at eligible Iowa colleges and universities, as well as registered nurses, advanced registered nurse practitioners, and physician assistants who practice full-time in high-need communities for five consecutive years.

**lowa Teacher Shortage Loan Forgiveness** Provides an incentive for Iowans to become teachers in high-need positions in Iowa's elementary and secondary schools.

**Education & Training Voucher** (federal) For students who are or were in foster care or were adopted from foster care and who attend an eligible college or university.

**GEAR UP lowa Scholarship** (federal) For students in the GEAR UP lowa cohort (graduating class of 2020 at partner high schools).

## Governor Terry E. Branstad Iowa State Fair Scholarship

For outstanding Iowa high school seniors who have strong academic and leadership credentials and have actively participated in the Iowa State Fair.

This program supports high schools in creating a college-going culture through five steps: Prepare, Apply, Finance, Decide, and Go. Iowa College Aid provides support and resources for schools to assist students from college preparedness through the transition to higher education. In FY19, for the first time, we offered two tracks: Participant and Partner. Partner sites commit to host a fall application event and/or activity, use FAFSA completion data to inform students of their completion status, host a spring decision celebration event and/or activity, develop a summer contact plan, implement yearround college preparation practices, and submit data to Iowa College Aid for each component. This year, 32 of our 119 registered schools chose to be Partner sites. This was also the first year that we offered automated FAFSA reports, and all of Iowa's public high schools signed up.

AmeriCorps members, recruited by Iowa College Aid through an AmeriCorps State Grant, are hosted in high schools around the state as college access coaches. These coaches provide customized direct support to students, as well as capacity development for the schools they serve. In FY19, we placed nine members at seven sites. "Program students" had at least one interaction and at least 15 minutes of time with an AmeriCorps member. In addition, 400 students received electronic communications only.





Local College Access Networks (LCANs) work collectively in communities to raise educational attainment. Iowa College Aid provides funding, training, and technical assistance to align the efforts of various sectors. The total awarded in FY19 was \$460,401. The program grew from 10 to 12 networks, and newer initiatives engage special populations: LatinosCAN (established in FY19) focuses on Iowa's Latinx community, while QSAT (established in FY18) supports LGBTQ youth.

This suite of Iowa-specific online courses helps college access and success professionals provide equitable postsecondary opportunities for all students. In FY 2019, 274 people from 87 school districts, community colleges, colleges/



universities, and Iowa AEAs enrolled in our courses. Of those, 19 participants completed three courses to earn a College Access Professional certificate, and five individuals completed all Academy courses to earn a College Access Specialist certificate.



students complete high school and succeed in college. GEAR UP Iowa follows students from seventh grade through their first year in college. Current GEAR UP Iowa students were high school juniors in FY19. Nearly 70 percent received some form of service in FY19. GEAR UP sponsored ACT testing in nine districts, where the number of students who took the test increased by an estimated 50 percent over non-GEAR UP years.



The Postsecondary School Authorization team authorizes institutions to offer courses and programs to Iowans and ensures that students attending nonpublic postsecondary schools receive the financial protections afforded under Iowa law. We authorize 268 postsecondary institutions in Iowa and throughout the United States that range from unaccredited, nondegree vocational schools to accredited, degree-granting institutions. They offer programs via a variety of teaching methods including distance education. We also work with students who have concerns about their schools to help mitigate or resolve their issues. In FY19, we received and vetted 38 student complaints. The Postsecondary School Authorization team also monitors the status of schools under our oversight and takes action, when possible, to close Iowa enrollment and warn students when a school is in danger of sudden closure. When Iowa students are displaced by a school that suddenly closes, we provide advice about options for debt relief or transfer and, when possible, compile and publish a list of comparable programs at other accredited institutions.

—Findings from "Condition of Higher Education in Iowa 2018"

Iowa College Aid continuously evaluates its grants and programs to assess their effectiveness. The Research Team collaborates with the U.S. Department of Education, the Iowa Department of Education, the Iowa Board of Regents, and Area Education Agencies to provide analytics and insight. The team also maintains a Higher Education Data Center on the agency's website, analyzes data for distribution to the media and the public, and tracks Iowans along a "student continuum" from FAFSA completion to college graduation. In addition to the semiannual "Condition of Higher Education" report and statemandated reports on college enrollment and diversity, the Research team released three research reports and a policy brief in FY19 and presented an analysis of the Iowa Tuition Grant to the Board of Commissioners. The team is currently working to convert the Higher Education Data Center to the Socrata platform, which will enable timelier updates and easier access for users.
