Enclosed is an electronic version (CD) of lowa's 2018 Section 303(d) list. The electronic version is Iowa DNR's official version. The list is being submitted for EPA review and approval pursuant to 40 CFR 130.7(d). In addition to the Section 303(d) list (Integrated Report Category 5), lowa's complete Integrated Report in an electronic version has been included with this submittal. EPA should consider this to be the formal submittal of Iowa's 2018 Integrated Report pursuant to Sections 305(b), 303(d), and 314 of the Clean Water Act. All assessments for the 2018 listing cycle, as well as historical assessments, are available through Iowa's Section 305(b) database, ADBNet (https://programs.iowadnr.gov/adbnet/).

Public comments were sought on Iowa's draft Section 303(d) list from November 14, 2019 through December 28, 2019.

Also included in this submittal is supporting documentation that includes lowa's assessment and listing methodology, the public participation responsiveness summary, and copies of public comments received on Iowa's draft 2018 Section 303(d) list.

As distributed for public comment, Iowa DNR's draft 2018 Section 303(d) list included 622 waterbody segments with a total of 831 impairments. For the final list, two segments were added to lowa DNR's Water in Need of Further Investigation (WINOFI), or potentially impaired list, (Tables 1) based on public comment.

These changes to the Iowa DNR's final Integrated Report did not affect the total number of waterbodies nor the total number of impairments.
