IAShares Deliveries Set To Resume



Delivery Service to Restart June 8th

The State Library is pleased to announce that **IAShares** van delivery service is scheduled to restart on **Monday June 8, 2020**. Thanks to library staff reporting their reopening dates, we have reached the minimum number of public libraries needed to be reopened with staff in the buildings to accept deliveries.

More detailed information will be forthcoming later this week. At this point we want to confirm the start date for **IAShares** that we proposed in [our last update on May 22](#). State Library administrators continue working with StatCourier and Mobius to make final preparations this week. Please note that there may be some modifications to route schedules as most libraries across the state are implementing limited hours and phased reopenings.

State Librarian Michael Scott writes *“Starting next **Monday June 8**, initial deliveries will include all materials that have been stored at the **IAShares** hubs since March 30 **AND** more **IAShares** bags that are due to arrive at the State Library this week.*

Along with delivering materials to libraries, the plan is to pick up as many materials as libraries have ready—more on this process later this week. We ask for

*everyone's patience as we restart the **IAShares** delivery service. Please know that we are working towards as smooth and efficient a process as possible...*"

Thanks to all library staff who answered the call by updating your library's reopening information via our website. **If you have not yet reported your library's reopening date, please do so by clicking the button below and filling out a quick questionnaire.** We ask that you complete this task sooner rather than later.

For those libraries we don't hear from via the online reporting form, expect a follow-up contact from State Library staff to determine your status for receiving ILL deliveries starting the week of June 8. Please understand that your ability to receive ILL deliveries on your scheduled delivery date **DOES NOT MEAN** that your library will be or must be open to the public.

ALA Notes Historic Milestone

By Donating Books to U.S. Libraries

This year marks the 100th anniversary of the passage of 19th amendment granting women the right to vote. To mark this historic milestone, the American Library Association (ALA) is partnering with the Women's Suffrage Centennial Commission (WSCC) to distribute 6,000 youth book sets on women's suffrage to libraries across the country. Public and school libraries are encouraged to apply for

these book sets as a means of highlighting the importance of libraries as hubs of civic education and engagement.

The WSCC selected the books and is providing funding for the project. Each set consists of three books corresponding to different reading levels: **Around America to Win the Vote** by Mara Rockliff for elementary readers; **The Woman's Hour: Our Fight for the Right to Vote** by Elaine Weiss for middle schoolers; and the **National Park Service Women's Suffrage Reader**," an anthology of essays for high school readers.

A working group representing members and staff from ALA's offices and three of its youth divisions will handle the requests. This group has created a recommended list of diverse books, as well as program and display ideas to accompany the book donations. Moreover, ALA and the WSCC will co-host a virtual series surrounding women's suffrage.

Contracting Cities Questionnaire

Complete By June 5th

Public library directors received this notice from Scott Dermont last week. Directors are asked to report all towns that will be contracting for library service in FY2021. Do not include our own city or other funding areas like the rural portion of your

county or funding from any townships. Report those towns without their own municipal libraries that are contracting for service with your library.



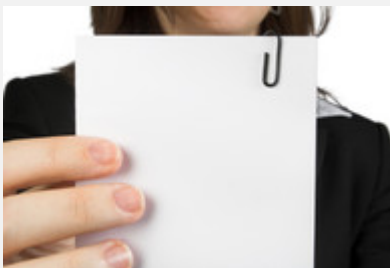
These service contracts should be written and include a stated monetary obligation. Because of changes to the Open Access Program (changes that went into effect in July 2017) the State Library now needs the dollar amount of the contract in addition to the name of the contracting town(s)

Among other things, this information regarding contracting cities is helpful for library staff when they need to determine if out-of-town visitors are legitimate Open Access customers or not. If out-of-town visitors are actually residents of contracting cities, then those people are Open Access customers. All contracting cities are listed on the Open Access form and in the “Contracting Cities” file on our website.

We’re using Survey Monkey to collect your responses. The questionnaire should take less than 5 minutes to fill out depending on the number of cities you need to report. NOTE: If your library does not provide to other towns via contracts, you do not need to answer the survey. However, if your library has provided service in the past but will longer have contractual agreements in place in FY20121, it will be very helpful if you will fill out the first page of the survey and answer "No." Please complete the “**Contracting Cities Questionnaire**” by June 5.
