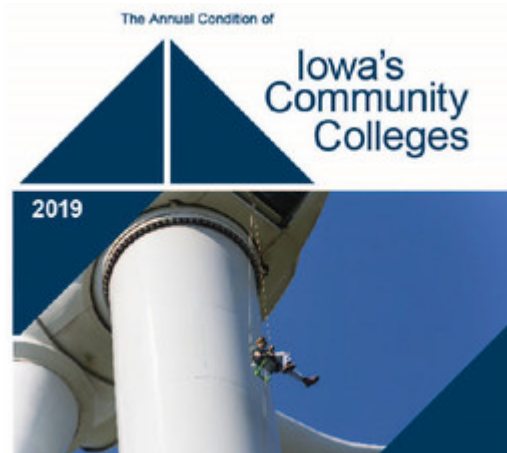

[2019 Condition of Community Colleges Report now available](#)



The Division of Community Colleges and Workforce Preparation (division) released its [Annual Condition of Iowa's Community Colleges 2019](#) report at the State Board of Education meeting on Jan. 23. The report provides a comprehensive overview, including academic year and trend data on enrollment, credit and noncredit programs, joint enrollment, adult education, online course delivery, student success, human resources, finances and more.

Report highlights include:

- **128,624:** The number of students enrolled in community college credit courses, down slightly from 131,144 the year before.
- **62,731:** The number of students enrolled in online credit courses through an Iowa community college, up from 60,689 the year before.
- **50,587:** The number of jointly enrolled students who earned college credit while in high school, down slightly from 51,001 the year before. Jointly enrolled high school students account for 39.3 percent of total community college enrollees and 24.8 percent of total credits.
- **764:** The number of high school students who participated in health sciences, technology, engineering and other programs through the Summer College Credit Program.

- **34.5%:** The percent of students under the age of 18 enrolled in community college courses, the highest in the nation.
- **23.1%:** The percent of community college enrollment from racial and ethnic minority groups, which represents a record high.
- **17,377:** The number of credit awards earned (associate degrees, certificates and diplomas), up from 16,747 the previous year.
- **43,538:** The number of noncredit program awards, up from 26,005 the year before. The majority of these awards (72.4 percent) were industry-awarded credentials designed to lead to or enhance employment opportunities.

Curriculum management system contract extended for one year



The Iowa Department of Education (Department) is in the process of extending its contract to provide CurriQunet META for an additional year, through Jan. 2021. The system, which is used to manage the state's career and technical education (CTE) program approval workflow and common course numbering, was previously scheduled to shut down on Jan. 31.

This transition from CurriQunet's META to DIGARC's Curriculog workflow platform is not expected to be completed this calendar year. The extension of the current contract ensures continued service for the next 12 months. Input sought on draft plan to meet federal career and technical education law

The Department is holding three [public input meetings](#) on Thursday, Feb. 6 from 4:30 to 6:30 p.m. in Cedar Rapids, Council Bluffs and Johnston to gather feedback on the draft of Iowa's state plan for meeting requirements of the federal Strengthening Career and Technical Education for the 21st Century Act.

Commonly referred to as Perkins V, the federal law reauthorizes the Carl D. Perkins Career and Technical Education Act of 2006, which provides support for career and technical education (CTE) programs in all 50 states and U.S. territories. CTE programs increase student engagement through the integration of technical and academic skills in hands-on, real-world learning experiences.

Strengthening Career and Technical Education for the 21st Century Act



The draft of Iowa's state plan incorporates input received through a state advisory council, education work teams and written comments and includes strategies for addressing the following new key priorities:

- Expanding high-quality CTE programs to middle school students.
- Focusing on teacher recruitment, retention and professional development, particularly in the area of work-based learning.
- Growing career and technical student organizations across the state to enhance classroom learning through real-world experiences.

Iowa Skilled Worker and Job Creation Fund reports released



The division recently released fiscal year (FY) 2019 reports for the Pathways for Career Employment (PACE), Gap Tuition Assistance, Work-Based Learning Intermediary Network, Adult Education and Literacy Programs (AEL), and the Workforce Training and Economic Development Fund (WTED). These programs are funded through the Iowa Department of Education's allocation of the Iowa Skilled Worker and Job Creation Fund, which was created to support worker training and job creation efforts with funding from the state's gaming industry receipts.

FY19 report highlights include the following:

- A total of 1,179 applicants were approved for tuition assistance under the Gap Tuition Assistance Program and 816 students completed their programs during FY19.
- A total of 2,906 applicants were approved for tuition assistance under PACE. By the end of AY18-19, 996 students received an award through credit programs, 627 completed noncredit programs, 978 earned National Career Readiness Certificates (NCRC) and 966 earned third-party credentials.
- The Iowa Work-Based Learning Intermediary Network provided services to 121,681 educator and student participants.
- Iowa's AEL programs served 16,551 unique participants.
- A total of 74,101 participants and 2,488 businesses benefited from programs funded through the WTED fund.

Request for proposals for grant funds to support adult education programs, increase credential attainment



The division will be releasing a request for proposals (RFP) on Feb. 14 for approximately \$3 million in Adult Education and Family Literacy Act (AEFLA) grant funds and workforce training funds through the Workforce Innovation and Opportunity Act (WIOA) to support the following three programs:

- Adult Education and Family Literacy Act (AEFLA) (WIOA Section 231)
- Corrections Education and Other Institutionalized Individuals (C&I) (WIOA Section 225)

- Integrated English Literacy and Civics Education (IELCE) (WIOA Section 243)

A Bidders' Conference for interested parties will be held Feb. 20 at the Grimes Building, B50, 400 E. 14th Street, Des Moines, Iowa from 10 a.m. to 4 p.m. Any organization that has demonstrated effectiveness in providing adult education and literacy activities is eligible to apply for grant funding.

Application materials, policies and criteria for submitting proposals are available on the Adult Education and Literacy section of the Iowa Department of Education's [website](#). Completed applications must be submitted via [IowaGrants](#) by 4 p.m. on April 3 to be considered for funding. Award announcements will be made in June.

Input sought on draft plan to meet the federal Workforce Innovation and Opportunity Act



As required under the Workforce Innovation and Opportunity Act (WIOA), Iowa's draft 2020 Unified State Plan has officially been released for public comment. The plan provides a vision for workforce, education and economic development policy in the state while also serving as a federal compliance document for the U.S. Departments of Labor and Education under WIOA.

The public comment period is open through Feb. 5. Individuals can make a general comment about the draft Unified State Plan or click directly in the draft text to make comments about specific sections from the [public comment website](#).

The 4-year strategic and operational plan includes an executive summary and six unique sections:

1. A statement of the type of plan being submitted. The options are a unified plan or combined plan. Iowa is submitting a unified plan.
2. A strategic analysis providing data on our economy and workforce, information on existing programs and the overarching goals for the next four years.
3. An operational section that details how the partner programs will work together to make the goals in section II a reality. This section includes information on partnerships, technology, funding formulas and specific initiatives to better serve customers.
4. A statement of how planning was conducted with all partners.
5. A list of assurances that the state is making regarding the development and ongoing governance of this plan.
6. Detailed operational plans for the core programs. Core programs are funded by WIOA and they all report on the same performance measurements.

The development of Iowa's draft plan was a collaborative effort of Iowa Workforce Development, the Iowa Department of Education – Division of Vocational Rehabilitation Services, the Iowa Department of Education – Division of Community Colleges and Workforce Preparation and the Iowa Department for the Blind.

Division welcomes new CTE bureau chief



The division is pleased to welcome Dennis Harden as the new chief for the Bureau of Career and Technical Education (CTE).

Prior to joining the division, Harden provided state level leadership for CTE for more than 32 years at the Missouri Department of Elementary and Secondary Education. For the past two decades, he served as coordinator of the Career Education Unit, marshalling a staff of 35 to provide leadership for curriculum development, teacher professional development and career and technical student organizations. In addition, Harden oversaw Perkins state plan development and implementation, and disbursement of an annual budget of \$70 million in state and federal funding supporting CTE in 444 comprehensive high schools, 57 area career centers, 12 community college districts and the State Technical College of Missouri.

Prior to becoming coordinator, Harden served as Director of Industrial Education overseeing Skilled Technical Sciences, Health Sciences and Industrial Technology/Technology Education programs and as Supervisor of Industrial Training.

Harden has master's, education specialist and doctor of education degrees in Career and Technical Education from the University of Missouri, Columbia and a bachelor's degree in business administration from the University of Central Missouri.

Harden currently serves on the National Alliance for Partnerships in Equity (NAPE) Education Foundation Board of Directors and the NOCTI Board of Trustees.

As chief of the CTE bureau, Dennis will be responsible for the direction of secondary and postsecondary CTE, including Perkins V implementation and veterans' education.

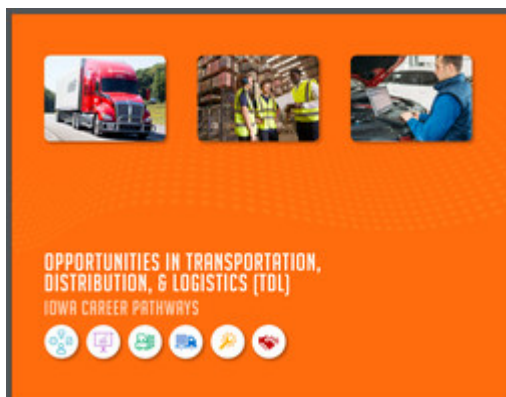
