Auditor of State Rob Sand today released a report on the Iowa Veterans Home for the year ended June 30, 2019.

The Iowa Commission of Veterans Affairs, which consists of nine members appointed by the Governor and confirmed by the Senate, oversees the conduct and operations of the Iowa Veterans Home.

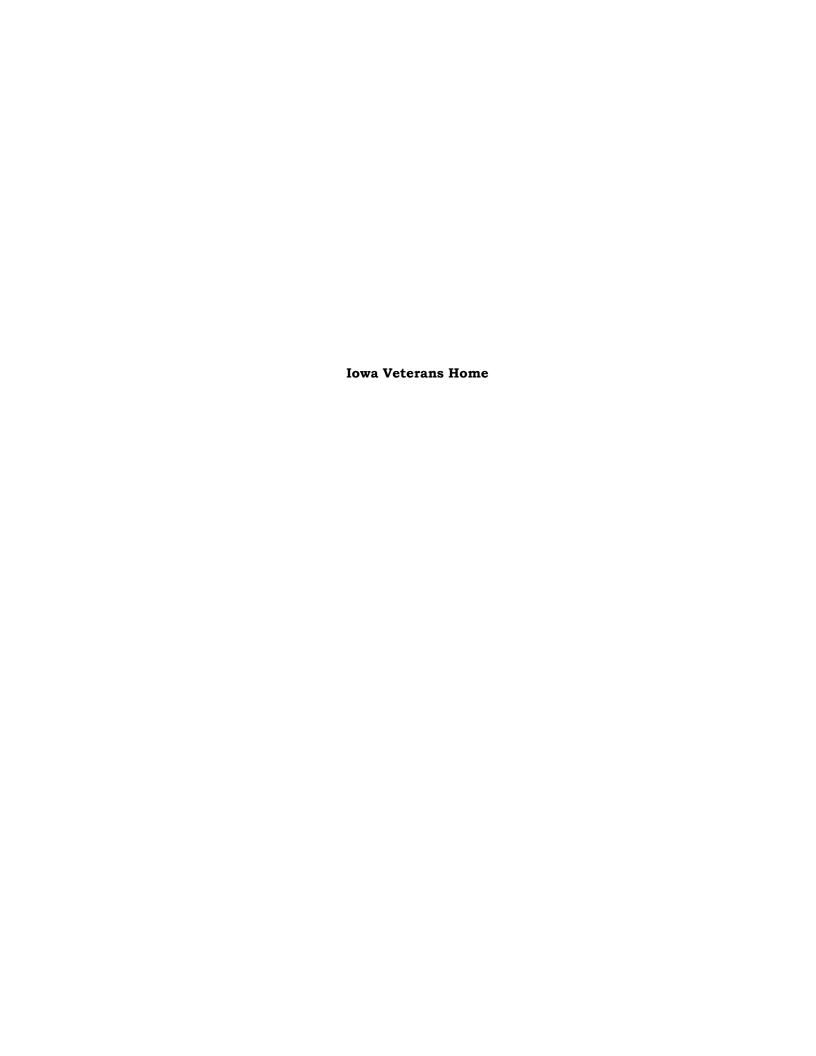
The Iowa Veterans Home, located in Marshalltown, Iowa, provides long-term health care for Iowa's aging, chronically ill, handicapped veterans and their dependent or surviving spouses. The annualized cost per resident was \$147,938 in fiscal year 2019, a 3% decrease from the prior year. The average number of residents increased from 495 in fiscal year 2018 to 498 in fiscal year 2019.

Sand reported no findings pertaining to the Iowa Veterans Home.

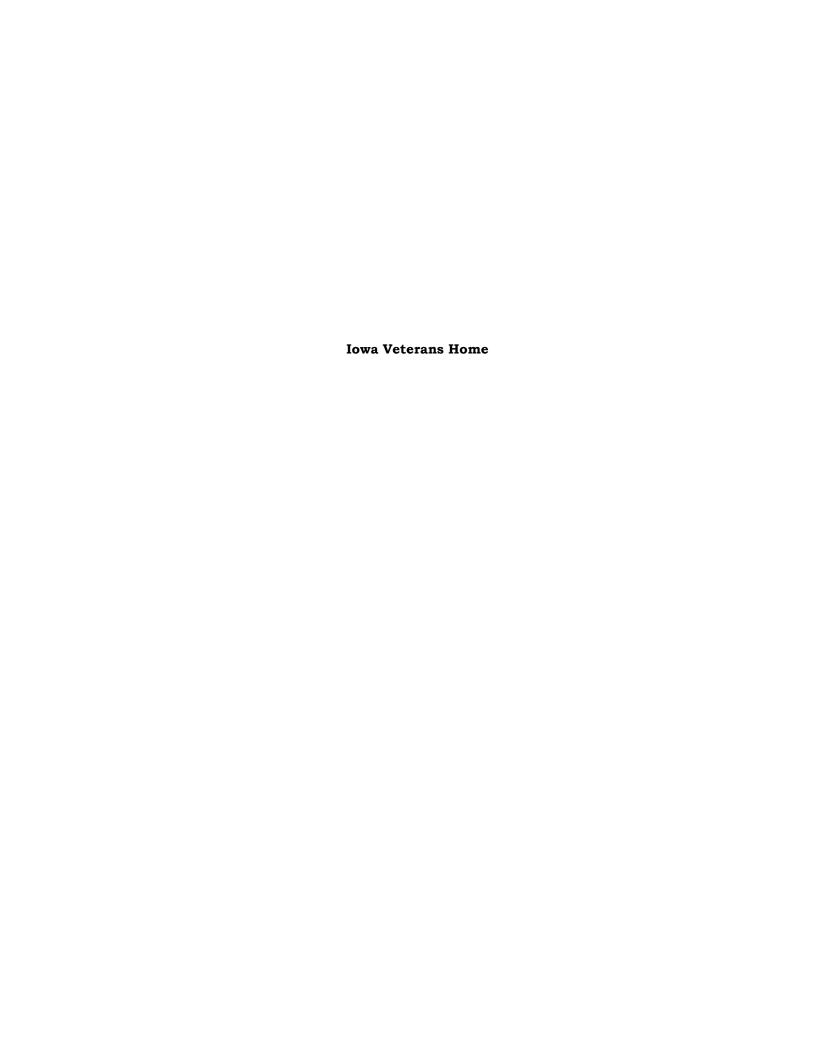
Dear Commission Members:
