Chapter 61 Rule Making: Aquatic Life Water Quality Criteria for Metals

The Environmental Protection Commission (EPC) has amended Chapter 61 to update aquatic life water quality criteria for selected metals. The final rule will become effective November 11, 2020. The adopted amendments to Chapter 61 were published in the lowa Administrative Bulletin on October 7, 2020 as 5226C.

The public comments received have been addressed in a public participation responsiveness summary, which may be viewed on the Iowa DNR's <u>Water Quality Standards webpage</u>.
