### Cmsn. Unveils Three-Year Strategic Plan

### What Iowa's Election Integrity Law Means for Voters



#### When do voters have to start showing ID at the polls?

During calendar year 2018, voters will be asked to show their ID before voting at the polls. Anyone who does not have the necessary ID will be asked to sign an oath verifying their identity and will be allowed to cast a regular ballot.

Beginning January 1, 2019, Iowa voters will be required to show a driver's license, non-driver's ID, passport, military ID, veterans ID, or voter ID card at the polls before they vote.

#### What about voters who don't have an ID?

Any registered voter who does not have an ID issued by the lowa Department of Transportation will be issued a voter ID card for free, automatically. Voter ID cards will need to be signed before going to the polls.

#### Is ID required for absentee ballots?

YES. Beginning January 1, 2018, voters requesting absentee ballots will be required to include their driver's license/non-driver's ID numbers on their request form. Voters receiving the voter ID card will be required to include their card's PIN number on the absentee ballot request form.

#### How will signature verification work?

This new law enables precinct election officials to challenge a voter if they believe the voter is not the person on the identification card; a signature that does not match the signature on the ID is one component of that review. Poll workers will be instructed to NOT reject a ballot based solely on signatures not matching and to take into account all of the information presented to them.

The Program of All-Inclusive Care for the Elderly (PACE) is a specialized managed care program that provides preventive care, primary care, social services, therapeutic recreation, acute and long-term care services. The goal of this program is to protect and improve the health, quality of life, as well as allow an individual to remain living at home. If you are already a member enrolled with PACE, please contact your PACE provider before making any changes to your plan. Your PACE provider will assist you with disenrolling with PACE and enrolling with the IA Health Link Managed Care program.

#### PACE ELIGIBILITY REQUIREMENTS

- Are 55 years of age or older
- · Reside in a county where PACE is provided
- Live in a community home (at time of initial PACE approval)
- · Have Medicaid, dual Medicaid/Medicare or Medicare eligibility
- · Meet the medical supports for nursing facility level of care

#### **Economic Impacts of Refugees in Iowa**

Panelists include Loren Bawn, Bureau of Refugee Services, Iowa Department of Human Services; Bram T. Elias and Hannah Shirey, University of Iowa College of Law; Mark Grey from the Department of Sociology, Anthropology & Criminology, UNI; and Mallory Petsche, of EMBARC (Ethnic Minorities of Burma Advocacy and Resource Center), Waterloo.
