The required SRF Front-End Documents have been updated and are now available for use. All SRF projects bidding in February 2021 and after will be required to use the updated SRF Front-End Documents.

Please note the addition of a new requirement in Attachment 10 of the SRF Required Front-End Specifications (DWSRF Exhibit 7A/ CWSRF Exhibit 12A), and in Attachment 5 of the SRF Required Front-End Specifications for Nonpoint Source and Sponsored Projects.

If you have downloaded a previous version of these documents, please replace them with the January 2021 updates for CWSRF and DWSRF infrastructure projects and the February 2021 updates for CWSRF nonpoint source projects (including Sponsored Projects).
