REPORT.

To the Honorable, the Legislature of the State of Iowa in General Assembly:

The State Historical Society of Iowa submits this, its fourteenth biennial report :

Since the last report a full catalogue of the library of the Society has been made, and a copy of the same is herewith appended.

A similar catalogue will be made of the miscellaneous collections of the Society in time for the next report.

In the fall of 1882 the Society was under the necessity of removing its collections, as the building hitherto occupied had changed to the hands of a gentleman who desired to use it for other purposes.

In a new building then in process of erection we were so fortunate as to secure a room admirably adapted to our purposes, and much more centrally located than our former room.

Our present hall is eighty by thirty-five feet, lighted from front and rear, and by a large sky-light in the center.

The building itself is of brick with an iron front. The rental is three hundred dollars a year. As all our cases were readily adapted to the new room, the expense of removal was comparatively slight.

As soon as we were fairly seated in our new quarters, steps were taken to extend our correspondence, to enlarge our collections, and to put new life into our organization.

To this end a gentleman, long connected with the Society, Mr. M. W. Davis, assumes the duties of secretary, and will devote much time to the furtherance of the interests of the Society.

And we hope for a more wide-spread interest in the work of the Society. Contributions are most respectfully solicited of whatever may be connected with the natural, social, or political history of the State.

We would be glad to receive portraits or photographs of men and

women who have identified themselves with the early history and the growth of the State.

Our collection of relics, already quite large, may be increased indefinitely as we now have ample room for their display.

We are prepared also to receive and arrange a mineralogical and geological cabinet, especially representing our own State, and would be glad to furnish cases for a complete representation of the *fauna* and the *flora* of Iowa.

In the furtherance of our purpose to infuse new life into our Society, we ask for a continuance of our present appropriation of fifteen hundred dollars annually.
