REPORT.

IOWA STATE BOARD OF DENTAL EXAMINERS, OFFICE OF SECRETARY, DES MOINES, IOWA, November, 1883.

To his Excellency, BUREN R. SHERMAN, Governor of Iowa:

Sir—In accordance with section 9 of an act entitled "An Act to insure the better education of practitioners of dentistry in the State of Iowa," approved March 8, 1882, I have the honor to submit the annual report of the Iowa State Board of Dental Examiners, comprising a brief account of their transactions from the date of organization as a Board, August 16, 1882, to November 15, 1883, with an abstract of the State Dental Register to date.

In pursuance of a call the members of the Board, having been duly qualified, convened at Cedar Rapids on August 16, 1882, all the members being present, they perfected an organization as a State Board of Dental Examiners, by electing J. Hardman, of Muscatine, President, and E. E. Hughes, of Newton, Secretary.

The work of the session was mainly the adoption of rules for the government of the Board and the discussion and preparation of forms of printed matter required in conducting the business of registration.

The subjoined forms together with register and record books, and list of questions to be used in examinations at next meeting, were ordered printed.

The following was adopted as the seal of the Board: "Iowa State Board of Dental Examiners, created July, 1882."

The legislature made no appropriation to assist in carrying out or enforcing the provisions of the dental law; nor was it asked for by the friends of the measure. 6

But without some means to meet the expense incident to the proper registration of the dentists in the State, it must readily be seen that this work could not be done.

For this reason the insertion of the following clause in Form 1: "Upon receipt of a fee of one dollar, certificate of registration will be returned." The response to this request was sufficient to fully cover the expense incurred.

On September 6th, was commenced the mailing of blank forms 1 and 2 to every dentist in the State whose name could be obtained. As applications for registration were received they were transferred to the register and certificates returned to all sending the fee requested.

December 23, 1882, a second notice was mailed to all who had thus far neglected to apply for registration.

At the expiration of time allowed for registration, January 3, 1883, the number registered in accordance with section 4 of the act was 364.

The first regular meeting of the Board was held at Iowa City on April 30, 1883. In addition to those having registered, the Board authorized the registration of three applications which failed to reach the Secretary prior to the expiration of time allowed for registration, thus making the total number registered 367.

At this meeting 18 candidates were examined, to 13 of whom licenses were issued. Five failed to pass the examination. To four of these a temporary permission was given to continue practice until the next meeting of the Board, when they are to be again examined. The other having failed was rejected.

Licenses have been issued on diplomas to eight practitioners.

The whole number of dentists in the State, either registered or licensed, as shown by the books of the Board, is three hundred and eighty-eight (388).

Leaving a balance of five dollars and fourteen cents to be paid from future receipts.

The work of registration has been accomplished with comparatively little opposition, and with few exceptions there has been a cheerful compliance with the law when once understood. It is conceded that a new law of any kind requires time and considerate amendments to have it approximate to a perfect law. Yet notwithstanding its limited provisions, and without expense to the State, the Board are encouraged in their labors by the visible and favorable reports of good already accomplished by the dental law. That its tendency is in the direction of the object set forth in its title, viz: "To insure the better education of practitioners of dentistry in the State of Iowa," attention is directed to the fact of there being at the present time a class numbering thirty-two in the Dental Department of the State University at Iowa City, a department in the second year of its existence. This record is unparalelled in the history of Univerity Departments in proportion to the number engaged in a profession in any State.

In addition, there are seven from this State in attendance at dental schools in other States.

The average number of dental students from this State for the five years last past has been but about two.

Attention is further directed to the fact that of those having applied for admission to practice, coming from outside this State, all but one were in possession of a diploma.

On the whole the Board are very well pleased with what has been accomplished thus far, and feel confident that a wise administration of the law must result in great good in the years to come.

All of which is most respectfully submitted.

OFFICE OF THE STATE BOARD OF DENTAL EXAMINERS OF THE STATE OF IOWA.

OFFICIAL NOTICE.

To those Dentists who were in practice March 8, 1882:

Every person engaged in the regular practice of dentistry in the State of Iowa on the 8th day of March, 1882, by filling in the enclosed blank and making affidavit to the same, and having it witnessed by two practicing physicians, is entitled to be registered in the books of the State Board of Dental Examiners; which registration must be accomplished before January 1, 1883, in order that he or she may continue practice and avoid the penalty for non-registration. Upon receipt of a fee of one dollar certificate of registration will be returned.

[Extract from Law.]

It shall be the duty of every person who is engaged in the practice of dentistry in the State, within six months from the taking effect of this act, to cause his or her name and residence, or place of business, to be registered with the said Board of Examiners, who shall keep a book for that purpose; and every person who shall so register with said Board as a practitioner of dentistry, may continue to practice the same as such without incurring any of the liabilities or penalties of this act.

Any person who shall violate any of the provisions of this act shall be liable to prosecution, before any court of competent jurisdiction, upon information, and, upon conviction, shall be fined not less than itwenty-five dollars nor more than fifty dollars for each and every offense.

To those Dentists not in practice March 8, 1882:

Any person commencing the practice of dentistry in the State of Iowa AFTER March 8, 1882, who does not hold a diploma from a reputable Dental College, must secure a license from the State Board of Dental Examiners; which license can only be obtained by examination before the Board; except that a temporary license to run till the next meeting of the Board can be obtained from any member of the Board, upon the applicant passing a satisfactory examination. Graduates of Dental Colleges can obtain license upon presentation of diploma and payment of the necessary fee.

APPENDIX.

A BILL FOR AN ACT TO INSURE THE BETTER EDUCATION OF PRACTITION-ERS OF DENTISTRY IN THE STATE OF IOWA.

Be it enacted by the General Assembly of the State of Iowa:

SECTION 1. That it shall be unlawful for any person who is not, at the time of the passage of this act, engaged in the practice of dentistry in the State, to commence such practice unless such person shall have received a license from the Board of Examiners, or some member thereof as hereinafter provided, or a diploma from the faculty of some reputable dental college, duly authorized by the laws of the State, or by some other of the United States, or by the laws of some foreign country in which college, or colleges, there was at the time of the issue of such diploma, annually delivered, a full course of lectures and instruction in dental surgery.

SEC. 2. A Board of Examiners is hereby created, whose duty it shall be to carry out the purpose and enforce the provisions of this act. The members of such Board shall be appointed by the Governor, and shall consist of five practicing dentists, who shall have been engaged in the continuous practice of dentistry in the State for five years or over, at the time of or prior to the passage of this act. The term for which the members of said Board shall hold their office shall be five years, except that the members of the Board first appointed under this act shall hold their office for one, two, three, four and five years, respectively, and until their successors shall be duly appointed. In case of vacancy occurring in said Board, such vacancy shall be filled by the Governor.

SEC. 3. Said Board shall choose one of its members President, and one the Secretary thereof; and it shall meet at least once in each year, and as much oftener and at such time and place as it may deem necessary. A majority of said Board shall at all times constitute a quorum, and the proceedings thereof shall at all reasonable times be open to public inspection.

SEC. 4. It shall be the duty of every person who is engaged in the practice of dentistry in the State, within six months from the date of the taking effect of this act, to cause his or her name and residence, or place of business, to be registered with the said Board of Examiners, who shall keep a book for that purpose; and every person who shall so register with said

Board as a practitioner of dentistry, may continue to practice the same without incurring any of the liabilities or penalties of this act.

Sec. 5. No person whose name is not registered on the books of said Board as a regular practitioner of dentistry, within the limits prescribed in the preceding section, shall be permitted to practice dentistry in this State until such person shall have been duly examined by said Board and regularly licensed in accordance with the provisions of this act.

SEC. 6. Any and all persons, who shall so desire, may appear before said Board at any of its regular meetings, and be examined with reference to their knowledge and skill in dental surgery, and if such person shall be found, after having been so examined, to possess the requisite qualifications, said Board shall issue a license to such person to practice dentistry in accordance with the provisions of this act. But said Board shall at all times issue a license to any regular graduate of any reputable dental college, without examination, upon the payment by such graduate to the said Board of a fee of one dollar. All licenses issued by said Board shall be signed by the members thereof and be attested by the President and Secretary, and such license shall be prima facie evidence of the right of the holder to practice dentistry in the State of Iowa.

SEO. 7. Any member of said Board shall issue a temporary license to any applicant upon the presentation by such applicant of the evidence of the necessary qualification to practice dentistry; and such temporary license shall remain in force until the next regular meeting of said Board, occurring after the date of such temporary license, and no longer.

SEC. 8. Any person who shall violate any of the provisions of this act shall be liable to prosecution, before any court of competent jurisdiction, upon information, and, upon conviction, shall be fined not less than twenty-five dollars nor more than fifty dollars for each and every offense.

SEC. 9. In order to provide the means for carrying out and maintaining the provisions of this act, the said Board of examiners may charge each person applying to or appearing before them for examination for license to practice dentistry, a fee of two dollars, and out of the funds coming into the possession of the Board from the fee so charged, the members of said board may receive as compensation, the sum of five dollars for each day actually engaged in the duties of their office. And no part of the salary or other expenses of the board shall be paid out of the State treasury. All moneys received in excess of said per diem allowance shall be held by the Secretary of said Board as a special fund for meeting the expenses of said Board, he giving such bond as the Board shall from time to time direct. The said Board shall make an annual report of its proceedings to the Governor, by the fifteenth of November of each year, together with an account of all moneys received and disbursed by them pursuant to this act.

SEC. 10. Any person who shall be licensed by said Board to practice dentistry, shall cause his or her license to be registered with the county clerk of any county or counties in which such person may desire to engage in the practice of dentistry; and the county clerks of the several counties in the

State shall charge for registering such license, a fee of twenty-five cents for each registration. Any failure, neglect or refusal on the part of any person holding such license to register the same with the county clerk as above directed, for a period of six months, shall work a forfeiture of the license; and no license, when once forfeited, shall be restored except upon the payment to the said Board of Examiners of the sum of twenty-five dollars, as a penalty for such neglect, failure or refusal.

Sec. 11. Nothing in this act shall be construed to prevent persons from extracting teeth.

The policy of this Board will be to obtain a willing compliance from every one affected by the law, but where stubborn determination without any regard to honor, justice, or law, manifests itself, it will then be the inflexible policy of the Board to meet such cases with all the force of legal chastisement, that duty and legal means furnish; and to this end it is confidently expected that all loyal members of the profession in Iowa will give the Board their hearty and vigilant co-operation. Cases of violation known to be such, should be reported at once to the Board. It may be well to remember that any one has the same power to file complaint before a justice of the peace, or other court of competent jurisdiction, as in any other breach of the law.

Candidates for license are required to apply in person, either to the full Board at its regular meeting, or to some one member of the Board at any time mutually agreed upon, and answer the full quota of questions used by the Board for said purpose. For a temporary license not less than fifty per cent, and for a permanent license not less than seventy-five per cent, correct answers, will be accepted as a satisfactory test.

The fee for each examination is two dollars. Examinations will be conducted in writing, embracing the following subjects: Anatomy, Physiology, Histology, Pathology, Surgery, Therapeutics. Materia Medica, Chemistry, Operative Dentistry, Prosthetic Dentistry, and Irregularities.

Those dentists who hold diplomas from reputable dental colleges can obtain license by proving their diplomas and paying a fee of one dollar.

Dental students or assistants, who are entrusted by their employers to do professional service in their absence, either in the office or outside, must procure a license from this Board.

The regular meeting of the Board will be held on the first Monday in May, at such place as the Iowa State Dental Society may meet, due notice of which may be found in the dental journals.

All registered or licensed dentists are requested to inform the Secretary of the Board of changes in their address, in order that the published lists shall be as nearly correct as possible.
