LIBRARIAN'S REPORT.

OFFICE OF THE STATE LIBRARIAN, DES MOINES, July 1, 1883.

To His Excellency, Buren R. Sherman, Governor of Iowa:

Sir-I have the honor to submit herewith the following report of this department of the public service for the period beginning October 1, 1881, and ending June 30, 1883.

At date of my last report the whole number of books in the library, exclusive of duplicates and pamphlets, was

In accordance with chapter 175, Acts of the Nineteenth General Assembly, the present biennial period has been reduced to twenty-one months, which accounts for the seeming decrease in the number of accessions to our library.

The unexpended balance of the appropriation for the term will be used to pay for books which are ordered, but which, by especial arrangement with dealers, will not be received until after our removal to the new building.

All of our sets of law reports, including the British Colonial, have been completed, with the exception of the East Indian, which as above shown have been ordered. There is also missing from our set of Vermont reports, volume 7, of which I make especial mention here in the hope that it may meet the eye of some librarian or other person who may possibly be able to supply the same. I have made diligent effort to procure it from the authorities of that State, from

their publishers, and from the various publishers and dealers of other States, but have not yet succeeded.

While much attention has been given to the law department it will be noticed by the appended catalog that the general library has not been neglected.

The "Iowa Department," spoken of in my last report, has received a number of valuable accessions with the promise of more to follow; the use of a number of valuable historical manuscripts has been promised the library, whenever the history of the State shall be written.

For the history of the present time we shall have access to the newspapers of the State, a large number of which has been kindly donated by their editors or publishers. Want of room and time has prevented a more general ingathering of our home literature, though a generous response has been made to the call for the same.

A number of interesting and valuable political pamphlets have been donated to the library by Mr. C. D. Collet, of the "Diplomatic Review Company," London, England.

A catalog of books which should be in the various divisions of the general library, has been submitted to the trustees and approved and a special appropriation for their purchase should be made by the General Assembly.

The library has grown to such vast proportions, and is in such constant and popular use, that there should be allowed a special attendant, whose duty it shall be to take the books from the shelves when desired for use by readers, and replace the same when used, and thus keep the books always in order; to see that no book is missing from a set; to show visitors—other than those whose object is to consult the books—through the library, and, when not otherwise engaged, to assist in such clerical duties as may at times be necessary. It seems to me that after the removal to the New Capitol, such extra assistance will be imperatively necessary; the expense thereof will be quite inconsiderable, and I respectfully suggest that an appropriation for such service be made by the General Assembly.
