Why Attend? Many water recycling success stories are in larger cities. These outreach and listening webcasts will introduce water recycling opportunities that make sense for smaller communities. Equally important, we want to learn from you about your communities' interests in water recycling and your needs for support to enable you to pursue recycling projects. We will follow up these webcasts with online training tailored for small and disadvantaged communities and set up pilot projects to assist individual communities with recycling project development. The State Revolving Fund Asks... Did You Know?

Did you know...changing a SRF project scope may require additional environmental, design and permitting, and/or administrative review? Significant changes in scope may cause delays if additional work is required by the DNR project manager or SRF environmental review specialist.

The scope of the project must be outlined on the SRF Intended Use Plan (IUP) application and in the facility plan/preliminary engineering report. Changes to the scope are allowed <u>prior to</u> loan closing but will require a revised IUP application. Once a loan is signed, only minor changes to the scope are allowed and *only if the changes <u>do not require additional technical or environmental review.</u> Scope changes that occur after a loan has closed will be considered a separate project and will require a new IUP application.*
