LETTER OF TRANSMITTAL

EXECUTIVE OFFICE, January 11, 1909.

To the Senate and House of Representatives:

In compliance with Section 16, Article IV., of the Constitution, I herewith transmit to you a report of each case of pardon, reprieve, commutation, and suspension granted, and the reasons for the same, also the names of all persons in whose favor remissions of fines and forfeiture have been granted, and the amounts, for the period ending December 31, 1908.

APPLICATIONS FOR PARDONS SUBMIT-TED TO THE GENERAL ASSEMBLY,

Under Section 5626, Chapter 49, of the Code

The following named prisoners convicted of murder in the first degree and sentenced to imprisonment in the penitentiary for the term of their natural lives have made application for pardon. The statute provides that for this crime no pardon shall be granted by the Governor until he shall have presented the matter to the General Assembly for its advice. It likewise requires publication of the application for pardon, containing the grounds upon which it was asked, which notices have been published as required by statute. The original papers with accompanying applications are on file in the Governor's office for the inspection of the General Assembly:

In the case of Thomas C. Robinson the notice was sent to the "Cresco Republican" for publication and after a delay of two weeks the Governor was advised that the "Cresco Republican" had suspended publication several months before. Notice was at once published in another paper and has been published for four consecutive weeks as required but the fourth publication was a little less than twenty days prior to the convening of this legislature on account of the suspension of the paper. It is urged that this circumstance shall not be permitted to militate against his application.

PARDONS ADVISED BY THE THIRTY-SECOND GENERAL ASSEMBLY

JASPER MASON, Dallas County. Committed to the penitentiary April 16, 1893, for the term of his natural life, for the crime of murder in the first degree. Notice was published and this case submitted to the Thirty-second General Assembly, as the law requires and by resolution of that body the defendant was conditionally pardoned on the 19th day of April, 1907.

PARDONS GRANTED UPON THE RECOMMENDATION OF THE BOARD OF PAROLE.

JOSEPH MAKINSIN, Guthrie County. Committed to the penitentiary on the 24th day of December, 1905, to serve a term of two and one-half years for the offense of manslaughter. A conditional pardon was recommended by the Board of Parole and the same was granted on the 14th day of October, 1907.

LOUIS WESTERMAN, Polk County. Convicted at the June term, 1907, of the offense of perjury and sentenced to serve a term of four years in the penitentiary. This application was referred to the Board of Parole for investigation and recommendation and after ascertaining the facts in the case the board recommended that he be pardoned before commitment. Pardon granted the 4th day of May, 1908.

R. S. MEYERS, Scott County. Committed to the penitentiary on the 13th day of December, 1904, to serve a term of seven years for the offense of larceny from the person. This application was referred to the Board of Parole for investigation and recommendation, which recommendation was that a full pardon be granted said R. S. Meyers. Pardon granted November 23, 1908.

JOHN G. STEEL, Monroe County. Committed to the penitentiary on the 21st day of September, 1907 for life, for the crime of murder in the first degree. This application was referred to the Board of Parole for investigation and recommendation. The Board of Parole in recommending that a pardon be granted in this case stated that inasmuch as the record of the prisoner in the penitentiary had been exceptionally good; that he had served more than eleven years, and is now seventy years of age; that the petitions for his pardon were numerous, coming

from Mahaska, Wapello, and Monroe counties; that there were no remonstrances against his pardon; that they believe him to be a man who will be perfectly safe if allowed his liberty and that under all the circumstances his punishment had been sufficient from the standpoint of retribution or the protection of the public, they therefore, recommended a full pardon, which was granted on the 21st day of November, 1908.

OTTO OTTEN, Pocahontas County. Committed to the penitentiary on the 29th day of January, 1887, for life, for the crime of murder in the first degree and granted a conditional pardon on the 23d day of April, 1902, upon the recommendation of the Twenty-ninth General Assembly, and additional showing having been filed with the Governor recommending a full pardon the same was granted on the 20th day of July, 1907.

WILLIAM YOUNG. Woodbury County. Committed to the penitentiary on the 20th day of February. 1897, for life for the crime of murder in the first degree and granted a conditional pardon on the 22d day of April, 1992, upon the recommendation of the Twenty-ninth General Assembly. Additional showing having been filed with the Governor recommending a full pardon for the said William Young, the same was granted on the 16th day of December. 1908.

SUSPENSIONS.

H. L. BRIGGS, Scott County. Convicted at the April term, 1904, of the offense of larceny from the person, and sentenced to serve a term of six and two-thirds years in the penitentiary. Clemency was recommended by a number of business man of Des Moines, where the applicant formerly lived, on account of his previous good character and on account of the condition of his wife. Sentence suspended January 10, 1907.

JOHN WEEKS, Cerro Gordo County. Convicted at the January term, 1905, of the offense of uttering a forged instrument, and sentenced to serve a term of four years in the penitentiary. Clemency was recommended by a number of business men of Des Moines, where the and by a large number of influential citizens and business men of Mason City who were familiar with all of the cicumstances of the commission of the crime. Sentence suspended January 12, 1907.

J. W. HILLYARD, Wright County. Convicted at the February term, 1906, of the offense of uttering a forged instrument, and sentenced to serve a term of five years in the penitentiary. Clemency was recommended by Hon. S. M. Weaver, Judge of the Supreme Court, Hon. B.

P. Birdsall, congressman from the third congressional district, and by the trial judge and the county attorney, also by Hon. C. F. Peterson. Sentence suspended, January 12, 1907.

SIMON HUDSON, Ringgold County. Convicted at the April term, 1902, and sentenced to serve a term of ten years for the offense of burgiary. Clemency was recommended by the county attorney, county auditor, county treasurer, and clerk of the district court, also by members of the board of supervisors and by a large number of the citizens of Clinton township, Ringgold county, who were familiar with all the circumstances connected with the commission of the crime. Sentence suspended January 17, 1907.

PETER FINNEGAN, Cerro Gordo County. Convicted at the September term, 1906, of the offense of embezzlement, and sentenced to serve a a term of six months in the penitentiary. Clemency was recommended by four of the jurors and by a large number of the citizens of Mason City who were familiar with the circumstances of the crime. Sentence suspended January 1, 1907.

J. M. ROBERTSON, Mahaska County. Convicted at the October term, 1905, of the offense of adultery and sentenced to serve a term of three years in the penitentiary. Sentence suspended January 30, 1907, after personal hearing had been granted by the Governor.

WILLIAM MANCHESTER, Woodbury County. Convicted at the September term, 1905, of the offense of larceny, and sentenced to serve a term of one year in the penitentiary. Clemency was recommended by the trial judge, by the sheriff, city attorney, city treasurer, practically all the county officers, by Hon. W. G. Sears, Mayor of Sioux City, and a number of the most influential citizens of Sioux City, who were familiar with all of the circumstances connected with the commission of the crime. Sentence suspended February 14, 1907.

HAL BUTLER, Crawford County. Convicted at the March term, dyl, of the offense of robbery, and sentenced to serve a term of ten years in the penitentiary. Clemency was recommended by the trial judge, by P. E. C. Lally, who was appointed by the county to prosecute, by Hon. J. B. Conner and by a large number of the citizens of Crawford county. Sentence suspended February 16, 1907.

BURT BUTLER, Crawford County. Convicted at the March term, 1904, of the offense of robbery, and sentenced to serve a term of ten years in the penitentiary. Clemency was recommended by the trial judge, by P. E. C. Lally, who was appointed by the county to prosecute, by Hon. J. B. Conner and by a large number of the citizens of Crawford county. Sentence suspended February 16, 1907.

LIZZIE AUSTIN, Marshall County. Convicted at the January term, 1904, for the offense of burglary, and sentenced to serve a term of ten years in the penitentiary. Clemency was recommended by six of the jurors, by Rt. Rev. M. C. Lenihan, Bishop of Great Falls, Montana, formerly of Marshalltown, by the mayor of Marshalltown, by the county

auditor, county recorder, county treasurer, clerk of the district court, and by a large number of the citizens of Marshall county. Sentence suspended February 22, 1907.

PURL O. WRIGHT, Green County. Convicted at the January term, 1906, of the offense of assault to commit rape, and sentenced to serve a term of three years in the penitentiary. Clemency was recommended by Hon. Mahlon Head and by a very large number of influential citizens of Greene County, who were familiar with all the circumstances of the commission of the crime. Sentence suspended March 12, 1907.

LOYD HAWK, Polk County. Convicted at the September term, 1906, of the offense of forgery, and sentenced to serve a term of one year in the penitentiary. Clemency was recommended by J. W. Jones, chief of police, Des Moines, and by a large number of the citizens of Rockford, Illinois, in order that Loyd Hawk might be released in time to reach home before the death of his brother who was dying of quick consumption. Sentence suspended March 4, 1907.

J. F. SPEAR, Lucas County. Convicted at the January term, 1906, of the offense of uttering a forged instrument and sentenced to serve a term of two and one-half years in the penitentiary. Clemency was recommended by Hon. Warren Garst, Hon. F. M. Hopkins, State Senator, and by Hon. W. T. McConnell of South Dakota, formerly of Iowa. Sentence suspended March 25, 1907.

W.T. McDONALD, Scott County. Convicted at the April term, 1905, of the offense of perjury, and sentenced to serve a term of two and one-half years in the penitentiary. Clemency was recommended by Hon. F. L. Coffin, also by E. P. and H. A. Schanz, of the Reliable Foundry & Machine Co., of Ft. Madison, who offered Mr. McDonald a position with their company at \$100.00 per month, immediately upon his release. Sentence suspended March 30, 1907.

CHARLES W. KING, Polk County. Convicted at the September term, 1905, for the offense of attempt to break and enter, and sentenced to serve a term of three years in the penitentiary. Clemency was recommended by Rev. A. C. Douglas, A. H. Miles Dr. Geo. Royal, Zell G. Roe, Charles W. Schram, Charles Murrow, B. F. Coffin, C. A. Dudley, A. J. Mathis, by A. H. McVey, trial judge, and by a number of other citizens of Polk County. Sentence suspended, April 19, 1907.

VOCLAV REJAC, Linn County. Convicted at the September term, 1903, of the offense of murder in the second degree, and sentenced to serve a term of twenty-five years in the penitentiary. Clemency was recommended by Hon. B. H. Miller, judge who presided at the trial, Hon. Jos. Mekota, county attorney, who prosecuted, by Hon. C. C. Watkins, ex-county attorney, Joseph Kozlovsky, city marshal at the time the crime was committed, by John W. Gelger, recorder "El-Kahir Temple," Joseph J. Hajek, editor "Vestnik Iowsky," L. J. Paldy, water commissioner, J. H. Smith, President Farmers' Insurance Co., W. F. Severa, manufacturing chemist, John Bosmek, Secretary Bohemian Building and Loan Association. Sentence suspended April 11, 1907.

GEORGE V. BURRIER, Clinton County. Convicted at the April term, 1903, of the offense of burglary, and sentenced to serve a term of fifteen years in the penitentiary. This suspension was granted for the purpose of carrying out an understanding which the officers of the court had with the defendant, to the effect that the sentence imposed should be reduced on account of defendant's giving testimony which aided in the conviction of several other criminals. Sentence suspended, April 30, 1907.

MATT MAHER, Johnson County. Convicted at the November term, 1905, of the offense of manslaughter, and sentenced to the penitentiary to serve a term of two years. Clemency was recommended by the trial judge, by the county attorney, the assistant county attorney, by the sheriff, Hon. G. W. Koontz, representative, and by all the other county officers of Johnson county. Sentence suspended April 30, 1907.

JOHN EZECHECK, Johnson County. Convicted at the November term, 1905, of the offense of manslaughter, and sentenced to the penitentiary to serve a term of two years. Clemency was recommended by the trial judge, by the county attorney, the assistant county attorney, by the sheriff, Hon. G. W. Koontz, representative, and by all the other county officers of Johnson county. Sentence suspended April 30, 1907.

SAMPLE DELLITT, Scott County. Convicted at the April term, 1907, of the offense of forgery, and sentenced to serve a term of one day in the penitentiary and to pay a fine of \$25.00. Suspension before commitment to the penitentiary was recommended by the court upon payment of the fine and costs. Same was also recommended by the county attorney. Sentence suspended May 2, 1907.

WILLIAM BELL, Polk County. Convicted at the March term, 1907, of the offense of breaking and entering, and sentenced to serve a term of eight months in the penitentiary. Clemency was recommended by the judge, and county attorney, the latter stating that when he accepted the plea of guilty at the time of the trial, he had in mind the imposing of the jail sentence only, and recommended the same to the court, but that it was in some way misunderstood or overlooked. The applicant was confined in the county jail ninety days awaiting trial and upon the above showing the sentence was suspended before commitment. Sentence was suspended May 2, 1907.

JOE WOOD, Ringgold County. Convicted at the November term, 1905, of the offense of larceny and sentenced to serve a term of three years in the pententiary. Clemency was recommended by H. Middlesworth, the owner of the pocket book, which was said to have been stolen, and by all of the county officers of Ringgold county. Sentence suspended May 4, 1907.

H. A. CUNNINGHAM, Scott County. Convicted at the April term, 1903, of the offense of robbery. Clemency recommended by Fred W. Nell, county attorney, at the time the crime was committed, Albert Hamann, and C. H. Murphy, assistant county attorney, E. G. McArthur, sheriff, by Geo. C. Scott, of Davenport, the trial judge having filed a statement that he would neither oppose nor recommend clemency. Sentence suspended May 11, 1907.

GEORGE M. BOOTON, Fremont County. Convicted at the January term, 1905, of the offense of larceny, and sentenced to serve a term of five years in the penitentiary. Clemency was recommended by the trial judge and the county attorney, and by A. L. Chantry, ex-county attorney. Sentence suspended May 11, 1907.

ORRIE EVANS, Benton County. Convicted at the September term, 1955, of the offense of conspiracy, and sentenced to serve a term of three years in the penitentiary. Clemency was recommended by the trial judge and the county attorney, by Hon. W. P. Whipple, state senator, and by a large number of citizens of Benton county, who were familiar with this case. Sentence suspended May 28, 1907.

CLEYE EVANS, Benton County. Convicted at the September term, 1905, of the offense of conspiracy, and sentenced to serve a term of three years in the penitentiary. Clemency was recommended by the trial judge and the county attorney, by Hon. W. P. Whipple, state senator and by a large number of citizens of Benton county, who were familiar with this case. Sentence suspended May 28, 1907.

LEWIS ROTH, Mills County. Convicted at the September term, 1395, of the offense of robbery and sentenced to serve a term of four years in the penitentiary. Clemency was recommended by George R. Logan, city marshal, Red Oak, William Thomas, sheriff, W. S. Ellis, county treasurer, Peter Ostrom, county auditor, E. W. Fenton, J. S. Cook, residents of Red Oak, Captain John Hayes, Secretary of the Iowa Shilo Commission. Sentence suspended May 28, 1907.

J. W. SALE, Page County. Convicted at the February term, 1902, of the offense of murder in the second degree and sentenced to serve a term of ten years in the penitentiary. Clemency was recommended by Hon. W. R. Green, judge who pronounced sentence, by W. P. Ferguson, and Charles S. Keenan, attorneys of Shenandoah, Iowa, by John M. Dawson and W. C. Pierce, Merryville, Missouri, and by a large number of the citizens of Page county, who were familiar with all the circumstances connected with the commission of this crime. Sentence suspended May 28, 1907.

WESLEY SMITH, Keokuk County. Convicted at the September term, 1906, of the offense of larceny and sentenced to serve a term of two years in the pentientiary. Clemency was recommended by S. G. Wilson, W. S. Utterback, shippers from whom the hogs were stolen, by James Hamilton of Delta, H. Hawkins, justice of the peace, and by practically all the business men and residents of Delta and vicinity. Sentence suspended May 28, 1907.

CHARLES W. BRYAN, Jasper County. Convicted at the December term, 1905, of the offense of forgery and sentenced to serve a term of five years in the penitentiary. Clemency was recommended by Hon. D. H. Gill, mayor of Prairie City, T. J. Cowman, justice of the peace, J. H. Furnay, constable, John T. Buckingham, city marshal, E. G. Robinson, editor "Prairie City News," J. Mummert, postmaster, and by over one hundred business men and citizens who were familiar with all the circumstances connected with the commission of this crime. Sentence suspended June 1, 1907.

JULIUS MENTZER, Humboldt County. Convicted at the October term, 1901, of the offense of murder in the second degree, and sentenced to serve a term of twenty-five years in the penitentiary. Clemency was recommended by W. B. Quarton, Judge who prosecuted, by William J. Taft, county attorney, by Hon. D. W. Ray, mayor of Humboldt, J. W. Foster, postmaster, by all of the county officers of Humboldt county, and by Hon. M. D. Reed, ex-representative. Sentence suspended June 24, 1907.

F. CROUCH, Palo Alto County. Convicted at the March term, 1905, of the offense of rape and sentenced to serve a term of seven years in the penitentiary. Clemency was recommended by Hon. Frank D. Jackson, Hon. W. B. Quarton, trial judge, F. C. Davidson, county attorney who prosecuted, Hon. Geo. H. Carr, Des Moines, by practically all the county officers of Palo Alto county and by a large number of influential citizens and business men of Emmetsburg. Sentence suspended June 24, 1907.

WILLIAM PURCELL, Muscatine County. Convicted at the January term, 1905, of the offense of assault to commit murder and sentenced to serve a term of twelve years in the penitentiary. Clemency was recommended by the trial judge, by Hon. Arthur Huffman, and W. L. Roach, S. M. Hughes, J. L. Giesler, Frank W. Reed, J. G. Van Lent, and a number of other influential business men of Muscatine. Also by Hon. R. S. McNutt, mayor of Muscatine. Sentence suspended June 24, 1907.

ED D. BROWN, Montgomery County. Convicted at the May term, 1905, of the offense of larcency, and sentenced to serve a term of four years in the penitentiary. Clemency was recommended by F. P. Greenlee, county attorney, who prosecuted and N. W. Macey who imposed the sentence, stating that while he was not prepared to recommend the same he was confident that Mr. Greenlee would not make any recommendations that were not worthy of consideration and he would not oppose clemency. This was also recommended by a large number of Mr. Brown's neighbors and friends in Montgomery county. Sentence suspended June 24, 1907.

M. O'CONNELL, Polk County. Convicted at the May term, 1907, of the offense of uttering a forged instrument and sentenced to serve a term of fourteen months in the penitentiary. Suspension before commitment was recommended by the trial judge and the county attorney. Also by a number of business men of Des Moines, who were familiar with all the circumstances connected with the commission of this crime. Sentence suspended June 27, 1907.

WILLIAM WARREN, Cass County. Convicted at the April term, 1906, of the offense of larceny and sentenced to serve a term of four years in the penitentiary. Clemency was recommended by Hon. C. A. Meredith, representative from Cass county, by Hon. James E. Bruce, state senator and by a large number of the leading citizens of Atlantic. Sentence suspended June 24. 1907.

H. M. VORHIES, Polk County. Convicted at the May term, 1904, of the offense of uttering a forged instrument and sentenced to serve a term of five years in the penitentiary. Clemency was recommended by W. L. Barrett, superintendent of the public schools, Poplar Bluffs, Mo., by J. H. Mackey, judge of the common pleas court, Cambridge, Ohio, by a number of business men of Byesville, Ohio, and Kansas City, Missouri, where the applicant formerly lived, and by H. M. Whinnery, cashier Century Savings Bank, Des Moines, Iowa, being one of the banks that was defrauded by the forgery. Sentence suspended July 16, 1907.

JOHN C. HARTER, Henry County. Convicted at the April term, 1906, of the offense of perjury and sentenced to serve a term of two years in the penitentiary. Clemency was recommended by the trial judge, after he should serve one year of his sentence, by Mr. William Hoaglin, and by a large number of businessmen and citizens of Henry county. Sentence suspended August 7, 1907.

EDWARD C. SPARKS, Decatur County. Convicted at the January term, 1907, of the offense of forgery and sentenced to serve a term of one year in the penitentiary. Clemency was recommended by C. W. Baker, county attorney, the trial judge, H. W. Evans, stating that while he was not prepared to recommend he would certainly offer no objection to a suspension of sentence. Sentence suspended August 29, 1907.

FRED LASSELL, Polk County. Convicted at the October term, 1903, of the offense of breaking and entering and sentenced to serve a term of six years in the penitentiary. Clemency was recommended by Mr. Leonard Brown in a personal interview. As a further reason for this suspension the brother of Fred Lassell represented to the Governor that their property interests in this city required the presence of his brother at an early date and on account of the shortness of the time to be served suspension was granted September 13, 1907.

DONALD W. BAIN, Polk County: Convicted at the January term, 1906, of the offense of robbery and sentenced to serve a term of fifteen years in the penitentiary. Clemency was recommended by Mr. Fred P. Carr, Mr. Charles Roe, of Des Moines, by E. M. Gray, President of the State Board of Examiners for Mine Inspectors, by Hon. J. P. Dolliver, United States Senator, by Hon. Thos. D. Healy, and S. T. Meservey, Fort Dodge, by Hon. Jesse A. Miller, judge, and by a large number of business men and citizens of Des Moines and Boone, Iowa. Sentence suspended September 24, 1907.

HENRY HAMILTON, Scott County. Convicted on the 19th day of October, 1904, of the offense of uttering a forged instrument and sentenced to serve a term of six years in the penitentiary. This suspension was issued upon the recommendation of the Board of Parole in order that Mr. Hamilton might be allowed to go to Kenosha, Wisconsin, to be under the direct supervision of Lynn A. Fox, General Secretary of the Y. M. C. A. Sentence suspended October 14, 1907.

MILLARD BUCK, Jasper County. Convicted at the January term, 1905, of the offense of murder in the second degree, and sentenced to the penitentiary for life. This suspension was granted upon a very strong showing made in his behalf and for the further reason that there is a strong belief that he was insane at the time the crime was committed, it having been necessary to confine him in the insane ward at Anamosa during the greater part of the time he was incarcerated there. After a very careful examination by our foremost alienist it was decided that he should be released under suspension of sentence and placed in the care of his brother, Frank E. This application was also supported by a petition very numerously signed by the former friends and neighbors of the applicant. R. S. MEYERS, Scott County. Committed to the penitentiary on the 13th day of December, 1904, to serve a term of seven years for the offense of larceny. This suspension was granted upon the written recommendation of the Board of Control of State Institutions for the purpose of permitting the said Board of Control to transfer the said R. S. Clemency was recommended by the trial judge, the county attorney, by W. H. Weaver, Sheldon, Hon. W. C. Kimmel, State Senator, and by a large number of business men and citizens of Sheldon and vicinity. Sentence suspended November 23, 1908, to take effect December 23, 1908.

JAMES LANE, Hardin County. Convicted at the January term, 1902, of the offense of murder in the second degree, and sentenced to serve a term of twenty-five years in the penitentiary. Clemency was recommended by Hon. Mark Furry, M. A. Whitney, John Combelick, John A. Tallon, W. M. Cousins, postmaster, Benjamin J. Birdsall and Son, bankers, John Laird, O. M. Harp, John Tomlinson, justice of the peace, John Hoskin, president of the school board of Alden, Iowa. Sentence suspended November 23, 1908, upon condition that he reside with his son William Lane in the State of Minnesota.

Clemency was recommended by the father and mother of the girl upon whom the offense was said to have been committed, F. S. Shanklin, Charles S. Clemency was recommended by the county attorney, county auditor, deputy auditor, county treasurer, deputy treasurer, clerk of the District Court, deputy clerk, by the sheriff, deputy sheriff, members of the board of supervisors, and by a large number of influential business men of Ottumwa. Also by James F. Weber, attorney, Ottumwa, who represented the Ministerial Association in resisting this application at the times it was first made but he now requests that the same be granted for the reason that he believes that Mr. Davis has forever quit the business of keeping a gambling house. Sentence suspended November 23, 1908.

TOM SUMNER, Wapello County. Convicted at the February term, 1908, of the offense of keeping a gambling house and sentenced to serve a term of sixty days in the county jail. Clemency was recommended by the county attorney, assistant county attorney, county auditor, deputy auditor, county treasurer, deputy treasurer, clerk of the District Court, deputy clerk, by the sheriff, deputy sheriff, board of supervisors, by foreman of the grand jury and a number of prominent citizens of Ottumwa, Iowa. Sentence suspended November 23, 1908.

W. B. FLOYD, Wapello County. Convicted at the February term, 1908, of the offense of keeping a gambling house and sentenced to serve a term of sixty days in the county jail. Clemency was recommended by the county attorney, county auditor, deputy auditor, county treasurer, deputy treasurer, clerk of the District Court, deputy clerk, by the Mayor of Ottumwa, sheriff and by a number of the responsible business men of Ottumwa. Sentence suspended November 23, 1908.

F. C. NEVINS, Page County. Convicted at the October term, 1908, of the offense of cheating by false pretenses and sentenced to serve a term of one year in the county jail. Clemency was reommended by Hon. O. D. Wheeler, Yiudge who pronuonced sentence, G. I. Miller, county attorney, S. J. McCord, sheriff, C. W. Stuart, Wm. F. Stipe, A. B. Clarke, and a large number of residents of Clarinda, Iowa. Sentence suspended December 22, 1908.

SUSPENSIONS FROM INDUSTRIAL SCHOOL

CARL BOWDER, Cerro Gordo County. Convicted at the September term, 1906, of the offense of larceny from a dwelling house in the day time and sentenced to the Industrial School at Eldora. Clemency was recommended by Hon. H. C. Baldwin, mayor, Charles City, Wm. Braend, marshal, F. M. Graham, clerk of the District Court, C. A. Kent, superintendent of the public schools, Hon. Clifford P. Smith, judge, J. H. McConlogue, and by a number of business men who were familiar with all the circumstances of this case. Sentence suspended September 26, 1907.

RESTORATION

Pardons and restorations to citizenship were granted in the following cases to persons whose sentences had previously been suspended during good behavior. In each case before an order restoring the applicant to citizenship was issued a showing was filed signed by five or six citizens who knew the applicant personally, and who gave it as their opinion that he would not again violate the law.

COMMUTATIONS

WILL H. COLTON, Louisa County. Committed on the second day of December, 1904, for the offense of larceny by embezzlement, to serve a term of two and one-half years. A statement was filed in this case to the effect that at the time of the trial of Mr. Colton, on this charge, the county attorney agreed with Mr. Colton that if he would plead guilty on this charge there would be no prosecution on other charges. He was afterwards indicted for perjury and was to be brought to trial at the January term, 1907. This commutation was asked in order that he might have a fair chance to prepare for his trial and also in view of the agreement with the county attorney above referred to. Sentence commuted to two years, one month, and four days, January 9, 1907.

LOUIS BUSSE, Bremer County. Convicted at the March term, 1902, of the crime of murder in the first degree and sentenced to be hanged on the 20th day of April, 1906. On account of an appeal of this case pending in the Supreme Court of the State of Iowa the Governor on the 19th day of April, 1906, designated Friday, August 10, 1906, as the day upon which Busse should be executed and on July 14, 1906, the appeal being still pending, the date for execution was again changed to Friday, December 14, 1906. Upon a request for a hearing in the application for a commutation of sentence the date for execution was again changed to Friday, January 11, 1907. Upon the showing made in the hearing of this application the Governor commuted the sentence to life imprisonment, making the following statement in regard to

"The only fact which seems to me worthy of serious consideration relating to this application is the division of the Supreme Court upon the original appeal. Three members of the court held that the jury had not been properly instructed and that there should be a new trial. Three were of the opinion that the trial was a fair one and that the judgment ought to stand. By operation of law, therefore, the judgment was affirmed.

It is urged that one whose prayer for a new trial was sustained by three of the six judges who compose the appellate tribunal ought not to suffer the extreme penalty of the law.

Five of the six judges have recommended the commutation of the sentence to imprisonment for life, upon the ground that it would be contrary to public policy to execute a man who, according to the opinion of one-half the court, had not been lawfully convicted, and should have been granted another trial. The remaining judge says that the fact that the court was evenly divided should be carefully and gravely considered in determining the application for commutation.

It becomes my duty to decide whether the circumstances I have just stated fairly require me to change the sentence of death into a sentence of imprisonment for life. I want it to be distinctly understood that I find no merit in the application unless it be in the circumstances above recited. I have made myself familiar with the testimony, and it seems to me that a more cruel, brutal and atrocious crime was never committed than the one of which Louis Busse is guilty. My decision must be approved or condemned upon the one proposition. A fair trial is one of the rights guaranteed to every person accused of a crime, whether he be high or low, rich or poor, and without regard to the character of the crime charged against him. In the case before me, I cannot doubt that the second trial would have resulted in a conviction of murder in the first degree; but I cannot assert that the penalty affixed would have been death.

In view, therefore, of the fact that one-half of the members of the Supreme Court held that Louis Busse did not receive a fair trial, coupled with the recommendations that are now before me, I have reached the conclusion that it is my duty to commute the sentence of death into a sentence of imprisonment for life." Sentence commuted January 4, 1907.

HARRY WILLIAMS, Wapello County. Committed on the 19th day of April, 1905, to serve a term of two years in the penitentiary for the offense of burglary, commuted to one year and nine months upon the recommendation of the warden for the purpose of restoring to the said Harry Williams, thirty days good time which he had forfeited by reason of an infraction of the prison rules. Sentence commuted January 15, 1907.

WILLIAM LA SALLE, Polk County. Committed on the 30th day of April, 1903, to serve a term of five years for the offense of larcency. Sentence commuted to three years, nine months, and twenty days, upon the recommendation of the warden for the purpose of restoring to the said William La Salle, twenty-five days good time forfeited by reason of an infraction of the prison rules. Sentence commuted February 23, 1907.

JOHN HARRIS, Wapello County. Committed to the penitentiary on the 29th day of September, 1904, to serve a term of three years for the offense of murder. Commuted to two years, ten months, and twenty days upon the recommendation of Hon. N. N. Jones, warden of the penitentiary. Sentence commuted March 15, 1907, cutting off nine days of his sentence in order that he might obtain employment on a farm of J. N. Jones, son of warden Jones.

JOHN CREES, Dallas County. Committed to the penitentiary on the 15th day of December, 1906, to serve a term of eight months for the offense of larceny. Commuted to seven months and six days upon the recommendation of the warden of the penitentiary who filed a statement of the prison physician to the effect that said John Crees was afflicted with tuberculosis and was in a very serious condition from hemorrhage of the lung. Sentence commuted March 30, 1907.

WILLIAM JONES, Dubuque County. Committed to the penitentiary on the 16th day of December, 1904, to serve a term of eighteen years for the offense of murder in the second degree. Commuted to two years eight months and twenty-five days for the purpose of enabling the said William Jones to undergo an operation for the removal of an abscess and which it was believed could be more successfully performed if said William Jones were permitted to return to his home at Hodges, South Carolina. This commutation was also recommended by Hon. M. C. Matthews, judge who pronounced sentence and who stated in his letter that from facts learned since the trial he was satisfied that the sentence was too severe and that if the said facts had been shown upon the trial he would probably not have received a term longer than three to five years. Sentence commuted April 30, 1907.

JOEL RICE, Pottawattamic County. Committed to the penitentiary on the 18th day of September, 1903, to serve a term of five years for the offense of violating section 5475 and 5478 of the revised statutes of the United States. Commuted to three years and nine months upon the recommendation of warden in order to restore to the said Joel Rice thirty days good time which had been lost by reason of infraction of the prison rules. Sentence commuted May 7, 1907.

W. H. CHAPMAN, Marshall County. Committed to the penitentiary on the 28th day of September, 1904, to serve a term of twelve years for the offense of larceny from the person. Application for commutation was made upon the ground that the sentence was excessive. Strong recommendations were filed from many business men in Chicago, where the said W. H. Chapman formerly lived, one of whom offered him a position as soon as he was released. Sentence commuted May 22, 1907.

DARIUS CLARKE, Jasper County. Committed to the penitentiary on the 31st day of October, 1903, to serve a term of five years for the offense of larceny. Sentence commuted to four years, nine months and fifteen days, upon the recommendation of the warden for the purpose of rstoring to the said Darius Clarke six days good time which he had forfeited by reason of an infraction of the prison rules. Sentence commuted July 26, 1907.

MICHAEL CONROY, Scott County. Committed to the penitentiary on the 18th day of April, 1905, to serve a term of three years for the offense of burglary. Clemency was recommended by C. H. George, W. J. McCoy, E. Burke, W. J. Keef, county attorney and L. E. Fay, all of Clinton, by Hon. Joe R. Lane, Chas. M. Waterman, M. T. Donegan, H. J. McFarland, T. J. Hudson, and W. G. Noth. Sentence commuted August 23, 1907.

ED. BELL, Johnson County. Committed to the penitentiary on the 5th day of June, 1901, to serve a term of five years for the offense of assault to rob. Sentence commuted to four years eight months for the purpose of giving said Ed Bell, the benefit of the four months spent in the county jail of Johnson county between his revocation of suspension of sentence and date of his recommitment to the penitentiary. Sentence commuted August 24, 1907.

WILSON FOSTER, Wapello County. Committed to the penitentiary on the second day of February, 1904, to serve a term of five years for the offense of breaking and entering. Sentence commuted to four years and ten months in order that the said Wilson Foster might be released on the 25th day of December, 1907, on account of the very serious illness of his parents. Sentence commuted September 24, 1907.

JAMES HANLON, Scott County. Committed to the penitentiary on the tenth day of October 1904, to serve a term of five years for the offense of forgery. Sentence commuted to three years, eleven months, and fifteen days, upon showing filed by Hon. Wm. E. Mason, United States Senator from Illinois and in order that he might be released on the first day of January, 1908, to take a position which was offered him at that time. Sentence commuted December 16, 1907.

ROBERT HAINES, Polk County. Committed to the penitentiary on the 21st day of March, 1995, to serve a term of three years for the offense of robbery. Sentence commuted to two years eight months and twenty-seven days upon the recommendation of the warden, thus restoring to him five days good time which he had lost by an infraction of the prison rules. Sentence commuted December 17, 1907.

EDWARD NORTON, Jasper County. Committed to the penitentiary on the 26th day of December 1905, to serve a term of two and one-half years for the offense of larceny. Sentence was commuted upon the recommendation of the Board of Parole on account of the health of the said Edward Norton and in order to permit him to go to South Dakota to live. Sentence commuted December 30, 1907.

ARTHUR SOUTHWELL, Pottawattamie County. Committed to the county jail on the 15th day of June, 1907, to serve a term of eleven months for the offense of assault to commit great bodily injury. Clemency was recommended by Hon. O. D. Wheeler, judge, John J. Ness, county attorney, by the board of supervisors, by Mr. Freemont Benjamin, and Mr. Robert Wallace, all of Council Bluffs. Sentence commuted on the 29th day of February 1908.

CHARLES TAYLOR, Wapello County. Committed to the penitentiary on the 2d day of October, 1905, to serve a term of three years for the offense of assault to commit rape. Sentence commuted to two years, eleven months, and twenty days, upon the recommendation of the warden of the penitentiary in order to restore sixty-two days good time which he had forfeited by reason of an infraction of the prison rules. Sentence commuted March '13, 1908.

GEORGE ANDERSON, Beuna Vista County. Committed to the penitentiary on the 20th day of September 1907, to serve a term of fifteen months for the offense of breaking and entering. Sentence commuted to nine months upon the recommendation of A. L. Whitney, county attorney and practically all the business men of Marathon and is for the purpose of making his sentence the same length as that of Emil Florine the co-defendant in this case. Sentence commuted May 4, 1908.

WILLIAM CATON, Woodbury County. Committed to the penitentiary on the 9th day of October, 1903, to serve a term of ten years for the offense of larceny from the person. Sentence commuted to six years, eight months and eighteen days, upon the recommendation of the Board of Parole. Sentence commuted May 4, 1908.

E. H. TRAVIS, Fayette County. Committed to the penitentiary on the 2d day of December 1904, to serve a term of five years for the offense of larceny. Sentence commuted to four years, eight months, and eighteen days, for the purpose of giving the said E. H. Travis the benefit of the three months spent in the county jall prior to his commitment to the penitentiary and because of the showing filed in this office that his wife was dying. Sentence commuted June 27, 1908.

ROBERT SATTERTHWAITE, Muscatine County. Committed to the penitentiary to serve an indeterminate term for the offense of breaking and entering. This commutation was granted upon the showing filed in this office to the effect that the physical condition of the said Robert Satterthwaite was such that further confinement would endanger his life and same was recommended by Hon. A. J. House, judge who pronounced sentence, A. H. Pepper, county attorney who prosecuted, R. F. Benham, sheriff, Dr. W. H. Norton, D. R. Foster, Muscatine and by F. C. Block from whom the goods were stolen. Sentence commuted August 28th so that the said Robert Satterthwaite would be released September 1, 1908.

HARRY WAITE, Monroe County. Committed to the penitentiary on the 11th day of May, 1906, to serve a term of three years for the offense of larceny. This commutation was granted for the purpose of giving the said Harry Waite the benefit of the ten months spent in the county jail of Monroe County, prior to his commitment and was recommended by the judge who pronounced sentence and who stated that this time was not taken into consideration in imposing the sentence. Sentence commuted to two years, ten months, September 5, 1908.

CHARLES KOONTZ, Pocahontas County. Committed to the penitentiary on the 2d day of March, 1907, to serve a term of two years for the offense of larceny. This commutation was granted for the purpose of giving the said Charles Koontz the benefit of one and one-half months spent in the county jail prior to the commitment to the penitentiary and recommended by the judge who pronounced sentence, by the county attorney who prosecuted, and by the warden of the penitentiary. Sentence commuted to one year, ten months and fifteen days, September 12, 1908.

GRANT RUSH, Fayette County. Committed to the penitentiary on the 4th day of December, 1905, to serve a term of four years for the offense of larceny. Clemency was recommended by Hon. A. M. Hobson, judge, R. G. Anderson, county attorney, J. L. Scallan, county auditor, O. C. Nuss, county treasurer, W. M. Peck, county recorder, J. W. Winston, clerk of the District Court, C. L. Low, sheriff, by all the members of the board of supervisors and by H. P. Hancock at West Union. Sentence commuted to three years and six months, September 12, 1908.

JOHN WALKER, Polk County. Committed to to the penitentiary March 14, 1905, to serve a term of six years, seven and one-half months for the offense of manslaughter. Sentence commuted to five years, one month upon the recommendation of the warden of the penitentiary. The intention of same being that the said John Walker should be released from the said penitentiary on the first day of January, 1909, so that he might have the benefit of good time earned upon the time served in the said penitentiary prior to his new trial in the Supreme Court of the State of Iowa. Sentence commuted November 11, 1908.

ROSCOE MOORE, Mahaska County. Committed to the penitentiary on the 26th day of March, 1907, to serve a term of two years for the offense of uttering a forged instrument. Sentence commuted to one year, eleven months upon the recommendation of Hon. Byron W. Preston, judge who pronounced sentence, for the purpose of giving the said Roscoe Moore the benefit of the time spent in the county jail prior to his commitment to the penitentiary. Sentence commuted November 11, 1908.

FRANK BALLARD, Wapello County. Committed to the penitentiary on the 24th day January 1904, to serve a term of fifteen years for the offense of burglary. Clemency was recommended by A. W. Enoch, formerly county attorney, by T. C. Walker, R. F. Cartridge, F. H. Telfair, C. R. Beachamp, and a large number of the citizens of Shaw, Bolliver county, Mississippl, where the said Frank Ballard formerly lived. Sentence commuted November 12, 1908.

WHLIAM McCAUSLAND, Wright County. Committed to the penitentiary on the 9th day of March, 1907, to serve a term of ten years for the offense of rape. Clemency was recommended by L. G. Boyer, father of the prosecuting witness, by J. W. Henneberry, Eagle Grove, by Dr. F. J. Will of Des Moines, by D. H. Levurd, deputy sheriff, W.

H. Trowlige, county treasurer, E. M. Callender, county auditor and one hundred and twenty-five residents of Eagle Grove and vicinity, including many influential business men who were familiar with the circumstances connected with the commission of the crime. Sentence commuted to one year, eleven menths and twenty days, November 14, 1908.

JOHN MILLER, Benton County. Committed to the penitentiary on the 17th day of May, 1907, to serve a term of two years for the offense of grand larceny. Sentence commuted to one year, seven months, and twenty-eight days. This man was paroled by the Board of Parole and had obtained employment in Des Moines, but a short time after release on parole developed tuberculosis and showing was filed with the Governor to the effect that he would not live more than a few months if compelled to remain in this climate during the winter and commutation was asked in order that he might leave the state. The same was granted on the 20th day of November 1908.

FRANK O'MEARA, Dubuque County. Committed to the county jail, on the 16th day of June, 1908, to serve a term of six months for the offense of malicious injury to a building. Sentence commuted to five months, four days in order that he might have an operation preformed for hernia, which was caused by injury received while confined in the county jail. Sentence commuted November 20, 1908.

JOE MARTINEZ, Mills County, Committed to the penitentiary on the 10th day of March, 1899, to serve a term of seventeen years for the offense of robbery. Sentence commuted to sixteen years, ten months, twenty-five days, upon the recommendation of Hon. W. R. Green, judge who pronounced sentence, and by the warden of the penitentiary, for the purpose of allowing the said Joe Martinez for the time spent in the county jail prior to commitment. Sentence commuted November 20, 1908.

GEORGE WEEMS, Polk County. Convicted on the 30th day of July, 1894, of the crime of murder in the first degree and sentenced to be hanged, which sentence was on the 11th day of July, 1896, commuted to life imprisonment by Francis F. Drake, Governor, and on the 21st day of November, 1908, commuted to thirty years imprisonment. The following statement being embodied in the order of the commutation of this sentence by the Governor.

"The Board of Parole, at my suggestion, has investigated this case and reports recommending a commutation of this sentence from life to thirty-two years. I have given the case careful consideration and in view of the age and health of Weems' father and in the hope that this old man may be permitted to be, at least for a time, with his son, I have concluded to commute the sentence from the life to thirty years instead of thirty-two years." Sentence commuted November 21, 1908.

ROBERT MAIZE, alias ROBERT SNOW, Polk County. Committed to the penitentiary on the 2d day of June, 1902, to serve a term of twenty years for the offense of robbery. Commuted to seven years solid time upon the recommendation of the Board of Parole. Sentence commuted November 23, 1908.

HARRY MIDDLETON, Linn County. Committed to the penitentiary on the 20th day of February, 1908, to serve an indeterminate sentence for the offense of larceny from a building. Sentence commuted to one year solid time upon the recommendation of the Board of Parole. Sentence commuted November 23, 1908.

CHARLES GARRISON, Grundy County. Committed to the penitentiary on the 6th day of September, 1907, to serve an Indeterminate term for the offense of forgery. Commuted to two years solid time upon the recommendation of the Board of Parole. Sentence commuted November 23, 1908.

FREDERICK HANSEN, Scott County. Committed to the penitentiary on the 10th day of December, 1900 for life, for the offense of rape, commuted to twenty-five years upon the recommendation of the Board of Parole to whom this application for clemency was referred by the Governor for an investigation and recommendation. Clemency was also recommended by Hon. James W. Bollinger, judge who pronounced sentence, by Hon. Geo. W. Scott, Mayor Davenport, by Hon. Harry W. Phillips, and Hon. Waldo Becker, both ex-mayors of the city of Davenport, by Louis Echardt, sheriff, H. J. McFarland, clerk of the District Court, F. Holn, recorder, E. Collins, and by Mrs. Theo Thiel, who was prosecuting witness at the time of trial. Sentence commuted November 23, 1908.

JOSEPHINE WILSON, Mahaska County. Committed on the 15th day of November, 1904, to serve a term of five years for the offense of keeping a house of ill-fame. Sentence commuted to four years upon the recommendation of John O. Malcolm of Oskaloosa and the warden of the penitentiary on account of the physical and mental condition of the said Josephine Wilson. Sentence commuted November 23, 1908.

HOYT S. WILKINS, Polk County. Committed to the penitentiary on the 3d day of May, 1904, to serve a term of seven years for the offense of breaking and entering and robbery. Commuted to five years three months and nine days, for the purpose of restoring to the said Hoyt S. Wilkins, one-half of the good time which he had lost by in-fraction of the prison rules and which was recommended by the warden of the penitentiary. Sentence commuted November 24, 1908.

CHARLES M. JOHNSON, Black Hawk County. Committed to the penitentiary on the 24th day of October, 1905, to serve a term of six years for the offense of assisting a prisoner to escape. Commuted to five years upon the recommendation of Clifford L. Niles, treasurer of the American Cooperage Co., Anamosa, Iowa, who wrote a very

strong letter in his behalf, by Sherman T. Mears, county attorney of Black Hawk County, and by W. M. Law, of Waterloo. Also a letter from Hon. A. S. Blair, Judge who pronounced sentence stating that he had no objection to the extending of clemency in this case. Sentence commuted November 24, 1908.

OTTAVIA LAPROVATIRA, Polk County. Committed to the pententiary on the 19th day of December, 1907, to serve an indeterminate sentence for the offense of manslaughter. Sentence commuted to one year, eleven months and twelve days solid time. Sentence commuted November 24, 1908.

FRANK NOVAK, Benton County. Committed to the penitentiary on the 30th day of December, 1897, for life for the offense of murder in the second degree. Commuted to imprisonment for twenty-five years. A strong statement in his behalf was filed by Mr. John J. Ney of Iowa City, in addition to the showing which had previously been filed in his behalf, for reference to the General Assembly in the matter of his application for pardon. Sentence commuted November 23, 1908.

REMISSIONS.

The remissions herein presented were, in almost every case, recommended by those officers in the counties where the fines were imposed who are concerned, directly or indirectly, in the collection of the same; namely, the county attorney, county auditor, clerk of the District Court, county treasurer, and the members of the board of supervisors, or a majority of them and were conditioned upon the payment of all costs when the same had not been paid.
