LIBRARIAN'S REPORT.

OFFICE OF THE STATE LIBRARIAN.
Des Moines, July 1, 1887. }

To His Excellency, WILLIAM LARRABEE, Governor of Iowa:

SIR—I have the honor to submit herewith the following report of this department of the public service, for the period beginning July 1, 1885, and ending June 30, 1887.

My last report showed the whole number of books in the library, exclusive of duplicates and pamphlets, to be 28,160. Additions made since are—

The growth and usefulness of the library are understood by those availing themselves of its advantages, and need not be pointed out, but the needs and deficiencies are not so apparent.

According to promise in my last report, the shelf lists of the books in the general library have been completed; a revised list of the law text-books is being made; also a list of the law reports. It now remains to revise the card catalog and prepare it for printing, in which work the librarian should have the continued assistance of experienced help, and as the salary of the first assistant is not sufficient to procure the best help, I respectfully ask that a small appropriation be made to supplement said salary, during the making and printing of the catalog.

As is well known by all who have to do with books, all kinds of bindings deteriorate rapidly in the dry steam-heated air used in most libraries. This is especially true of old bindings. Many of our old books must be rebound within a short time, or be a total loss to the library. As our annual appropriation is not sufficient to keep up

with the times in all departments, I would respectfully recommend that an additional annual appropriation of three hundred dollars be made for rebinding the old books as needed.

A book elevator, spring rollers for the maps—without which they are useless—and an easel or table for the life-size illustrations of Audubon's birds, are needed and economy as well as convenience dictate that the library be supplied with them.

I would call your attention to the limited number of Iowa supreme court reports left to the library, after the regular distribution; eight copies only are left us, six of which go into the sets in the library and other offices, while the State Historical Society receives twenty copies.

I desire to speak of another matter, which, though not directly connected with the library, is relatively so. I refer to the State Historical Society, which should be at the Capitol, or at least a State Historical Society should be in the Capitol, where the two institutions could supplement each other.

I have occasional offers of relics presented to the library for which I have no place, and, consequently, I cannot accept them. The newspapers of the state, which have been so kindly donated by their editors and publishers, and which will be invaluable in the future as historical references, are accumulating beyond the accommodations for them in the library. They would of themselves make a fine nucleus for one department of an historical collection.

Since my last report an additional case of autographs, photographs and steel engravings has been made to the Aldrich collection, which, owing to the indefatigable efforts of the generous donor, is assuming vast proportions. Among the most notable recent gifts are autographs—in some cases letters—and steel engravings of Queen Victoria, George Eliot, G. H. Lewes, E. B. and Robert Browning, Sir Walter Scott, Thackeray, Tennyson, Burns, McCauley, Darwin, Lyell, Huxley, in short an innumerable array of kings, queens, popes, bishops, statesmen, literary celebrities and persons of distinction generally. As constant additions are being received no catalog has yet been made.

Allow me to add one *important need* (omitted above) is strips of matting from door to door and from end to end of the library. To nervous persons and those unaccustomed to studying in public, the tread of the variety of boots and shoes, from the squeaking tenor to

the profound bass, of the constant stream of visitors and sight-seers is, to say the least, very distracting.

I append, as usual, the financial statement and catalog of accessions.
