

## REPORT OF BOARD OF ENGINEERING EXAMINERS

The Iowa State Board of Engineering Examiners was created by an Act of the Thirty-eighth General Assembly, under authority of Chapter 392, effective July 4, 1919.

The first meeting of the Board was held July 14, 1919, at Des Moines, Iowa, and the following appointments were made:

- Mr. Seth Dean, Glenwood, four years.
- Mr. K. C. Kastberg, Des Moines, four years.
- Mr. L. M. Martin, Atlantic, four years.
- Mr. F. W. Stubbs, Oelwein, two years.
- Mr. Alvin LeVan, Ft. Dodge, two years.

From July 4, 1919, to December 31, 1919, the Board of Engineering Examiners registered all applicants without examination who were in practice at the time the law went into effect. There were 1,062 registered during this period.

During the past two years, approximately 150 filed applications, for examination, of which about ninety appeared to take the examination, about ten of this number failing to pass the examination satisfactorily.

New rules and regulations have been adopted by the Board of Engineering Examiners from time to time, in an effort to raise the standards of the engineering profession generally.

### RECIPROCAL REGISTRATION

Laws of the various states provide for reciprocal registration among the states. The carrying out of these provisions has made it necessary for the several state boards to come to an agreement as to qualifications and conditions for the mutual operation of the several state laws. As a result of conferences between representatives of the several state boards a National Council of State Boards of Engineering Examiners has been formed, and an agreement entered into whereby reciprocal registration can become operative among the states, based on qualifications that will meet all state laws. In most cases this agreement sets a standard higher than the individual state law.

Each state continues to issue its state registration; in addition, where requested, and complying with the requirements, a reciprocal certificate is issued. The card issued by the Council and signed

and sealed by the state board when application is made, is retained by the applicant, and with it a letter or certification is issued to the state where reciprocal registration is desired, to be retained in the files of such state as evidence of the issuance of such registration. This must be accompanied by the regular application with such data as may be required together with the fee required in the state where applicant desires reciprocal registration.

#### NATIONAL COUNCIL OF STATE BOARDS OF ENGINEERING EXAMINERS REVISED ARTICLES OF AGREEMENT RELATING TO RECIPROCAL REGISTRATION OF ENGINEERS.

Article 1. Reciprocal registration as provided for in these Articles of Agreement shall be granted only to an applicant who is already registered in some state which is a member of this Council. A detailed professional record, properly attested, and accompanied by references as to character and qualifications from three registered practicing engineers shall be filed with the applicant's board of examiners. Qualifications for reciprocal registration shall be determined upon the basis of such professional record, thorough consideration of which shall constitute examination.

Article 2. Engineering experience gained by the applicant prior to his reaching the age of eighteen years shall not be counted as a part of his professional experience.

Article 3. Professional experience shall be considered as beginning when the candidate has entered upon a position in professional engineering work which requires original thought and responsibility. For example:

(a) In the field experience shall begin to count when the applicant reaches a position of responsibility equivalent to that of actual transitman.

(b) In the shop or laboratory experience shall begin to count only after apprenticeship, foremanship, inspectorship, or other subordinate positions, unless the work done specifically shows that the applicant possesses originality of design and has had responsibility in his subordinate positions.

(c) In the office or drafting room experience shall begin to count when the applicant ceases to do merely tracing, lettering, or purely mechanical work, requiring for its performance merely manual dexterity and enters a position of responsibility where he begins actual design.

(d) Experience in the teaching of engineering shall begin to count when the applicant is a full time instructor in engineering in an engineering school of recognized standing, and each year of teaching shall be considered equivalent to one year of practice.

Article 4. The applicant shall have had ten years of experience in professional engineering, and in addition shall show that he qualified to design as well as to direct engineering operations, as evidence of qualifications for reciprocal registration, and his experience record shall show progressive advancement in the character of the work performed.

Each case shall be considered on its merits, and the experience record must be given in such complete detail that the Board of Examiners can determine the character of work performed by the applicant.

Article 5. Graduation from an engineering school of recognized standing shall be accepted as the equivalent of four years of such practice.

An engineering school of recognized standing shall be one which requires the equivalent of a high school or preparatory school diploma as an entrance requirement and demands the equivalent of a four years' course in engineering for graduation.

Article 6. Making reciprocal registration operative between the states shall be done by means of certifications from one state to another of the applicant's qualifications. This certification shall be by means of a card or form bearing the date, serial number, and the signatures of the officers and the seal of the board of the state issuing same. This card is to be printed and distributed by the National Council of State Boards of Engineering Examiners.

Article 7. Whenever an applicant applies to his own state board for reciprocal registration, if his qualifications fully comply with the standard herein provided, he shall be granted the same.

(NOTE—The Council has by resolution interpreted "that he may be granted a reciprocal card by the state in which he was first registered, provided the state of which he is a resident does not have a law providing for the registration of engineers.")

Article 8. The aforesaid reciprocal registration certificate shall be prima facie evidence of qualification for registration in any state that is a member of this Council and that has subscribed to these Articles of Agreement. When such reciprocal registration certificate is presented, together with the legal fee required, and such information (other than evidence of qualification) as may be requested for the records of the Board to which the application is made, such board shall issue a registration certificate to the applicant.

Article 9. Any reciprocal certificate may be revoked by the state issuing same upon presentation to its Board of Examiners of good and sufficient evidence of the incompetency or proof that the applicant's character warrants such revocation.

Article 10. Should any questions or disagreements in the interpretation of these Articles arise, such questions shall be referred to the Council for action at its next regular meeting, or if more expeditious action shall be necessary, they may be acted upon by the Council by letter ballot.

If action is taken by letter ballot, such action shall be conducted through the office of the Secretary of the Council in the customary manner; and the votes shall be counted not later than sixty days after forwarding from his office, by registered mail, of questions at issue. The Secretary of the Council shall thereupon immediately certify to the various member boards the roll call and results of the vote, and the determination of the questions at issue; and consequent actions shall be in accordance with the majority of the votes recorded.

#### RULES AND REGULATIONS RECIPROCIDITY

Reciprocal certificates will only be granted if an examination therefor has been held by the State Board granting such certificate.

State Boards of Engineering Examiners with which we have reciprocal

relations will be given a list of registrants whose certificates have been revoked, together with the reason for such action.

This Board will issue, upon application and receipt of the fee, as provided by law, our own registration certificate to any person from any of the states with which we have reciprocal agreements, presenting satisfactory evidence that he is registered in good standing with, and recommended by the Board of the State in which applicant is first registered.

To persons registered in other states than those approved and making application, our registration certificate will be denied except as they satisfy the Iowa Board by examination or other evidence acceptable in the judgment of the Board that they are competent professional engineers and (or) Land Surveyors in conformity with Sections 1855 and 1866 of the Iowa law.

Examinations conducted for the purpose of granting reciprocity will be in one of the general branches such as Civil, Mechanical, or Electrical, rather than in special branches such as Highway, Drainage, Heating and Ventilating, et cetera.

Applicants for reciprocal registration who were registered under the "Grandfather Clause" without examination must appear before the Board of Examiners for examination before reciprocal registration can be granted.

#### PRACTICE OF ENGINEERING PENDING EXAMINATION

Any person, or persons, desiring to practice engineering will be required to make formal application to the Iowa State Board of Engineering Examiners for registration before beginning such work in the state of Iowa. They shall be allowed to practice not more than 90 days before securing said registration, and the Board of Engineering Examiners shall arrange to hold called meetings of said Board for examination of applicants at such periods as will enable the applicants to secure said examinations within the time limit above mentioned.

#### TIME LIMIT FOR TAKING LAND SURVEYING EXAMINATION UNDER ONE FEE

Applicants applying for registration as Land Surveyor after the time they apply for Professional Engineering, in order to receive registration for both under the one fee of Twenty-five (\$25.00) Dollars, but who do not take examinations for both branches at the same time, shall appear and take examinations for both branches within one year from the date of the first examination. Upon failure to do so, a new application shall be required, with a new fee of Twenty-five (\$25.00) Dollars.

#### RULES RELATING TO EXAMINATIONS

Before notifying any applicant to appear for examination, a digest of his training and experience shall be submitted to the members of the Board for approval, and no one will be admitted for examination until he has had the full amount of training and experience required by law.

At each examination, one day shall be devoted to questions on fundamentals in all branches of engineering, and one day shall be devoted to examination on professional questions.

At the time of examination, each candidate shall be given similar sets of ten questions each for fundamentals and the several branches of engineering.

The final rating of an applicant shall be determined by the following:

Personality, having to do also with character and executive ability; ten per cent of total rating.

Experience, (nature and extent); fifteen per cent of total rating.

Examination in fundamentals, consisting of ten questions in writing, thirty-five per cent of total rating.

Examination on principles of good practice, consisting of a certain number of questions in writing, depending upon the branch of engineering taken; forty per cent of total rating.

A grade of seventy (70%) per cent shall be considered a passing grade.

Examinations given subsequent to one or more in which an applicant may

have failed, shall be complete in themselves, and no former examinations or any parts thereof shall have any consideration whatsoever.

All applicants shall be notified of two consecutive Engineering Board meetings after their application is filed with this office.

The examinations are usually held in the Senate Chamber in the State House at Des Moines, Iowa.

An extra charge of \$2.00 shall be made for issuing duplicate certificates to any registered engineer.

## IOWA LAW RELATING TO ENGINEERING

## CHAPTER 89, 1927 CODE OF IOWA

1854. **Registered engineers and surveyors.** No person shall practice professional engineering or land surveying in the state unless he be a registered professional engineer or a registered land surveyor as provided in this chapter, except as permitted by the last section thereof.

1855. **Terms defined.** The "board" means the Iowa state board of engineering examiners provided by this chapter.

"Professional engineering" means the practice of any branch of the profession of engineering other than military engineering. The practice of said profession embraces the designing and the supervision of the construction of public and private utilities, such as railroads, bridges, canals, harbors, river improvements, lighthouses, wet docks, dry docks, ships, barges, dredges, cranes, floating docks, and other floating property, the design and the supervision of the construction of steam engines, turbines, internal combustion engines and other mechanical structures, electrical machinery and apparatus, and of works for the development, transmission or application of power, and the designing and the supervision of the construction of municipal works, irrigation works, water supply works, sewerage works, drainage works, industrial works, sanitary works, hydraulic works, structural works, and other public and private utilities or works which require for their designing or the supervision of their construction such experience and technical knowledge as are required by this chapter.

The execution as a contractor of work designed by a professional engineer or the supervision of the construction of such work as a foreman or superintendent for such a contractor or the construction, improving, or extending of private drains or drainage works, private irrigation works, private water supply works, or other works of a private nature shall not be deemed to be the practice of professional engineering within the meaning of this chapter.

A "professional engineer" means any person who practices professional engineering.

"Land surveying" is surveying having to do with the boundaries or areas of tracts of land. The surveying of lands for the purpose of subdividing or determining boundary lines where no contest is involved shall not be deemed to be the practice of land surveying within the meaning of this chapter.

A "land surveyor" is any person who makes land surveys.

1856. **Board of engineering examiners—qualifications.** There is hereby created a state board of engineering examiners consisting of five members who shall be appointed by the governor. Each member of the board shall be a professional engineer at least thirty-five years of age, and shall have been a resident of

this state for at least three years immediately preceding his appointment and shall have had at least ten years' active practice preceding his appointment and during such time shall have had charge of engineering work as principal or assistant for at least two years, and shall be a member in good standing of a recognized state or national engineering society. No two members of said board shall be from the same branch of the profession of engineering.

**1857. Appointment and tenure.** Appointments to said board shall be made as follows:

1. Two members on July 1, 1925, and each four years thereafter.
2. Three members on July 1, 1927, and each four years thereafter.

**1858. Vacancies—how filled.** Vacancies in the membership of the board caused by death, resignation, or removal from office, shall be filled by an appointment from the governor for the unexpired portion of the term.

**1859. Official seal—by-laws.** The board shall adopt and have an official seal which shall be affixed to all certificates of registration granted and may make all by-laws and rules, not inconsistent with law, necessary for the proper performance of its duty.

**1860. Attorney general to assist—general powers.** Such board, or any committee thereof, shall be entitled to the counsel and to the services of the attorney general, and shall have power to compel the attendance of witnesses, and may take testimony and proofs and may administer oaths concerning any matter within its jurisdiction.

**1861. Compensation and expenses.** Each member of the board shall receive as compensation the sum of ten dollars per day for the time actually spent in traveling to and from, and in attending sessions of the board and its committees, and shall receive all necessary traveling and incidental expenses incurred in the discharge of his duties, but in no event shall the state be chargeable with any expense incurred under the provisions of this chapter.

**1862. Organization of the board—meetings—quorum.** The board shall elect annually from its members a chairman and a vice chairman. The secretary of the executive council, or one of his assistants, to be designated by him, shall act as secretary of said board. The board shall hold at least one stated meeting on the first Tuesday of December of each year, and special meetings shall be called at other times by the secretary at the request of the chairman or of three members of the board. At any meeting of the board, three members shall constitute a quorum. The board shall have power to employ such additional clerical assistants and incur such office expense as may be necessary to properly carry out the provisions of this chapter.

**1863. Annual report.** At the time provided by law, the board shall submit to the governor a written report of its transactions for the preceding year, and shall file with the secretary of state a copy thereof, together with a complete statement of the receipts and expenditures of the board, attested by the affidavits of the chairman and the secretary, and a complete list of those registered under this chapter with their addresses and the dates of their certificates of registration. Said report shall be printed by the state and a copy mailed to, and placed on file in the office of the clerk of each incorporated city or town in the state and in the office of the auditor of each county therein.

**1864. Secretary—duties of.** The secretary shall keep on file a record of all certificates of registration granted and shall make annually such revisions of said record as may be necessary. In revising said record the secretary shall communicate annually by mail with every professional engineer and surveyor registered hereunder. In every case in which a reply is not received within thirty days after the date of the first letter, the secretary shall send a second letter by registered mail and the failure on the part of any engineer or surveyor to reply within sixty days from the date of said second letter shall operate to revoke his certificate of registration, but he may be reinstated at any time upon due application therefor and upon the payment of a registration fee of ten dollars as hereinafter provided.

**1865. Engineering examiners' fund.** The secretary shall collect and account for all fees provided for by this chapter and pay the same to the state treasurer who shall keep such moneys in a separate fund to be known as the fund of the board of engineering examiners, which shall be continued from year to year and shall be drawn on only for the expenses and compensation of said board of examiners as provided in this chapter.

**1866. Examination fees.** The board shall admit to examination any candidate who pays a fee of fifteen dollars and who under oath submits evidence prescribed by the board that he is more than twenty-five years of age, is of good character, and has been engaged in the practice of professional engineering or land surveying for at least six years and during that period has had charge as assistant, for at least one year. Each year of work satisfactorily completed at an engineering school of recognized standing shall count as one year of practice in fulfilling the six-year requirement of this section.

**1867. Examinations—report required.** Examinations for registration shall be given at stated or called meetings of the board. The scope of the examinations and the methods of procedure shall be prescribed by the board. As soon as practicable, after the close of each examination, a report shall be filed in the office of the secretary of the board by the members conducting such examinations. Said report shall show the action of the board

upon each application, whereupon the secretary of the board shall notify each applicant of the result of his examination.

**1868. Seal—certificate evidence of registration.** Each registrant shall provide himself with a suitable seal with a uniform inscription thereon formulated by the board, with which he shall stamp all plans, specifications, surveys, and reports made or issued by him. A certificate of registration provided for in this chapter shall be presumptive evidence that the person named therein is legally registered.

**1869. Certificate.** To any applicant who shall have passed the examination as a professional engineer and who shall have paid an additional fee of ten dollars, the board shall issue a certificate of registration as a professional engineer signed by the chairman and secretary of the board under the seal of such board, which certificate shall authorize the applicant to practice professional engineering as defined in this chapter. Such certificate shall not carry with it the right to practice land surveying, unless specifically so stated in said certificate, which permission shall be granted by the board without additional fee in cases where the applicant duly qualifies as a land surveyor as prescribed by the rules of said board.

**1869-b1. Expirations and renewals.** Every certificate to practice professional engineering or land surveying issued under the provisions of this chapter, shall expire on the thirty-first day of December following the date of the issuance thereof, and shall be renewed only upon application by the holder thereof, without examination, upon the payment of a renewal fee of two dollars. Application for renewal shall be made in writing to the secretary accompanied by the fee before the first day of December of each year. Every renewal certificate shall be displayed in connection with the original certificate. The secretary shall notify by mail each holder of a certificate of the expiration thereof.

Any holder of a certificate who allows his certificate to lapse by failing to renew it as provided herein, may be reinstated without examination upon the recommendation of the examining board and upon the payment of the registration fee of ten dollars as provided in section 1864, and the renewal fees then due.

**1870. Land surveyors' certificate.** To any applicant who shall have passed the examination as a land surveyor and who shall have paid an additional fee of ten dollars, the board shall issue a certificate of registration signed by its chairman and secretary under the seal of the board, which certificate shall authorize the applicant to practice land surveying as defined in this chapter and to administer oaths to his assistants and to witnesses produced for examination, with reference to facts connected with land surveys, being made by such land surveyor.

**1871. Foreign registrants.** The board shall from time to time examine the requirements for registration of professional engi-

neers and land surveyors in other states, territories, and countries, and shall record those in which in the judgment of the board standards not lower than those provided by this chapter are maintained. The secretary of the board upon presentation to him of satisfactory evidence, by any person, that he holds a certificate of registration issued to him by proper authority in any state, territory, or country so recorded, and upon the receipt of a fee of ten dollars, shall issue to such person a certificate of registration to practice professional engineering or land surveying as provided by this chapter, signed by the chairman and the secretary under the seal of the board, whereupon the person to whom such certificate is issued shall be entitled to all the rights and privileges conferred by the certificate issued after examination by the board.

**1872. Revocation of certificate.** The board shall have the power by a four-fifths vote of the entire board to revoke the certificate of any professional engineer or land surveyor registered hereunder, found guilty of any fraud or deceit in his practice, or guilty of any fraud or deceit in obtaining his certificate, or in case he is found by the same vote to be incompetent.

**1873. Procedure.** Proceedings for the revocation of a certificate of registration shall be begun by filing with the secretary of the board written charges against the accused. The board shall designate a time and place for a hearing, and shall notify the accused of this action and furnish him a copy of all charges at least thirty days prior to the date of the hearing. The accused shall have the right to appear personally or by counsel, to cross-examine witnesses or to produce witnesses in his defense.

**1874. Expenditures.** Warrants for the payment of expenses and compensations provided by this chapter shall be issued by the auditor of state and paid by the state treasurer upon presentation of vouchers regularly drawn by the chairman and secretary of the board and passed by the state board of audit, but at no time shall the total amount of warrants exceed the total amount of the examination and registration fees collected as herein provided.

**1875. Violations.** Any person who is not legally authorized to practice in this state according to the provisions of this chapter, and shall practice, or shall in connection with his name use any designation tending to imply or designate him as a registered practitioner within the meaning of this chapter, and any person presenting or attempting to file as his own the certificate or registration of another, or who shall give false or forged evidence of any kind to the board, or to any member thereof, in obtaining a certificate of registration, or who shall falsely impersonate another practitioner of like or different name, or who shall use or attempt to use a revoked certificate of registration shall be deemed guilty of a misdemeanor and shall for each of-

fense of which he is convicted be punished by a fine of not less than one hundred dollars, nor more than five hundred dollars, or by imprisonment for three months, or by both such fine and imprisonment.

**1876. Applicability of chapter.** This chapter shall not apply to any full-time employee of any corporation while doing work for that corporation, except in the case of corporations offering their services to the public as professional engineers or land surveyors.

Corporations engaged in designing and building works for public or private interests not their own shall be deemed to practice professional engineering within the meaning of this chapter. With respect to such corporations all principal designing or constructing engineers shall hold certificates of registration hereunder. This chapter shall not apply to corporations engaged solely in building said work. This chapter shall not apply to any professional engineer or land surveyor working for the United States government, nor to any professional engineer or land surveyor employed as an assistant to a professional engineer or land surveyor registered under this chapter, nor to purely operative services in connection with mechanical plants or systems, nor to any professional engineer or land surveyor from without this state until a reasonable length of time as prescribed by the rules of the board shall have elapsed to permit the registration of such a person under this chapter, provided that, before practicing within this state, he shall have applied for the issuance to him of a certificate of registration and shall have paid the fee prescribed in this chapter.
