## COVID-19: On-Going Service Changes

While COVID-19 remains in Iowa, IPERS continues to provide the vital services you need. Though the way we deliver our services has changed, our commitment to our members remains the same.

On-going service changes include:

- Members who apply for a refund (after leaving IPERS-covered employment) may be eligible for reduced penalties if they have been directly affected by COVID-19. Submit [this waiver](#) with your refund application (available when you log in to [My Account](#)).
- [Notarization requirements](#) on some applications are waived until further notice.
- [In-person counseling appointments](#) take place either by phone or online. Members can call 800-622-3849 to schedule an appointment or schedule one online through [My Account](#). To do this, click on the "Members Meeting" tab, choose an available date and select "Register" on the left side of the date. Then follow the Registration Instructions on the right side of the next page.
- Retirement education workshops are held via livestream and are available on-demand.

## FY2022 Contribution Rates

IPERS recently announced that contribution rates for Regular members and employers will be unchanged in FY2022. Total contribution rates for both Protection Occupation and Sheriffs/Deputy Sheriffs members and employers will be reduced by 0.50% in FY2022.
