## **Department News**

#### **POMW Looking for Training Location Options**

Through the Prevention of Opioid Misuse in Women (POMW) grant, the Iowa Department of Public Health has provided 14 "Identifying Opioid Misuse" trainings to Iowans across the state in the first two years of the project. Presentations include an overview of the following topics:

- Screening, Brief Intervention and Referral to Treatment
- Opioid overdose and recognition
- Naloxone administration
- CDC Guideline for Prescribing Opioids for Chronic Pain
- Medication-assisted treatment

### IDPH Focuses on Iowans Impacted by both HIV and OUD

The Bureau of Substance Abuse is collaborating with the Bureau of HIV, STD & Hepatitis on a project for Iowans impacted by both HIV and Opioid Use Disorder. The Strengthening Systems of Care for People with HIV and Opioid Use Disorder initiative is funded by the Health Resources and Services Administration (HRSA). The initiative provides coordinated technical assistance (TA) across HIV and behavioral health/substance use service providers. The project aims to enhance system-level coordination and networks of care among Ryan White HIV/AIDS Program (RWHAP) recipients and other federal, state and local entities, motivated by data showing that from 2011-2015, the opioid overdose death rate in the U.S. among persons diagnosed with HIV increased by 42.7%.

The purpose of this initiative is to ensure that people with HIV and OUD have access to care, treatment and recovery services that are patient-centered and culturally responsive. An on-site visit in February from the national technical assistance providers will establish state-specific goals and objectives for the project which lasts until 2021.
