# What is the Iowa Violent Death Reporting System?

The lowa Violent Death Reporting System (IAVDRS), as part of the National Violent Death Reporting System network, is the only state-based reporting system that pools more than 600 unique data elements from multiple sources into a usable, anonymous database. This system covers all types of violent death-including homicides and suicides-in all settings for all age groups. As such, this system is far more comprehensive than what is available elsewhere and data can be used to develop and tailor violence prevention efforts. To help find ways to prevent violent deaths, the IAVDRS links information about the "who, when, where and how" from data on violent deaths and provides insights about "why" they occured.

### **Quick Facts about IAVDRS**

- ✓ The Iowa Department of Public Health receives funding from CDC to administer the program.
- ✓ The program collects data from death certificates, medical examiner reports and law enforcement records to identify circumstances that contribute to these types of violent deaths:
  - Homicides
  - Suicides
  - Deaths resulting from law enforcement intervention
  - Deaths of undetermined intent
  - Deaths resulting from terrorism
- ✓ Iowa first received funding in 2014.
- ✓ Data collection began for deaths that occured in calendar year 2015 from the 7 most populous counties in Iowa.
- ✓ Statewide data collection began in calendar year 2016 and continues to this day.
- ✓ IDPH has contracted with the University of Iowa's Injury Prevention Research Center (UI-IPRC) since 2014 to conduct day-to-day data collection and abstraction, and data analysis and evaluation.
- ✓ The program has 15 months after the end of a calendar year to "close out" data for deaths that occurred each year. Data for 2018 will "close out" in Spring 2020 and analysis will begin shortly after.
- ✓ The program has put out an annual "Suicide in Iowa" report for 2015, 2016 and 2017 deaths. A 2018 report is forthcoming after data close out is complete.



# Males accounted for 80.7% of suicide victims and females accounted for 19.3% of suicide victims in 2017.

# **Notable Data from 2017 Suicide Report**

- ✓ In 2017, the majority (76.4%) of violent deaths in Iowa were classified a suicide.
- ✓ The remaining deaths from violence in Iowa were attributed to homicide (16.6%), undetermined (6.2%) and legal intervention (0.8%).
- ✓ Males accounted for 80.7% of suicide victims and females accounted for 19.3% of suicide victims in 2017.
- ✓ Firearm use was the manner of death in 45.7% of suicides, followed by asphyxiation (30.9%) and poisoning (17.0%).
- ✓ The age groups with the largest proportion of suicide deaths were people aged 25-44 and 45-64 (32% of the deaths in each group), followed by older adults (65 years or older,18%) and youth (ages 10-24) which comprised 17% of suicide deaths.
- ✓ Intimate partner problems contributed to more suicide among young adults (followed by youth and middle-age adults) than to those in the older adult group.


### Jon Davis, Data Analyst

base. She has an extensive background in records management and health information management, and maintaining the quality, accuracy, integrity and confidentiality of electronic and hard-copy data.

## **Where Have We Been?**

The IAVDRS team was busy in 2019! We are thankful for the opportunity to get out across the state and raise awareness about the program, to share data, and to thank data providers face-to-face. In the fall of 2019 we traveled to 5 of the 6 LEIN (Law Enforcement Intelligence Network) Regions in Iowa to provide an overview of the IAVDRS and region-specific data to each region.
