# Significant October rainfall improves lowa drought conditions

DES MOINES — This October ranks as one of the top 10 wettest Octobers on record, with rainfall significantly improving drought conditions, according to the latest Water Summary Update.

lowa received nearly 5 inches of rain in October, almost double the normal rainfall for the month. The U.S. Drought Monitor has eliminated the Severe Drought rating from the state for the first time since July 2020.

Streamflow and soil moisture conditions have both improved, both of which are critical for establishing good conditions for the spring of 2022.

"The widespread above-normal rainfall in October was just what was needed in Iowa," said Tim Hall, Hydrology Resources Coordinator for the Iowa DNR. "Good soaking rainfall before the winter freeze will set us up for a much better start to 2022. Hopefully this trend can continue for the next four to six weeks."

# Air Quality permits under review

DES MOINES – The DNR Air Quality Bureau has the following draft permits up for review. The permits help protect lowans' health and air quality. DNR's permitting staff review each permit application to ensure facilities comply with state and federal air quality requirements. We encourage public comments on draft permits, providing help on how to <u>make effective comments</u>. Submit written comments to the assigned permit writer before 4:30 p.m. on the last day of the comment period. DNR considers public comments before finalizing the permits.

#### **Title V Operating Permits**

Title V Operating permits are reviewed and re-issued every five years. Facilities with a Title V permit have the potential to emit large amounts of air pollutants compared to other facilities. The five-year reviews are a federal requirement and ensure adequate monitoring is included in the permit. The DNR plans to issue Title V Operating Permits for the following facilities. #### **Monroe County**

Wacker Chemical Corporation – 1 Wacker Drive, Eddyville. The application was submitted to operate their existing wet corn milling facility. The public comment period ends Dec. 4.

Project No. 21-221, Amendment of Prevention of Significant Deterioration construction permits to reflect a new Volatile Organic Compounds emission limit of 99.31 tons/year, the removal of three emission units, the updated maximum capacity for each remaining unit, and the updated exhaust temperature and flow rate for Emission Point RTO. The public comment period ends Dec. 3.
