
CEO & Board

Win....

It's a word we use often in the lottery industry, but those who win aren't just those who play our games.

With a fourth straight year of record sales for scratch tickets, the Iowa Lottery achieved record sales overall of approximately

\$371 million in its latest financial year. Those scratch ticket sales results are something that truly show the strength of our team's efforts. By working to keep a mix of game themes, price points and playstyles in the field, and by coming up with some really inventive game ideas, we've driven the success of our leading product. The Lottery finished fiscal year 2018 well ahead of budget projections, amid other significant achievements.



Considering those results, there were many winners this year:

- **The State of Iowa** The Iowa Lottery generated nearly \$87.1 million in proceeds to state causes in FY 2018. That was second-highest proceeds total in the Lottery's 33-year history and the fifth time that its annual proceeds topped the \$80-million mark.
- **The Iowa Veterans Trust Fund** The nearly \$87.1 million generated for state causes by the Lottery this year includes \$2.5 million for this fund that benefits veterans. The Lottery has now raised nearly \$25 million for this fund since it began providing proceeds to that cause in 2008.
- *Iowa Lottery players* Lottery players won a record \$227.5 million in prizes during the year.
- Lottery retailers Local businesses across the state received \$24.2 million in annual sales commissions from the Lottery, an increase of about 5.7 percent from the previous year.

We have just finished an astounding year on several fronts. With strong sales, another clean audit, strong support for "play responsibly" messages and an international award for gaming compliance in the longrunning jackpot investigation case, it was a well-rounded, successful year for our organization.

Finally, and most importantly, thanks to everyone for your patronage and support of the lowa Lottery.

Iowa Lottery Board

The lowa Lottery Board is made up of five lowa citizens appointed by the governor, and the State Treasurer serves as an ex-officio member of the board. The board oversees the Lottery and its operations. Each department at the Lottery reports to the board at meetings held throughout the year. According to lowa Code, the Lottery Board must have a member with an accounting background, a member with experience in marketing, a member with law enforcement experience and another member who has or is currently practicing law. No more than three board members can be of the same political party.



• Scratch ticket sales in Iowa, which have set records consecutively since FY 2015, totaled \$244.3 million, an increase of nearly \$7 million from the previous record for that product set the year before. Sales growth for scratch games in Iowa is far outpacing the rest of the country. Scratch ticket sales in Iowa increased 89 percent from FY 2007 to FY 2017, compared to the national average 58 percent

• **Powerball**[®] and Mega Millions[®], both lotto games offered across the country and known for their large jackpots, saw sales increases in FY 2018 in Iowa. In early January 2018, for the first time, both Powerball and Mega Millions achieved estimated jackpots of more than \$400 million at the same time.

• Pick 3 and Pick 4 sales both tallied sales increases in FY 2018. Pick 3 sales increased from \$7.3 million

Lotto America®



New Lotto Game Began Nov. 12

Sales in the Iowa Lottery's new \$1 lotto game, Lotto America[®], started Nov. 12, 2017 here in Iowa and in 12 other states. The game's first drawing had a one-time \$15 million starting jackpot. Jackpots in this new game start at \$2 million, but with the rollover of the money remaining in the prize pool from the end of the Hot Lotto[®] game on Oct. 28, the first Lotto America jackpot was significantly bigger.


The game's name is a throwback to the first multi-state lotto game that became known for big jackpots in the United States. Iowa was a founding member of the original version of Lotto America, which began in 1988 and made headlines around the world at the time for its jackpots before ultimately being replaced by Powerball[®] in 1992.

Plays cost \$1 and the drawings are Wednesdays and Saturdays at approximately 10 p.m. For an extra \$1, players can add the All-Star Bonus[®] for a chance to multiply their non-jackpot prize by 2, 3, 4 or 5. Tickets may be purchased until 8:59 p.m. on the evening of the drawing. Players pick 5 out of 52 numbers for the white balls, then choose 1 out of 10 numbers for the Star Ball[®].

To help introduce the new lotto game, Lottery staff visited several retailers around the state and handed out free-play Lotto America coupons prior to the game's launch.

LotteryPlus Mobile App Update

App Updated to Allow VIP Club Access, Promotion Entry

In October 2017 the Iowa Lottery added the ability for players to log in to the Iowa Lottery VIP Club[™] through the "LotteryPlus" app so they can enter Play It Again[®] promotions.

Now, players can simply use a mobile device that has the app and scan their eligible scratch or lotto ticket to enter the latest promotion. It's that easy!

Players can also view a list of their promotion entries and access FAQs for the current promotion(s).

The Iowa Lottery introduced its "Iowa Lottery LotteryPlus" mobile app in May 2017. The app also allows players to:

- Check their tickets to see if they're a winner using the bar code scanner
- Use the "ePlayslip" feature to design a ticket for their favorite lowa Lottery game on the go. They can pick their favorite numbers or shake their device to use the numbers generator
- Get current jackpots and winning numbers for all of the lowa Lottery's games
- Find a nearby lowa Lottery retailer
- Learn about the Iowa Lottery's latest promotions, scratch tickets and more

Winners

Since the Iowa Lottery's start in 1985, its players have won nearly \$4.2 billion in prizes.

Prizes to players totaled a record \$227.5 million in FY 2018.

It was all about the cash last holiday season in the lowa Lottery's Secret Santa promotion, where players got to choose their cash prize in each drawing. If they liked surprises, they could pick the "Secret Santa" surprise drawings. But if they preferred to choose their prize, they could enter the "Not So Secret Santa" drawings and know the prize amount right away!

Forty-nine players won more than \$100,000 in total cash prizes ranging from \$800 to \$3,000 in six drawings held Oct. 17 through Dec. 29, and one player - Alisha Beermann of Denison - won a \$10,000 grand prize.

Players had a chance to win concert ticket packages and a \$10,000 grand prize in the JACKPOT PARTY[®] promotion June 4 - Aug. 22, 2018.

The promotion was named for the games that were eligible for it. Players could enter using nonwinning tickets in the \$10 JACKPOT PARTY Progressive InstaPlay game or the \$5 JACKPOT PARTY scratch game. The promotion had four prize drawings for a total of 55 total concert ticket packages to Maroon 5 and Kelly Clarkson in Cedar Rapids, Counting Crows in Council Bluffs and Fleetwood Mac in Des Moines. Randy Schott of Lake Park won the \$10,000 cash "Plan-Your-Own-Party" grand prize.



After a great response in 2017, the lowa Lottery brought back in 2018 the Powerball[®] Power Cruise[™] promotion that gave players the chance to win a Caribbean cruise vacation package. This time 28 cruise packages were on the line for lottery players in Iowa – three more than in 2017's initial version.

Sales commissions to retailers totaled \$24.2 million in FY 2018.

Thanks to hard work from our retailers and Lottery staff, commissions to retailers increased by more than 5 percent from FY 2017.

Lottery Kiosks Debut at Some Retail Locations

Beginning in mid-September 2017 customers could use self-service kiosks in some retail locations to buy lotto, scratch and InstaPlay tickets on their own all from one machine. Players also can check their tickets at the kiosks, just like they can with the self-checkers installed in nearly all of the Lottery's retail locations.

The first touch-screen kiosk was installed at Hy-Vee, 1700 Valley West Drive in West Des Moines. Installation continued statewide over the next two months. The kiosks are in the Lottery's very biggest, busiest locations to give players there an additional way to buy tickets.







Fiscal Year Proceeds to State



Since the Lottery's start in 1985, it has raised nearly \$1.9 billion for state programs.

General Fund: \$1,624,101,388 - Since 1992, a majority of Lottery profits have been directed into the state general fund, where they are used to pay for programs that benefit all lowans. In the lowa Lottery's latest fiscal year, the Lottery raised more than \$84.6 million in proceeds that were deposited in the state general fund. Some of the programs that receive money from the general fund include education, natural resources, health and family services and public safety. The Governor and Iowa Legislature allocate money from the general fund based on where they believe those funds are needed most.

Iowa Plan: \$170,318,439 — The Iowa Plan was a long-term economic development program. It was divided into four basic areas: a Jobs Now program designed to put people to work; government construction programs; community and economic betterment; and educational and agricultural research. Lottery profits were dedicated to the Iowa Plan from fiscal year 1986 through fiscal year 1990.

CLEAN Fund: \$35,894,355 — The CLEAN Fund stood for Committing the Lottery to Environment, Agriculture and Natural Resources. The program dedicated money to environmental and cultural causes. Lottery profits were dedicated to the CLEAN Fund during fiscal year 1991.

Iowa Veterans Trust Fund \$24,852,121 — Since July 2008, a portion of Lottery proceeds has been dedicated to the lowa Veterans Trust Fund, where they are used to support our state's veterans. The Iowa Lottery currently provides \$2.5 million annually in proceeds to the Iowa Veterans Trust Fund. The lowa Veterans Trust Fund was created to provide assistance to gualified veterans to help pay for expenses such as job training or college tuition assistance; some dental, vision and hearing assistance; and individual or family counseling programs.

Iowa Gambling Treatment Fund: \$15,732,208 — The Iowa Gambling Treatment Program provides treatment, counseling and outreach programs for those concerned about gambling as well as the 1-800-BETSOFF helpline. The lowa Lottery is committed to responsible play and helps address the issue of problem gambling. Each year, the Lottery provides the public with information about 1-800-BETSOFF by including messages about the helpline on millions of lottery tickets, brochures and point-of-sale materials as well as other publications. In 2009, the Gambling Treatment Fund was eliminated, with the Gambling Treatment Program now receiving its funding from the state General Fund.

Special Appropriations: \$13,773,572 – A portion of Lottery profits have been earmarked for specific purposes within the state budget.

Backing For Vision Iowa:

In addition to those direct uses of Lottery proceeds, Lottery profits are also linked to the Vision Iowa program. Vision lowa was implemented in 2000 to create tourism destinations in the state, assist with community attractions, and build and repair schools. Direct funding for Vision Iowa comes from gaming revenues. However, as the program was being initiated, investors indicated there was a need to strengthen the Vision Iowa bonds by dedicating \$20 million annually in Lottery revenues as a backup. Legislation was approved that dedicates \$15 million in Lottery revenues to programs for community attractions in Iowa and another \$5 million to Vision Iowa programs to build and repair schools if gambling revenues don't reach that amount. Lottery funding will continue to be linked to Vision lowa over the 20-year payback period of the program's bonds.

Overview

Agency Mission:

"The Iowa Lottery strives to administer lottery games in a secure manner to maximize revenue while maintaining the dignity of the state and the welfare of its people."



The lowa Lottery was established in 1985 and began ticket sales on Aug. 22 of that year. Since the lottery's inception, its players have won nearly \$4.2 billion in prizes while the lottery has raised nearly \$1.9 billion for the state programs that benefit all lowans.

The guiding principles of the Iowa Lottery are:

- Develop and distribute products that are fun and exciting to lowans;
- Maintain integrity and security in production and delivery of those products while utilizing advanced technology;
- Educate and motivate the public to play Lottery games responsibly; •
- Maintain the dignity of the Lottery through truthful, tasteful and informative advertising; •
- Develop an effective employee workforce that is professional, knowledgeable, skilled, and offers maximum service and reliability to retailers and players; and
- Maximize net revenues to the state.

Today, lottery proceeds in Iowa have three main purposes: They provide support for veterans and their families through the Veterans Trust Fund; help for a variety of significant projects through the state General Fund; and backing for the Vision Iowa program, which was implemented to create tourism destinations and community attractions in the state and build and repair schools.

The Lottery has approximately 115 employees in the following departments: external relations, finance, marketing, systems, sales and security. That number does not include the five board members.

The Lottery has approximately 66 employees at its headquarters in Clive. The Lottery also maintains a warehouse facility in Ankeny and four regional offices in Cedar Rapids, Council Bluffs, Mason City and Storm Lake. The lottery has four product categories: scratch tickets, pull-tab tickets, InstaPlay and lotto games. Lottery products are sold through approximately 2,400 licensed retailers across lowa.

In 2003 the Legislature recognized that as an entrepreneurial entity, the Iowa Lottery could operate more efficiently and established the Iowa Lottery Authority, a public instrumentality of the state. As a result of that change, combined sales for the Lottery's traditional products have continued to climb in the fiscal years since then.


The lowa Lottery develops an annual budget, which requires approval by the Board of Directors. The budget is monitored through a series of performance measures.

The goals and results discussed in this report cover the following core functions of the Iowa Lottery's operations: sales and distribution; resource management; enforcement and investigation; and reconciliation clearing account.


