#### iPLEDGE Program Update

Changes to the iPLEDGE risk evaluation and mitigation strategy (REMS) program went into effect on December 13, 2021. Risk categories for patients have been reduced from three to two options. These options include:

- patients who can get pregnant
- patients who cannot get pregnant

With the first login for each patient on or after December 13, providers must reassign and confirm a patient's risk category. This includes patients enrolled prior to this date. If a patient's isotretinoin prescription risk management authorization (RMA) expired before pickup, they must go back to their prescriber and start the authorization process over again.

Pharmacies should be aware of a change in the REMS administrator. As a reminder, the "switch" pharmacy management system is no longer a method to verify authorization to dispense isotretinoin. Pharmacists can no longer use the switch system for pre-dispense RMA. As of December 13, pharmacists must obtain an RMA by accessing the iPLEDGE REMS website or contact center.

Patients now have the option to present a unique QR code to their pharmacy instead of providing their iPLEDGE identification number.

## **IDPH Medical Director Update**

At the end of October, Dr Caitlin Pedati resigned from her position with the Iowa Department of Public Health (IDPH) as the state's medical director and epidemiologist. IDPH is working to fill the position and has engaged David Stilley, MD, in the interim. Dr Stilley has authorized all statewide standing orders that were in place (naloxone, coronavirus disease 2019 (COVID-19) testing,

COVID-19 vaccination, etc), and pharmacies should make sure that they have the most current authorized standing order available for use.

#### **Update on Naloxone and Disposal Solution Dispensing Programs**

The lowa Prescription Monitoring Program (PMP) continues to support lowa pharmacies interested in the naloxone and disposal solution programs. Since July 2020, over 1,700 naloxone (Narcan®) kits have been successfully dispensed to lowa patients with over 225 lowa pharmacies participating. All lowa adult patients (18 years of age and older) are eligible to receive Narcan at no cost (\$0 co-pay), and lowa community pharmacies are reimbursed the cost of the product plus a \$20 dispensing fee for patient education and counseling. Claims are submitted electronically via downloadable patient voucher cards.

In July 2021, the Iowa PMP also began sponsoring a disposal solution program. To date, Iowa pharmacies have dispensed more than 2,800 kits with more than two dozen Iowa pharmacies participating. Similar to the naloxone program, all Iowa patients (regardless of age) are eligible to receive a disposal kit at no cost (\$0 co-pay). Iowa community pharmacies will be reimbursed a \$7.50 dispensing fee to cover the cost of the disposal product and providing patient education and counseling. Downloadable patient voucher cards for the disposal program are available here. Note, Iowa pharmacies can bill for both a naloxone and disposal kit for a patient on the same day by submitting two eligible claims.

#### Online Pharmaceuticals: How to Keep Patients Safe

The Alliance for Safe Online Pharmacies (ASOP Global) reported an increase in demand for medications sold online during the COVID-19 pandemic. Many Americans cite lower cost and convenience as reasons for jeopardizing their health and safety. Out of more than 35,000 online pharmacies worldwide, approximately 95% supply drugs illegally. These drugs can range from lower quality and efficacy, to potentially deadly. Along with proposed legislation reform, ASOP Global provides pointers to help educate pharmacists and other health providers when discussing online access to pharmaceuticals.

- Look for ".pharmacy" in the website address (which certifies that the business has been reviewed by the National Association of Boards of Pharmacy®) or verify that the pharmacy website is safe and legal by visiting the Buy Safely section of www.BuySafe Rx.pharmacy.
- Counsel patients that they should never buy from an online pharmacy that:
  - does not require a valid prescription
  - does not have a physical street address in the United States
  - does not have a licensed pharmacist on staff
  - · sends unsolicited emails
  - · ships medications worldwide
- Stress that medications coming from Canada are not necessarily legitimate and are
  often not from Canada at all. Many counterfeiters and rogue pharmacies will use the
  guise of being a "Canadian pharmacy" when in fact they are located overseas, often in
  third world countries with very little, if any, regulatory oversight.
- Explain to patients that counterfeit medications can include dangerous substances or poisons like paint thinner, arsenic, or antifreeze.

Many patients will also have questions about the COVID-19 vaccine and treatment and are susceptible to fraudulent pharmacy sites. The following are additional pointers to avoid COVID-19 scams.

 Remind patients that the vaccine is free and only available at federal- and stateapproved locations. Patients will never be asked to pay out of pocket for the vaccine or pay to sign up for vaccination.

- Explain that vaccination cards should be kept in a safe place and not shared with others, including posting on social media. This can facilitate fraud and identity theft.
- Counsel patients to always talk to their health care providers before trying any product claiming to treat, prevent, or cure COVID-19.
- Discuss the dangers of purchasing fake vaccination cards, test results, or other certificates. Not only is this providing a false sense of security, but the conduct is also illegal and can result in a fine or jail time.

### Pharmacy Workplace and Well-Being Reporting Program

The American Pharmacists Association and the National Alliance of State Pharmacy
Associations have recently initiated a new program, Pharmacy Workplace and Well-Being
Reporting (PWWR). The PWWR intends to collect anonymous submissions from pharmacists and
pharmacy personnel to decipher workplace factors and "determine how they affect pharmacy

personnel well-being and patient safety." The PWWR aims to be a voice to pharmacy strengths, concerns, and solutions.
