There are two newly designed plates from which you can choose: the patriotic plate is red, white and blue; and the scenic plate shows the rural and urban flavor of Iowa.

To get a set of sequentially numbered sesquicentennial plates, take your current plates and registration to your county treasurer and request the sesquicentennial plates. These plates display seven charac-ters-six numbers and the letter " S ". The initial cost of the plates is $\$ 15$, in addition to your regular registration fee; and there is a $\$ 10$ yearly renewal cost in addition to the regular fees.

Gift certificates for sequentially mumbered sesquicentennial plates are available and may be purchased from your county treasurer for $\$ 15$. Recipients of the gift certificates may exchange their regular registration plates and registration receipts for sequentially numbered sesquicentennial plates and registration receipts.

You can also get personalized sesquicentennial plates or personalized sesquicentennial gift certificates in either design. There is an initial fee of $\$ 40$ for the plates in addition to the regular registration fee, and the renewal will cost $\$ 15$ plus your regular fees each year. Complete the application form on the reverse side and mail, along with $\$ 40$, to the DOT Office of Motor Vehicle Registration, Park Fair Mall, 100 Euclid, P.O. Box 9204, Des Moines, IA 50306-9204.

Proceeds from the sesquicentennial plates will support the programs and activities of Iowa's 150 th birthday commemoration in 1996. Governor Terry E. Branstad has appointed former governor Robert D. Ray to chair the statewide Iowa Sesquicentennial Commission. Your county sesquicentennial commission also shares in the funds from your county's plate sales and renewals.

Your sesquicentennial plates symbolize 150 years of Iowa heritage. Display them with pride, and join with your fellow Iowans in the local and statewide celebrations of our past and future. INFORMATION: To order personalized sesquicentennial plates for yourself or as a gift for someone else, with you selecting what is to be on the plate, complete and sign this application, submit a photo copy of the current registration and a check for $\$ 40$. If your choice is unavailable or not approved, your check will be returned. A gift certificate may be purchased that allows the person receiving the gift certificate to make a plate choice. If the plate choice is unavailable or not approved, that person may obtain the refund. Personalized sesquicentennial plates are available for your auto, motorhome, multipurpose vehicle, light delivery truck, panel truck, pickup and travel trailer.

TO RETAIN SESQUICENTENNIAL PERSONALIZED PLATES: In addition to the annual registration fee, a $\$ 15$ validation fee is required for personalized sesquicentennial plates. Your plate choice may be issued to someone else if you do not renew your plates when your vehicle registration is due. If you do not renew your registration within two months after the expiration date, a new application and fee will be required to retain your plate choice if it is still available.

IMPORTANT: Your plates will be sent to your county treasurer's office within 21 days. If your plates have not expired, you must exchange yofr county plates and the copy of your registration receipt for your new personalized sesquicentennial plates and registration receipt.

RESTRICTIONS: Offensive or suggestive combinations cannot be approved. To avoid confusion with the state plate system, your choice cannot consist of a combination of 3 letters and 3 numbers, 2 letters and 4 numbers, 1 letter and 4 numbers, 1 letter and 3 numbers, numbers only, amateur radio call letters or misleading combinations (FBI, IHP, DMPD, DCI) or other initials used by government agencies. No choice can duplicate an existing plate. Plate choices must have at least 2 , but not more than 7 characters. Characters A through Z, 1 through 9 may be used. Punctuation marks are not acceptable.

## TO ASSIGN PERSONALIZED SESQUICENTENNIAL

PLATES: If you sell a vehicle displaying personalized sesquicentennial plates, the plates are to be turned in to the county treasurer, or assigned to the replacement vehicle without extra charge if you obtain a replacement within 30 days. Plates may be assigned to another person if both vehicles are currently registered and the owner completes an assignment statement at the county treasurer's office.
