INTRODUCTION

Historic preservation in Iowa is the responsibility of many partners. Ranging from formal government agencies to local volunteer commissioners, we all strive to achieve our preservation goals. Working in unison, we must communicate and cooperate. Our mutual success is made more likely if there is a plan that identifies our common goals and points out a general direction for us to take.

The State Historical Society of Iowa is charged under Federal law with preparing a comprehensive state historic preservation plan, a plan for all historic preservation activities in the state, not simply a workplan for this agency. Such a plan would present the preservation planning priorities and goals of all preservation agencies or "partners." This document, entitled "Partners in Historic Preservation" is the first step in that joint planning process. It catalogs the roles played by each partner and defines some partner-specific goals, some of which are joint goals, some are SHPO goals. "Partners" was first distributed last spring and was well received. This revised version represents our on-going commitment to revise and redistribute it each year. The document has greatly increased communication and planning between partner organizations.

"Partners" identifies each of the state's preservation organizations and it defines the role that each of these plays in preservation. The "Section 106" process, authorized by the 1966 Historic Preservation Act, requires every Federal agency to "take into account" how each of its undertakings could affect historic properties. Thus projects which involve Federal funding, licensing or permits, or Federal property automatically require that the responsible agency becomes involved in historic preservation. This listing therefore identifies the major Section 106 partners.

Finally, goals and objectives are identified. SHSI goals appear in column four in boldface type. Your preservation goals will appear in italicized type. Since this listing will be updated and distributed annually, it is intended that these goals will be short-term ones that can be realized within a one to two year timeframe.

I ask you to respond with any corrections or additional information for this publication. Those who respond in any manner, will receive a revised edition by mid-year. The document will otherwise be constantly updated by SHSI and a current vision is always available upon request.

I further ask you to consider goals which you would like to accomplish, working with SHPO or with other partners. Forward these to me for inclusion in this document. "Partners" is intended to serve as an annual tracking mechanism for these goals, keeping them in our mutual minds. It is our experience that the document literally "drives" inter-agency planning. It serves also as a useful contact list, giving each of us access to the broadest array of case studies, models and solutions.

Please review what we have said about your organization. The entry should provide a correct title, list of key contact persons, address and phone/fax number. The second column should briefly summarize your role in preservation. This entry would ideally be taken directly from your plan or mission statement. If you are responsible for cultural resources, a brief overview of those holdings should be provided.

This document will function as a primary appendix to the comprehensive preservation plan. As such it will be available as a public planning document, although it will not be a part of the plan itself.

In order to make this function as a dynamic planning document, your comments will always be welcome. I will appreciate your cooperation in making this a useful and on-going communication tool between our respective agencies.

**PRESERVATION ROLE(S)—LAND &
RESOURCE MANAGEMENT STATUS:**

The 19-member Advisory Council and independent Federal agency serves as the major policy advisor to the President and the Congress in the field of historic preservation, and under Section 106 of the NHPA guides other Federal agencies to ensure that their actions do not needlessly harm historic properties. Four Council members are appointed by the President who also names the chairman and vice chairman. Six Council members represent key cabinet/Department positions along with the Architect of the Capitol, also serve. Ex-Officio members include the chairman of the National Trust for Historic Preservation and the president of the National Conference of State Historic Preservation Officers.

Holdings consist of Ag. Res. Service, ISU (1914 45 ac., Nat. Animal Disease Ctr., Ames, 318 ac., Animal/Plant Health Inspection, Ames, 25 ac., Vet. Biological Lab and Natl. Vet. Services, Ames, 153 ac., Ag. Res. Ser. Ankeny, Soil Cons. Service D.M. (1945) .8 ac., Ag. Res. Serv. Watershed Res. Ctr., Treynor, (1963).

The SCS has as its primary role the planning and development of programs and practices aimed at controlling soil erosion. Control of soil erosion will improve water quality and lengthen the useful life of public lakes, etc. Constructs lakes under its P.L. 566 program. Administer small watershed programs (dam projects), also under Public Law 556, also hold easements. Field staff regularly assist public recreation resource managers in developing soil conservation plans

**PRESERVATION ROLE(S)—LAND &
RESOURCE MANAGEMENT STATUS:**

for public lands, and are also instrumental in implementing soil erosion control practices on private lands within the watersheds of publicly owned lakes.

Responsible for agricultural land use policies and laws and impacts on natural resource base, especially soil erosion and water quality. Involved in resource management programs which affect outdoor recreation through enactment of the Resource Enhancement and Protection Act through its administration of the Soil and Water Enhancement Account. Funds are available for soil and water conservation and enhancement projects and practices. Eligible use of funds include: improvements to and development of terraces, ponds, grass waterways, reforestation, woodland protection and enhancement, wildlife habitat preservation and enhancement, protection of highly erodible soils and water quality protection.

Appears to be nationally non-compliant in 106 despite large-scale involvement in ag land undertakings. It is estimated that only one of its programs, the conversion of highly erodible lands, which is monitored by SCS, an annual average of 5 farmsteads or former farmstead sites are being destroyed without program review.

Excellent working relationship developed over 5 year period. Assisted with their first AML survey in 10 yrs. by managing archeological consultant contract for them and assisting in development of retainer consultant services. Participated in Farm Conference planning. Administers Century Farms program, a useful database (in state archives). Bureau did 1978 questionnaire follow up (Bureau inventory).

There are indications that the Advisory Council on Historic Preservation has been reluctant to push nationally for compliance on the part of this agency. Determine 106 status and consider acting to insure compliance with the law [status-no developments].

Offers excellent educational and promotional opportunity for Bureau, changing farm practices, changing rural economy could aid or impair rural preservation, loss of rural/small town resources represents crisis state. **PRESERVATION ROLE(S)—LAND &
RESOURCE MANAGEMENT STATUS:**

preservation of archeological remains, the coordination of archeological activities with the Iowa Department of Transportation, the Department of Natural Resources and other state agencies, the publication of educational and scientific reports, the performance of archeological investigations on federally funded projects, and the investigation, preservation and reintering of ancient human remains. OSA has the equivalent of 22.5 full time employees. Sponsors Iowa Archeology Week along with the Iowa Archeological Society, usually in mid-September.

The Iowa DOT and The University of Iowa conduct the Highway Archaeology Program jointly as a public service. Our goal is to provide each county, municipality, and the Iowa DOT with complete archeological and historic architectural coverage on transportation projects. This work gathers useful historical and archeological information that is of significant research and educational value. The program has had a long and successful tenure, and due to its comprehensive nature, is equipped to provide efficient and professional cultural resource evaluations.

Large highway corridor surveys have focused state rural survey guidelines and field procedures. 1991 planning meeting focused on survey issues.

Sets standards for and provides network for many

**PRESERVATION ROLE(S)—LAND &
RESOURCE MANAGEMENT STATUS:**

Commission founded out of concern for preserving local bricked streets, also in response to developmental pressures from Polk County to east.

The commission works closely with Albia Industrial Development Corporation and other groups involved with community and economic revitalization. They submitted a HRDP grant application for the "Skean Block" project. With Albia Area Improvement Association, completed restoration of the Hennion Block exterior. The Commission is working closely with the city council on the enforcement of a health ordinance on historic but dilapidated structures, to implement a city-wide tax abatement ordinance, and on installing an additional block of Victorian-era street lights.

The Commission is forging good partnerships with local groups, for example, in cooperation with the Allamakee Historical Society they restored a Norwegian settler's house and relocated it on the lawn of the county historical museum. The project was partially funded by a HRDP grant. They received a HRDP grant (\$48,000) to conduct an archeological survey of Bear Creek Valley, this work is now in progress. They worked with DNR on a development plan for newly acquired DRN property which contains the Winnegbago Mission historic archeological site.

The Commission developed a set of criteria for feasibility studies for the demolition of historic buildings; conducted a survey of existing signage; and sponsored a workshop and artist-in-residence program on architectural preservation for the grade school. They found that continuing public education is the key to success, especially creative educational programs.

Historic properties will be protected through partnership, advocacy, education and the empowerment of individuals, communities, and agencies. 3. Statewide preservation communication networks are vital to the success of the movement and must be established and maintained. 4. Funds not allocated to Certified Local Governments will be targeted to the survey of statewide themes and state lands; to develop historic contexts and property typologies so as to facilitate local preservation activities, and finally to test and refine new field techniques and models. 5. Preservation "tools" such as incentive programs, strategies, and legislative authorization require constant vigilance, maintenance and refinement. 6. A stronger state financial commitment to historic preservation in Iowa is a high priority. 7. A plan is most effective and meaningful when it is used broadly and frequently, and when it enables a program to act proactively. 8. Historic Preservation as a movement, in order to be truly effective, must be mainstreamed into the political decision-making process on the state and local level, just as are public safety and environmental concerns.

Promotes volunteer participation in community and economic development organizations. Rural Enterprise Fund provides support to rural communities in the form of seed money, technical assistance and training.

Communities develop plans which emphasize broad community input, the identification of local concerns, and creativity in proposing solutions. Communities with completed plans receive bonus points for CDBG, REAP, RISE and other grant programs.

The Iowa Main Street program is designed to encourage downtown economic revitalization using historic preservation as a tool to attract new investments to the community. It focuses on the four elements of the "Main Street Approach," organization, promotion, design and business improvement of selected Iowa downtowns. As funding is available, a limited number of communities are selected during their start-up phases. Communities under 5,000 in population are eligible for the Rural Main Street program; selected communities receive two years of grants. Communities under 50,000 in population are eligible for the Main Street Iowa Program and selected communities receive three years of grants. Communities continue to receive technical assistance and training upon completion of their start-up phase as a graduated community by contractual arrangement with the Department.

**PRESERVATION ROLE(S)—LAND &

Authorized in 1976 as a tax incentive to stimulate capital investment in income-producing historic buildings and the revitalization of historic communities. The incentives include an investment tax credit for the rehabilitation of old and historic structures, and income and estate tax deductions for charitable contributions of partial interests in historic property.

This is the "other" primary NPS grant program. Since its inception in 1965 it has funneled \$43 million to Iowa. Provides 50/50 matching grants-in-aid to state and local governments to help acquire, develop and improve public outdoor recreation areas and facilities. Each state designates a state liaison officer who is responsible for analyzing recreation needs, setting priorities for funding, supervising project work and ensuring compliance with Federal regulations and guidelines. Iowa applications exceed available funds by a 5 to 1 ratio. In Iowa one half of the funding is reserved for city/county projects, the other half for state projects. Funding has declined to less than half a million annually, down from a high of \$5 million in 1979, and up from a low of no funding in 1982.

Colleges meet own outreach/educational priorities to various degrees through these individuals. These can take the form of substantial on-going programs, paid for using grant funds.

HPB has worked extensively with Eino Kainlauri, College of Design, co-sponsoring historic preservation conferences. Similarly, Jim Cain, Energy Extension, has consulted with HPB over time on historic preservation issues.

Administers Living Roadway Trust Fund of REAP (receives 1% of annual funding). Owns right of way and a few interchanges, one cultural resource (Little Maquoketa Mounds, 42 acres, Dubuque County) which is a State Preserve. Is entrusted with administration of the State Recreational Trails Program funded by a \$1 million annual appropriation and based upon the Iowa Statewide Recreational Trails Plan. Nearly \$3 million awarded to 18 projects in four grant cycles. Local match averaged 32% of grants.

Intermodal Surface Transportation Enhancement Act (ISTEA) promises to redefine the transportation planning process in the state, beginning fall of 1992. Mandates statewide plan, local plan initiatives by Metropolitan Planning Offices, and provides 10% of annual grant funding for enhancements.
