

# **Project Description**

This new 16-mile section of U.S. 20 between Iowa 150 near Independence and Iowa 297 near Waterloo will make travel more convenient and safer for motorists. The new four-lane highway replaces existing U.S. 20 to the north which has two lanes and carried approximately 5,500 vehicles every day. U.S. 20 in northeast Iowa is now four-lane from Delaware in Delaware County to near Waterloo.
