Bipartisan Infrastructure Law (BIL) - Stakeholder Engagement Webinars

You're invited to join the State Revolving Fund (SRF) Team to discuss the implementation plans for the federal Infrastructure Investment and Jobs Act (IIJA) funding, also known as the Bipartisan Infrastructure Law (BIL).

Two separate webinar sessions will be held for Drinking Water and Clean Water funding opportunities on Monday, June 27th. In these sessions, we will discuss Iowa's BIL allocations, proposed project funding opportunities, proposed new Disadvantaged Community definition, proposed loan forgiveness eligibility criteria and proposed loan forgiveness allocation formula.

Registration is NOT required. There will be a 20 minute presentation followed by a 40 minute question and answer session.

Consumer Confidence Report Reminder

Each community public water supply system (CWS) is required to distribute the annual Consumer Confidence Report (CCR) to its consumers by July 1st. Even if a system uses the template sent to it by DNR in March, a copy of what was actually distributed to the consumers must be submitted to DNR by July 1st.

Send a copy of the CCR to DNR by July 1st. The certification must be sent to DNR after the distribution is complete, no later than October 1st, as directed in the letter sent to each CWS in March 2022. Many systems submit the copy of the report and the certification at the same time to DNR, before July 1st.

If a CWS needs an electronic copy of the CCR and/or Certification Form, please send the request to CCR@dnr.iowa.gov. This is an email address that all of our environmental specialists can access.
