Public Hearing on Proposed Renewal of NPDES General Permits 1, 2, 3, and 4

The NPDES Section is proposing rule changes to Chapters 60 and 64 of the Iowa Administrative Code to renew four of Iowa's general permits for storm water (GPs #1, #2, and #3) and private sewage disposal systems (GP #4). The new effective dates for all four general permits will be March 1, 2023. The proposed revisions to GPs 1 through 4 and to Chapter 60 will improve the clarity and readability of the requirements, definitions, and standard conditions, and will ensure consistency with corresponding federal regulations. The proposed revisions do not affect the substance of the general permits.

The Environmental Protection Commission approved the Notice of Intended Action for the proposed rule at their meeting on August 16, 2022. The Notice was published in the Iowa Administrative Bulletin as on September 9, 2022.

A public hearing on the proposed rule and general permit renewals will be held via Zoom on September 28, 2022, at 2:00 pm.

Persons who wish to make oral comments at the public hearing will be asked to state their names for the record and to confine their remarks to the subject of this proposed rule making. Any persons who intend to attend the public hearing and have special requirements, such as those related to hearing impairments, should contact the Department and advise of specific needs.
