# HHS Releases First Ever National Strategy to Support Family Caregivers

The U.S. Department of Health and Human Services (HHS), led by the Administration for Community Living (ACL), submitted the first ever National Strategy to Support Family Caregivers to Congress. This completes the final mandate of the Respect, Assist, Include, Support, and Engage (RAISE) Family Caregiver Act of 2018. HHS will be opening the Strategy for public comments for 60 days, starting on October 1, 2022.
